12. 'One Club Affiliation' Update

- 12.1.David Nixon (Football Services Manager) provided an update to Council on the current affiliation position
- 12.2.K Shoemake addressed Council on the competitive pricing obtained through Sportsguard of Public Liability and Personal Accident Insurance
- 12.3.D Nixon informed Council of correspondence sent to all sanctioned Leagues and Competitions around 'pre-season' matches and the requirement that, under the rules and regulations of The Football Association, the matches must be between teams from affiliated Clubs. Failure to affiliate before competing is 'unaffiliated football' and may invalidate any insurance and may result in a charge of failing to comply with the rules and regulations of The Football Association.
- 12.4.Council was reminded that FA Registered Referees must not participate in unaffiliated football
- 12.5.K Shoemake advised Council on changes to the level of cover scheduled and the exclusions detailed under the Public Liability Insurance provided by the Association. There is a requirement for all Clubs to ensure that the cover provided under the policy meets the needs of the Club.

13. Formation of Standing Committees for Season 2018-2019

- 13.1.The Chair advised Council of the meeting of Officers, called under Article 15.2, on Wednesday, 4 July 2018 to appoint Council Members to Standing Committees for Season 2018-2019
- 13.2.A discussion took place regarding the role of the Sanctions and Compliance Standing Committee and in accordance with Article 15.3, Council approved to dispense with the Sanctions and Compliance Committee from Season 2018-2019 onwards
