Chairman of the Board of Directors' Annual Report

Having served the Association as Chairman for 9 years, 3 terms with each term of 3-years, in accordance with the Articles of Association of Birmingham Football Association at point 13.1, the Board of Directors, unanimously agreed to appoint me as Chairman of the Board of Directors for a final, 3-year term to 30 June 2025, which I accepted. In doing so, this is allowing time for "Board succession planning" including a new Chair from 1 July 2025.

Gareth Roberts, Independent Director – Commercial, resigned from the Board due to other commitments. BCFA is currently in the recruitment phase for a new independent director with a commercial specialism to join the Board and to bring the Board up to its' full strength of 12 Directors.

David Nixon retired from his role as BCFA Football Services Manager on 9 June 2023 after more than 15 years' service with the Company. I am pleased to say that the Company has retained David's knowledge and experience in a "consultancy" role and where this includes the role of Board Secretary.

Mohammed Juned was appointed to succeed David Nixon as BCFA Football Services Manager and joined the Board as an "ex-officio" Director on taking up his appointment.
