Proposed Changes to the Articles of Association [EGM 1 July 2021]

The Board of Directors is proposing the following changes to the Articles of Association [EGM 1 July 2021] by way of Special Resolution at an Extraordinary General Meeting called for this purpose and to be held on **Thursday, 29 February 2024 at 7.00pm**.

Article of Association 13 – Chairing of Directors Meeting

Current:

13.1 The members may appoint a director to chair directors' meetings (the "chairman"). The chairman shall not be the chief executive officer of the Association (or any equivalent office holder).

Proposed:

13.1 The members *must* appoint a director to chair directors' meetings (the "chairman"). The chairman shall not be the chief executive officer of the Association (or any equivalent office holder).

Reason:

In accordance with The FA's Code of Governance for County Football Associations, the Board of Directors "must" appoint a chair.

Article of Association 16 – Methods of Appointing Directors

Current:

Save as otherwise provided in the Articles, the directors of the Association shall be:
 16.1.1 Such persons as the Association may by ordinary resolution appoint who are willing to act to as a director.

16.1.2 Such other persons as the directors may from time to time co-opt to the board of directors on a temporary basis, provided that any co-opted director shall not be entitled to hold office for a period of longer than one year save in exceptional circumstances documented by the directors.

16.1.3 The Chief Executive Officer

Proposed:

16.1 Save as otherwise provided in the Articles, the directors of the Association shall be:
 16.1.1 Such persons as the Association may by ordinary resolution appoint who are willing to act to as a director.

16.1.2 Such other persons as the directors may from time to time co-opt to the board of directors on a temporary basis, provided that any co-opted director shall not be entitled to hold office for a period of longer than one year save in exceptional circumstances documented by the directors.

- 16.1.3 The Chief Executive Officer (Ex-Officio)
- 16.1.4 The Football Development Manager, or their equivalent (Ex-Officio)
- 16.1.5 The Football Services Manager, or their equivalent (Ex-Officio)

Reason:

As from 1 July 2022, the Football Development Manager and the Football Services Manager, or their equivalents, were appointed as Ex-Officio Directors of Birmingham County Football Association Limited. In accordance with The FA's Code of Governance for County Football Associations, the method of appointing these Ex-Officio Directors, along with the Chief Executive Officer, are required to be recorded in the Articles of Association.

Article of Association 27 – Quorum for General Meetings

Current:

27.1 If the Association only has one [1] member that member shall be a quorum. In any other case twenty-five [25] members entitled to vote upon the business to be transacted shall be a quorum. A proxy or an authorised representative of a member shall count for the purposes of the quorum. No business other than the appointment of the chairman of the meeting is to be transacted at a general meeting if the persons attending it do not constitute a quorum.

Proposed:

27.1 If the Association only has one [1] member that member shall be a quorum. In any other case *two* [2] members entitled to vote upon the business to be transacted shall be a quorum. A proxy or an authorised representative of a member shall count for the purposes of the quorum. No business other than the appointment of the chairman of the meeting is to be transacted at a general meeting if the persons attending it do not constitute a quorum.

Reason:

Since the adoption of the Articles of Association in 2021, the Annual General Meeting of the Association has, in the first instance, been adjourned by the Chair to a later date as no quorum was formed. This has stifled the Executive from managing the affairs of the Association. The proposed change is in accordance with the Companies Act 2006 and will ensure that the business is not hindered by the memberships, non-mandatory, attendance at the Annual General Meeting. The business transacted at the Annual General Meeting is by ordinary resolution, one member, one vote, by majority.

27.1 If the Association only has one [1] member that member shall be a quorum. In any other case two [2] members entitled to vote upon the business to be transacted shall be a quorum. A proxy or an authorised representative of a member shall count for the purposes of the quorum. No business other than the appointment of the chairman of the meeting is to be transacted at a general meeting if the persons attending it do not constitute a quorum.
