4. DCFA Updates

a) Safeguarding Report – RS presented in the absence of Gary Parkin,

RS updated that he Jenny and Liam had attended the National Safeguaridng Conference in November 2023, Staff in person briefings had taken place and Council written briefing had been sent out post conference and all Codes of Conduct are to be returned by Council members by 20th December 2023.

The 2023/24 season has seen the introduction of the player welfare course and all staff have completed the course. We would ask that all board and council members complete the course which will be mandated for all open age welfare officers for 24/25 affiliation. - advise to all clubs and leagues to do this.

In addition, the FA have introduced new Welfare Officer Workshops for clubs at step 1-4 and Derbyshire have 100% of clubs booked to attend a workshop.

Cases - increase in number - 116 cases reported so far this season - currently 14 ongoing cases that are with the Police or FA SCMT for investigation which are still being managed locally by our DSO.
