- Proof of insurance coverage
- Relevant licenses and permits

Safeguarding

• Organisation safeguarding policy

Equality and Diversity

• Organisation equality policy

Timeline

- Proposed timeline for availability of birthday parties to begin
- Notice period for any bookings to be taken and fulfilled



SUBMISSION DEADLINE

All proposals must be submitted by Friday 19th April.

Late submissions will not be considered.

- Creativity and innovation in event planning
- Cost-effectiveness
- References and reputation
