Dorset County Cup Competitions Hints & Help Season 2018-2019

- All players must be registered in their League at least seven days prior to the date set for the match (except for the Final or Semi-Final Ties (Rule 5(e) of the Dorset Challenge Cup).
 Players may not be signed on the day of the match.
- 2. Please check the <u>Players Cup Eligibility List</u> on Cup Section of the DCFA Website.
- **3.** In all Adult Competitions: should the scores be level after 90 minutes, extra time shall be played, if the scores are still level the result of the match shall be determined by the taking of kicks from the penalty mark. (NO REPLAYS)
- 4. Youth (U10-U18) Competitions: If the scores are still level after extra time the match shall be decided on kicks from the penalty mark in accordance with guidance given in the Laws of Association Football under the procedures to determine the winner of the match (NO REPLAYS).
- The Home club is responsible for reporting the result of the match to Colin Chainey on <u>colin.chainey@dorsetfa.com</u> telephoning 07908 647050 or reply to the Full Time automated Text Message.
- 6. All Cup Team Sheets must be sent to the <u>County Office</u> and not your League Secretary, within three days of the date of the match, clubs may use their League team sheets if they so wish.
- **7.** Opposing teams in a Cup Tie shall exchange team sheets in the Referee's dressing room at least 30 minutes prior to the commencement of the match.
- 8. It shall be the duty of the Home Club to notify the match officials, the visiting Club and the DCFA Member in Charge (where appointed) of match particulars i.e. ground, dressing room, advertised time of kick-off, etc. at least five days before the match where possible. Notification and Amendment of the appointment of Match Officials is done via automated email to both clubs and the Match Officials, these can be viewed on the Cup Section at www.dorsetfa.com
- **9.** Correspondence, draws and fixture amendments will be conveyed via email through the Full Time website.
