

Lincolnshire County FA

Introduction

Anyone who has a concern about the welfare of a child, young person or adult at risk or the behaviour of an adult towards a child, young person under 18 years of age or an adult at risk in football, must refer it to The FA's safeguarding team. The team is staffed by professionals who are experienced in dealing with these concerns.

It is important to state that anything urgent, where there may be an immediate risk of harm to a child, young person or adult at risk, must be reported to the police or the children/adults social care and also to the County FA Designated Safeguarding Officer (DSO).

Referring non-immediate risk of harm concerns can be done via a club, league or County FA Designated Safeguarding Officer (DSO).

If the club or County FA DSO cannot be contacted, call your area's Multi-Agency Support Hub/Duty Team. The numbers can be found in our Important Contact Information section below.

Concerns that someone may be behaving inappropriately or seeking to groom a child in an online environment should be reported via the CEOP website <u>https://www.ceop.police.uk/safety-centre/</u> or by contacting the police on 999 or 101.

Victims of non-recent sexual abuse in football should contact the NSPCC or The FA at safeguarding@thefa.com

If a child or young person is in immediate danger, the advice is ALWAYS to call 999.
