Cup Competitions 2021-22

Five of the youth competitions are already through to the final stage and even the Senior Cup is at the quarter finals.

The Chairman congratulated JH on the smooth running of the cups to date.

Cup Fees

A discussion was held over a possible increase to the youth cups for 2022-23. There has been a surge in entries to our cups this season and the general opinion was that a £5 increase was justified. It was strongly expressed that clubs who drop out in future should be fined and not allowed to get away without penalty.

Abandoned match in October. Both teams expelled. Appeal pending.

Croydon v AFC Cubo
Allegation that Croydon used ineligible players. Under investigation.

AFC Oakwood v Balteze (Sunday Challenge). Protest from Oakwood. Rejected as out of time.

Rise United v Crown Pro Elite (U15 Saturday Club). Complaint about ID. No independent evidence so match score to stand.

Dynamo Youth U12 v Ryan (Youth) Red Echo (U12 Cup)
Dispute over photo ID. No independent evidence. Match score to stand.

Anatolians v Shepherds Bush Old Stars (Veterans Cup). Shepherds Bush caused the abandonment. Expelled from Cup.

Discipline Procedures

ILW expressed concern at the delays and lack of information being provided. The London Turkish Masters v Cheam match is in a disgraceful state. All information concerning the incident have been withheld, so the decision to expel both teams was made blind. Now Cheam have indicated that they wish to appeal. We are left in an impossible situation. Ms PT promised to look into the whole matter.

Cup Final Venues

Some of our 19 youth finals will hopefully be played at the training grounds of Charlton Athletic (6 matches) and Arsenal, free of charge. Dates and final confirmation is awaited.

Other venues will be Haringey Borough and Barking with three matches being played each Saturday and Sunday through March. The girls finals will be held later.
