#### **Judicial Committee Minutes**

## 1 Welcome & Apologies

- Those present were welcomed.
- Louise could not make the call today, so Anita chaired the call.
- Anita welcomed Priti back
- Priti thanked Carl and Aquila for how they managed things so well while she was away which was supported by the committee.

### 2 Minutes of the Meeting held on 19<sup>th</sup> July 2022 and Matters Arising

- The minutes from the previous meeting were agreed.
- See updates to actions on the actions page.
- On AP 7, there was a discussion on the recent media reporting on violence at grass roots football, so being able to demonstrate the volume and nature of the cases that London deals with would be very timely now. We also discussed that more could be done to assist leagues and clubs on how to report incidents as some may not be aware.

#### 3 Discipline team update (Carl)

- Essex, Herts and Middlesex counties have recently joined the regional disciplinary panel which means that the pool that they can call upon has grown, and there are plenty of panel members to hear cases now.
- The numbers of incidents so far are similar to last season. There have been 116 cases to date.
  - Of these, 53 are serious and 63 are non-serious.
  - There have been 17 abandoned games of which 5 are already closed
  - o There have been 18 discrimination cases of which 6 are already closed
  - o 84 of the cases are for adult games and 32 for youth
  - $\circ\quad$  There have been 22 cases of misconduct towards referees
- There have been some significant changes to regulations for this season (and some smaller ones):
  - For abandoned games, counties now have 28 days to raise a charge and hearings must be within 14 days of the date of the charge letter. County now requests dates to avoid from all parties and then sets a hearing date based on this. (To illustrate volumes, last weekend there were 5 – 7 abandoned games)
  - Penalty points are no longer to be issued for fines that do not relate to a player (e.g. supporters/management)

- Spectator behaviour has been split from club official behaviour. Club officials is an E20 fine, and spectators is an E21. The sanctions are identical, so a club could now receive both for this same incident if spectators and club officials/players are involved.
- Financial sanctions have in some areas (e.g. E20) increased significantly this season having been the same for the past 7 years.
- The commission hearing a case where a players or clubs has more than 1 aggravated breach now have the power to deduct league points from the club. There was some discussion on the practicalities of this, e.g. impact on league winners at the end of the season if points are deducted after winners have been awarded, how points are deducted from clubs, not teams, that there is no reference to this in the SCOR or SCORY).

#### 4 Football Services team update (Priti)

- The LFA have now moved premises to Wembley. The team are required to be in the office 1 day per week but are able to work from home on other days.
- Sufi Sangamneheri has now left the company. Jordan Crichlow has been promoted to Investigating Officer. There is a new administrator in Football Services joining on 24<sup>th</sup> October (Freddie Law-Keen), and another administrator (Alfie Howden) is also helping out.
- Lewis Warren has left the safeguarding team, and Carly has been promoted to the DS Manager role, and Harry Woodley has been recruited to the Assistant Designated Safeguarding officer role she vacated.

#### 5 AOB

- David asked when the next window to join the regional panel would open. Priti believes there was a window this Summer, but no-one else was aware. See new action 26.
- Jen asked what training she could do to be eligible to apply to join the disciplinary panel. There is nothing formal, but Priti will send some relevant training material to Jen. See new action 27.
