Item	Area and Discussion	Action
1	Chair's welcome and introductory remarks	
1.1	JM as Chair opened the meeting and explained that due to COVID-19 restrictions, only a very limited number of London FA Directors were permitted to attend this meeting in person. He introduced the Directors present (listed above) and welcomed the 22 members who had joined the EGM virtually (via Microsoft Teams and conference call). Each member then introduced themselves.	
1.2	PB confirmed attendance at the meeting in person (see above) and by proxy (see below) and confirmed that a quorum (more than 25 members) had comfortably been reached.	
1.3	SH explained the purpose of the EGM, namely for members to consider and vote on the three special resolutions set out in the EGM calling notice. All these special resolutions were set out in response to the COVID-19 pandemic, which has severely impacted London FA business and as a result requires certain changes to the Articles to ensure the Association can sensibly and technically comply with its own rules.	
1.4	SH described each of the three proposed special resolutions in turn, referring to the calling notice and London FA Member Communication EGM1 circulated as advance papers to the members.	
1.5	PB then gave a summary of the consultation process and feedback from members, as follows:	
	<ul> <li>The London FA Board had agreed to propose the following three special resolutions in response to the COVID-19 pandemic and this information was provided to the London FA Council members on 17<sup>th</sup> April 2020, in a detailed communication and briefing paper. Council members were asked to respond with any feedback.</li> <li>Council member feedback was overwhelmingly in favour of the proposals</li> </ul>	
	and so the papers were distributed via email and by post to members on 1 <sup>st</sup> May 2020, well within the 21-day EGM advance notice requirements. These documents were also placed on the London FA website.	



	• Two council members had expressed concerns that the proxy notice circulated as document EGM2 did not allow members to vote against the special resolutions. A response had been provided to those Council members by the CEO and PB explained to members that the proxy notice at document EGM2 does make clear how members can issue specific instructions to their proxy and request that their vote is recorded against any of the three resolutions (notes 4 & 5).
