# Matters Arising from Minutes:

No issues from the minutes of the previous meeting.

### KPIs: Report Received from DD

Recruitment – 310 officials recruited as of 11/04/2022 –

Target 199 – (168% ahead of target)

Courses from April being inputted so update to happen on Monday.

Total number of officials – 1007 as of today

Retention – this number has had a glitch as it's gone up and down – The FA to clarify, current percentage 73% and target is 80%

Conversion – again, Power BI is being updated but our current number 52 converted, we expect the number to be closer to the target at Mondays update – target from the FA 119

Progression – We will need to confirm a final number as it was updated as 80 as of earlier this year but some removed – our target is 60, it says 80 so we're completed but again need to just confirm who has been removed.

Our CFA percentage is 88% which is orange, out of the 3 scaled measurement (Green, Amber and Red). Retention is our biggest area for improvement as we would assume.

## Promotion Scheme Update:

RH stated that Gordon Manning and Steve Down are standing down at the end of the season.

Still a massive shortage of observers, for example; March 2022 – 9 games covered by observers, compared to March 2020 – 23.

Most candidates have had at least 2 observations.

5-4 almost everyone will have had their 5 observations, and if they haven't it's generally their fault.

DD – "The FA are making changes which haven't been 100% confirmed, myself and Russell met yesterday to discuss, I will update when The FA have given more concrete information. The promotion won't be as it was this season at all levels between L7 and L5-4."

## Development Group:

No Report and decided to temporarily remove from the agenda although DD added 28th June – Premier League Official coming down, Joint CFA event, decided at our last meeting (RDOs MCFA and AFA) that we will do 3 a season, March, June and November – June to try and encourage re-registration for the season.
