

#### 1. NOTICE TO CONVENE THE MEETING

The Chair of the Board of Directors J McLellan-Grant welcomed all to the meeting noting that these were the most extraordinary times and hoped that everyone was safe and well. Thanks were made to everyone who is going above and beyond in supporting their local communities and in doing so helping us get through the Covid pandemic. The Chair also recorded the recognition of all those connected with Grassroots football across Greater Manchester who are also key workers who have all been heroes. Sadly, the Chair noted that through Covid we have lost friends and family, many of those who had given so much commitment and dedication to the Grassroots Game. He asked that this be recognised with a minute silence whilst our thoughts and prayers be with those that we fondly remember.

The Chair then handed over to the CEO who read out the notice to convene the meeting. The CEO advised of the voting strength of the meeting both in attendance (27) and by proxy (37). Voting strength was 66%.

#### 4. PROPOSED AMENDMENT TO ARTICLES OF ASSOCIATION – Item 2.2 on Proxy Form

The Directors of the Association have proposed the following amendment to the Articles of Association to be put before the General Meeting.

Proposed removal of 'In September' from Article 14 -

14. The Executive and Non-Executive Directors will serve for a term of three years. Following which at a General Meeting in September the persons appointed as Executive Directors pursuant to Article 15 shall retire but are eligible for re-election subject to the application process in Article 15. Elections of Executive Directors to fill the places of those retiring shall be held pursuant to Article 15. This article also applies to the replacement of Executive Directors who may resign, become disqualified or be removed pursuant to Article 20 at any point during the three-year term in place when they are elected.

Rationale for the proposed change: The Board of Directors have the ability in the Standing Orders to set the date of a General Meeting.

Sandra gave the members an overview that the Board of Directors have been able to provide all the reassurances to Beever Struthers of the ability to manage future risks and importantly the commitment statement ensuring the organisation can and will manage a 'Going Concern'.

#### 7. BUSINESS REPORT PRESENTATION FOR SEASON 2019/20 SEASON

The CEO gave a presentation to the members reflecting the 2019/2020 season and the challenges both nationally and locally here in Greater Manchester with the Covid Pandemic.

The CEO explained that internally the resources have had to be managed and that since July Manchester FA have had to utilise the Government Furlough Scheme. However, he was keen to stress that the staff at Manchester FA were there to support Grassroots across Greater Manchester and the utilisation of the Government Furlough Scheme would continue to be operated as flexible furlough. During Covid from March to June 2020 he confirmed that seven of the staff were full time and had not been furloughed.

The challenges moving forward are supporting Grassroots with the return to football. We also expect some changes in the FA's approach to delivery and funding and this information will be communicated as transparently as possible.

The CEO took the opportunity to thank everyone for their support and to thank them for their patience at such a difficult time.

Those is attendance reciprocated the thanks and asked Colin as CEO to thank his team for the support they have given and continue to give grassroots football across Greater Manchester. Some members stating that there was clear leadership from Manchester FA and it was pleasing to see Manchester and local County FA's all working together.

#### SECTION 4 / ITEM 4 – Proposed amendment to the Articles of Association

The Directors of the Association have proposed the following amendment to the Articles of Association to be put before the General Meeting.

Proposed amendments to Article 8 -

- Black Text No Changes in wording
- Green Text Proposed New additional Text
- Red Text Proposed to be deleted

The Board of Directors shall approve an open, transparent and formal procedure to recruit and appoint the FA Representative for Manchester County FA. Completed applications to be the FA Representative for Manchester County FA must be submitted in writing to Manchester County FA by such time as the Directors shall prescribe. Potential candidates must conform to any prescribed Football Association eligibility criteria. Eligible candidates who have completed the application process will be considered for appointment election by the Nominations and Remuneration Sub Committee and a proposal made to the Board of Directors for approval. Once appointed the FA Representative shall serve in accordance with the FA Council's term limits and terms of office. to the end of the NGS that is in place when they are appointed. Should the FA Representative resign or cease to be eligible for the role before the end of their FA term of office, Manchester County FA MCFA will invite applications from those who meet the FA's criteria. The Board of Directors at all times reserve the right to review and if required recruit a new appointment to such role.

Rationale for the proposed change: The FA's changes to FA Representatives Terms on FA Council now include Term Limits (3 x 3 years, maximum of 9 years). The Board of Directors at Manchester FA also would like the ability to review and if required recruit a new appointment at any time during those term limits.
