NORTHUMBERLAND FA CLUB AFFILIATION GUIDE 2022/23





WHAT ARE THE BENEFITS OF AFFILIATION?

At the start of every season, all clubs playing in FA sanctioned leagues and competitions must affiliate to their local County FA.

What is included in your affiliation fee? Affiliation to Northumberland FA gives you access to a huge range of benefits including:

Competitions

- Games are played to The IFAB Laws of the Game, The FA Rules & Regulations, and The FA Standard Code of Rules and Standard Code of Rules for Youth to ensure fairness and integrity.
- Affiliated teams can enter affiliated leagues, cups, and events, to play against other affiliated teams with affiliated match officials.
- All affiliated teams from U12s up to open-age are eligible to enter NFA County Cups.
 There are now 20 separate NFA County Cups, with finals held at Whitley Park, home of Newcastle United U23s, and St James' Park, home of Newcastle United.
- Non-affiliated teams, officials, private football providers, and organisations are ungoverned, so their actions (good or bad) can't be acted upon by County FAs or The FA.

County FA Support

- All clubs, teams, match officials and leagues, can be supported and monitored to
 ensure they meet all legal and FA requirements for safeguarding all young people
 aged under 18, and all vulnerable adults aged over 18, ensuring football is a safe
 activity for everyone. Clubs who do not comply can be suspended.
- Northumberland FA works with key safeguarding agencies and organisations to ensure safeguarding cases are appropriately escalated to ensure football plays its role in protecting young and vulnerable people in society.
- All clubs, teams, match officials, and leagues, can be supported through FA discipline procedures to ensure the sport remains fair, and those who breach rules are appropriately sanctioned and removed from the game if appropriate.
- Clubs and their coaches can access a variety of local CPD opportunities via Northumberland FA's Coach the Coach programme.

• Club access to administrative and governance support and advice e.g. player registration, player transfers, FA Rules.

 Clubs can access FA and CFA programmes such as FA Wildcats, FA Just Play, NFA Inclusion Hubs, FA Squad Girls, and any future programmes, to help clubs develop and grow to support more of their local community access football. Many of these schemes come with financial support.

Clubs can become England Football Accredited (formally FA Charter Standard) ensuring
they meet good practice criteria and can ensure the wider community know your club
aspires to be the best they can be. Benefits include up to £110 Kitlocker Voucher, Nike
Footballs, Digital Asset Pack, and 3* Accredited Clubs can access the FA Club
Improvement Programme, gaining an independent business advisor.

- Affiliated Accredited Clubs are eligible to be nominated either themselves, or have individual members nominated, to be recognised by the NFA England Football Awards and FA England Football Awards.
- Affiliated clubs, their officials, and their players/guardians, are able to access County FA staff support for any help, or issues they may have.
- Affiliated clubs can access benefits from Northumberland FA partner organisations.
- The NFA Benevolent Fund is available to support injured participants who may experience hardship due to becoming injured in football. And our SCARF fund helps keep children playing football in instances where their families are struggling to pay subs, kit costs etc.

FA Technology

- Free Club Management systems: Whole Game System and Club Portal. Allows clubs to register players, club and team officials, check qualification and DBS status of club officials and coaches, pay club invoices, affiliate, manage and apply for England Football Accreditation online.
- Free use of FA Matchday app, allowing clubs to manage their teams and collect subs via a free app.
- Team's leagues can use FA Full-Time league management website for free to provide a high-quality league website at no cost, allowing teams to view tables, fixtures, news, and stats for free.

Facilities

- Free use of PitchPower. The web based app allows clubs to complete grass pitch inspections of their pitches with a mobile phone, spade, and tape measure. After an assessment is completed the club receives a free Pitch Assessment Report from the Grounds Maintenance Association (GMA), which includes Football Foundation funding the club may be eligible to apply for.
- Affiliated clubs can apply to the Football Foundation to gain funding for facility improvements, including: new goalposts, grass pitch improvements, fencing, machinery, club houses/pavilions,
 4G pitches, defibrillators, stadium improvements, floodlighting, and small-sided facilities.
- Affiliated clubs have been able to access emergency funding from the Football Foundation for repairs due to flooding, storms, or other severe weather events.
- County FA staff support and advice on proposed facility developments.

Club / Organisation Governance

- Clubs affiliated to a recognised governing body can open Club/Community Bank Accounts at a number of high street banks to support efficient, sustainable, and safe operations.
- Clubs affiliated to a recognised governing body can apply for charitable status or, to become a community interest company (CIC) to support with UK Tax and VAT payments, as well as being eligible to apply for external charitable funding.

Insurance

- Affiliated Clubs are able to purchase Public Liability insurance to cover legal costs and compensation payments if the club is held responsible for injury or property damage to a client, contractor or another member of the public.
- Affiliated Clubs are able to purchase Personal Accident Insurance to cover players and club members who are seriously injured or die while participating in club football activity.
 - By only playing other affiliated teams in affiliated competitions with affiliated match officials, clubs can be reassured their own insurances remains valid

Discounts

- Northumberland FA has a wide range of partners who offer discounts to affiliated clubs.
 - This includes Veo cameras; Duralock fencing, Grounds Maintenance Services who maintain grass pitches; Agrigem who offer fertiliser products; goals from MH Goals and energy solutions from Fusion for Business.

BEFORE YOU START

All clubs must have:

- A Secretary to arrange fixtures, keep records and deal with Northumberland FA and league correspondence
- A Treasurer to oversee the club's bank account and manage cash flow
- A Chairperson to act as overall manager to the club

Clubs with at least one youth team must have a Club Welfare Officer. This is also best practice for open age teams with any U18 players and disability teams, and will be mandatory from season 23/24

In youth football, the posts of Club Secretary, Chairperson and Treasurer must be held by more than one individual. One person may hold two of these roles, but not all three.

It is also best practice if the Secretary and Welfare Officer roles are held by different people, due to the high workload both of these roles entail.

In Youth football, each team must have at least one coach/manager with the following qualifications. Assistant coaches/assistant managers who take sole charge of a team at training or matches must also have these:

- Online Introduction to Coaching Football (or former Level 1 in Coaching Football)
- In-date FA DBS
- In-date Safeguarding Children Course (available online from summer 2021). Valid for 2 years. Or an in date Safeguarding Children Workshop (face to face which was discontinued 2020)
- In-date Introduction to First Aid in Football (IFAIF). Valid for 3 years.

Assistant coaches and managers who do not have sole charge of a team MUST have at least:

- The FA Playmaker course
- In-date FA DBS
- In-date Safeguarding Children Course (available online from summer 2021). Valid for 2 years. Or an
 in date Safeguarding Children Workshop (face to face which was discontinued 2020) This can be
 recertified free.

BEFORE YOU START

You will need:

- Club Secretary details (this should be you in order to affiliate the Club): FAN number, full name, postcode, email address and date of birth.
- If you have a FAN but don't know it please do not create a new one. Send us your full name, postcode, email address and date of birth and we will search this for you.
- FAN Numbers for the following members of your Committee:
 - Chairperson
 - Treasurer
 - Club Welfare Officer (for Youth Teams only) please note that The FA require a Club Welfare Officer (CWO) for Open Age (adult) football teams who have younger players in their squad.
 - Coaches/ Managers & all Assistants
 - Details of your Teams (including age groups) that you are intending to run along with your kit colours
 - · Name of the League that you are wishing to register with
 - Home Ground details
 - Details of any County Cup Competitions that you intend to enter (see Appendix 1)
 - A copy of your personal accident cover policy document to upload to WGS

Disclosure and Barring Service (DBS)

Please check the qualifications table on the following pages for information on which volunteers require a DBS. If a DBS is required, this MUST be carried out through The FA. DBS checks from other organisations are not acceptable.

Clubs should now use Whole Game System (WGS) to administer FA DBS checks for volunteers.

SAFEGUARDING

Safeguarding children and vulnerable adults is a top priority for Northumberland FA.

It is the responsibility of everyone involved in grassroots football, and we require all clubs to endorse and adhere to The FA's Safeguarding Children Policy.

As an affiliated club, you agree to ensure that:

- Records on WGS accurately reflect the individuals who are working with children, young people and vulnerable adults at your club.
- All individuals have an in date and valid DBS and safeguarding qualification in place, if their role requires it.
- You report any safeguarding concerns to our Designated Safeguarding Officer immediately.

You will not be able to affiliate your club if your volunteers do not have the mandatory qualifications in place.

WELFARE OFFICERS

We regularly hold webinars and events aimed at supporting Welfare Officers and increasing their knowledge around best safeguarding practice.

And for season 22/23 we are launching a new online Welfare Officer Hub which will contain useful resources, information and links to other organisations.

If your Welfare Officer has not already received an invitation to join the Hub, please ask them to email info@northumberlandfa.com to request access.

SAFEGUARDING VISITS

Northumberland FA is required to carry out unannounced safeguarding visits throughout the season. We ask all clubs at the start of the season to provide training schedules to facilitate this.

Visits can take place at training or on a match day, and their purpose is to ensure that those working with young people and vulnerable adults have the correct qualifications, and that these individuals are properly identified by the club on WGS. We also carry out a review of club websites, and ask questions of coaches, players and parents at these visits.

This season we will also be carrying out match day spot checks to ensure that the individuals supervising teams are appropriately linked to the club on WGS, are fully qualified and have the required equipment.

Any issues identified could result in charges under our discipline procedures, and may lead to an in-depth safeguarding review for affected clubs.

KIT AND SPONSORSHIP

Black or dark coloured shirts are not allowed under FA regulations as it leads to kit clashes with match officials. Rule 19 in the Standard Code of Rules and the Standard Code of Rules for Youth Football states that all teams must register the colour of their shirts and shorts with their competition secretary before the start of every new season, and the secretary will decide suitability.

Any team changing colours during the playing season must notify the competition secretary immediately and goalkeepers must wear colours which distinguish them from all other Players and the Match Officials.

In addition, The FA has issued regulations regarding U18 kit sponsorship. It is not appropriate for youth team kit to feature logos relating to age restricted products. Kit should not feature logos relating to businesses involved in gambling, alcohol and tattoos among others.

References to pubs and restaurants MAY be allowed, unless they exist solely for the supply and consumption of alcohol. Sponsorship by pub restaurants **may be** acceptable, but sponsorship by an establishment such as a nightclub or pub that doesn't serve food would not be allowed. In this instance you should contact Northumberland FA for guidance and approval.

Alcoholic drinks, breweries and products, services or activities related to gambling are unlikely to be permissible under any circumstances.

Please contact us for advice if you are in any doubt, before you enter into a contractual agreement and we will be happy to assist you.

READY TO AFFILIATE?

If you are a new club, you must first complete our online New Club Application Form which you can find here: bit.ly/3LZC4J1

Clubs can start the affiliation process through the Whole Game System from 16 May 2022. Please check your club officials have the required qualifications before you submit your application.

Please note that any Discipline Fines outstanding must be paid in full before your application will be approved.

To begin the affiliation process:

- Once affiliation opens on 16 May, log into https://wholegame.thefa.com using your email address and password and click on the 'Club Secretary' tab at the top of the dashboard.
- Click on the 'Affiliation 22-23' tab on the left hand menu. It may take a few minutes for your form to generate as the system loads the most up to date information.
- Ensure your club details are correct on 'My Club'.
- Each stage of the affiliation process has a 'How to Guide' linked to it which will explain what you need to do.
- There are 8 stages to the affiliation process, once you have submitted your application at Stage
 7 you will be able to review it at Stage 8.

WHAT HAPPENS NEXT?

Once you have submitted your application it will be reviewed by our staff.

Please be aware that we deal with a large number of applications. We will process your application as quickly as possible but ensuring all your information is correct and qualifications are in place will speed up the process.

Once your application has been reviewed, we may come back to you with queries which require clarification. If there are no queries, or they have been resolved, your application will be marked as 'submitted and invoiced'. Your invoice will then be available to download and pay through WGS.

If you have entered our County Cup competitions you will receive a separate invoice for this.

Once you have paid and your application is approved your affiliation number will be generated. This can be seen on the affiliation tab in WGS.

Northumberland FA County Cups remain £20 to enter (Senior Cup - £40 & Benevolent Bowl - £25.

INSURANCE

You must have valid Public Liability Insurance in order to affiliate. This covers the cost of claims made by members of the public for incidents that occur in connection with your club activities. This can be purchased for a £30 annual fee within the 'additional products' section of the online affiliation process on Whole Game System.

Alternatively, Clubs may take out their own PL Insurance with a minimum cover of £10,000,000, a copy of this must be attached within your affiliation application on WGS. The policy should be valid until 30 June 2023.

Teams must also take out Personal Accident Insurance. This can be purchased from our partners BlueFin Sports Insurance here:
