STATEMENT FROM THE CHAIR

On behalf of the Board of Directors at the Sheffield & Hallamshire County Football Association Ltd, welcome to the Annual General Meeting 2023.

The Annual General Meeting forms part of the Association's corporate governance structure and I'm delighted to say that we have made significant progress in this area over the past season. Members voted overwhelmingly to support the Board in refreshing the Articles of Association at September's Extraordinary General Meeting. The Articles now allow for and encourage greater diversity and representation across our structures, including the appointment of independent Trustees, and it is pleasing to see that we are able to attract high-calibre applicants to join the Board. Our work in relation to corporate governance will continue to evolve as we push towards the attainment of The FA Code of Governance for County FA's and Equality Standard in Sport (Preliminary level), which will build upon the work undertaken to achieve the Foundation Level which we attained earlier in the season.

As part of our governance work the Association recently undertook an independent Board audit which was commissioned by the FA. The audit report included a number of recommendations, one of which was that I be appointed as the Chair of the Association, which was then supported by the Trustees. I am incredibly proud to have been appointed as Chair and I'm sure that by working collaboratively across the Board, executive and volunteer workforces we can continue to move towards our main strategic metrics.

In relation to football matters, there has been much to celebrate over the past year. Over the summer of 2022 the County FA team played a pivotal role in helping to make the UEFA Women's Euros a huge success across our patch. The combined efforts of the County FA, The FA, Local Authorities, professional clubs and community organisations delivered a truly remarkable fan experience in Rotherham and Sheffield, and of course the Lionesses' performance on the pitch made the whole event one which everyone involved can look back on with great pride.

Our current strategic plan clearly identifies that following the UEFA Women's Euros we would look to the "legacy" to help grow the number of females involved in football locally. In relation to our growth aspirations our performance in 2022-23 has been strong with an additional 2,250 females now playing football. We also stated our aspirations around the growth of disability football within the current strategic cycle, and I was absolutely delighted to be recently informed by The FA that our County FA's performance in this area was the strongest in the country.

Safeguarding, and attainment of the FA Safeguarding Operating Standard, remains a key part of our work. In 2022 we had a first assessment with the NSPCC, who were incredibly complimentary about the work undertaken and the culture within our Association. Safeguarding remains everyone's responsibility, and I'm aware through our Board Safeguarding Champion and Designated Safeguarding Officer that they value and appreciate the work undertaken in this area by club volunteers and Welfare Officers.

Financially the Association posted a year end 2022 surplus which will sit within unrestricted reserves. The future plan remains to invest a significant proportion of reserves in to a 3G facility and pitch-based County FA headquarters. In relation to facilities we continue to work with The Football Foundation to deliver pitch improvements and a number of significant capital projects have been completed during the 2022-23 season.

The main body of this report highlights many successes and I would like to place on record my thanks to the staff team for their dedication and talent in delivering outstanding progress against FA KPIs. Similarly, it is vital that the Association recognises the work of the many volunteers who support grassroots football. I would therefore like to extend the Trustees sincere thanks for everything our member leagues, clubs and grassroots football volunteers do to deliver football across the Sheffield & Hallamshire County FA region. We are looking forward to working with you as we hopefully move towards another successful season in 2023-24.

Finally, talking of success, I'd like to congratulate Sheffield United on their promotion to the Premier League and wish Barnsley and Sheffield Wednesday the best of luck with their play-off campaigns.


