SHCFA 'Euro's Ready' Club Pledge is for clubs who believe they are the best places for Women & Girls to play football in the County. As we move towards the Euros in 2022 in which are delighted to be the home of not 1 but 2 hosts cities. We, the Sheffield & Hallamshire County FA are aiming to not only raise the number of Women & Gils playing/volunteering/Officiating in the game but to also raise the standards of our clubs both on and off the pitch to make them truly the best places for Women & Girls to play football for now and in the future.

The pledge itself is a set of criteria outlined below that will demonstrate to us as well as players/coaches/parents/carers etc that your club take the Women & Girls seriously and, that you are ready to take the game to the next level as we embark on the legacy created by the upcoming Euro's. Meeting the criteria outlined will put your club in the best position to maximise the opportunity of the upcoming tournament and will make you one of our 'Euro's Ready' Clubs.

## What are the benefits of being a Euro's Ready Club?

We hope it will put you and your club in the best position to maximise the effect of the upcoming Euro's and long into the future as well as;

- A more representative volunteer workforce at the club
- A more equal offer for female players (Mixed Clubs)
- Helping to inspire and retain your current crop of players
- Attract new players to the club (with the possibility of additional teams)
- Attract new volunteers to the club

This pledge will demonstrate to your local community that your club is FOR ALL, a club that provides local women and girls a safe space to play football, develops female leadership from a young age and promotes equal representation within your organisation

### What support Is available?

SHCFA Development Officers will offer bespoke support for your club. We will support any clubs who are 'working towards' specific criteria. We will advertise your club through all of our media platforms before, during and after the tournament highlighting that you are a club that provides local women and girls a safe space to play football, develops female leadership from a young age and promotes equal representation within your organisation. We will also direct funding and further resources towards your club to help you meet your goals.

We will include your club on our 'Euro's Ready' club page which will be the first stop for perspective players and parents to find their local football offer. We'll also provide your club a social media website asset pack to support you to maximise the impact of the tournament.







We will provide access to a player survey which will provide your club with bespoke feedback to help meet the needs of your current players and improve your current offer. We'll give you access to an exclusive online coach CPD designed specifically for coaches working with Women & Girls (5-11, 12-16 and adult CPD).







## Criteria

## All Clubs must;

- Be affiliated to SHCFA and have Charter Standard Accreditation
- Have a website/social media platform that is fully up to date with the club "offer" and contact details
- Distribute a listening to players survey (created & designed by CFA) and achieve a return of at least 10% of all female players at the club.
- Already do so or commit to providing female teams with appropriately sized kit\*
- Already have or pledge to work towards 50% of your Club's female teams have a listed female volunteer\*
- Already do or commit to offering equal access to any 'Club paid for' coaching qualifications\*
- Already have or working towards having a representative committee\* (adopt a target of, and take all appropriate actions to encourage, a minimum of 30% of each gender on its committee)

## **Mixed Gender Clubs**

### In Addition to the above

- Already have in place or commit to equal access for ALL teams to access best available pitches on training/matchday\*
- Commit to using representative photography for club media

#### \*Must be written into the Club's Constitution

We feel it is important to clarify that we are not looking to reduce the number of male volunteers who play a vital part in the delivery of female football but, aiming to increase the number of female volunteers alongside the current volunteer workforce.

Generally, this will require a Special General Meeting (SGM) or at your Annual General Meeting (AGM) and a vote. Please ensure that your Club rules are followed to complete this process. If the Club Rules are not followed the committee members aren't appointed lawfully, and so their actions may not be lawful either. This could result in the committee members being personally liable for the actions of the club.
