PLAYER REGISTRATION





Player registration is a key part to the football season. It is vital that all players are correctly registered for insurances and compliance purposes. Leagues may have differing deadlines on when players can be registered by before a match.

Be sure to check with your teams respective leagues on specific rules. Playing unregistered players in affiliated leagues and cups may result in a charge, points deduction or expulsion from a cup competition. It may also void clubs insurance.

PLAYER REGISTRATION





Player Dispensation

Player Dispensation enables children with a disability, Significant Physical Development Delay (SPDD), or who are schooled no more than one year behind the age group prescribed by their date of birth (their "prescribed age group") to play football outside of their prescribed age group.

In the past all applications have been made manually through downloading a form and submitting this alongside evidence to the equality mailbox. The key change to the 2023/2024 season is that all applications will now be made by the player's parent/carer via their whole game system portal.

International Clearance

In accordance with FIFA Regulations, international clearance is required for any player over the age of 10 who is seeking to register for a club in England and has previously been registered for a club abroad (including the other Home Associations), or who is a foreign national seeking to register for the first time in this country.

The Westmorland County FA Senior Challenge Cup is open to all Senior Adult clubs. You may enter a maximum of one team per club. This can be entered into at affiliation stage.

Benevolent Trophy

The Westmorland County FA Benevolent Trophy is open to all Senior Adult clubs. You may enter a maximum of one team per club. This can be entered into at affiliation stage.

Junior Cup

The Westmorland County FA Junior Cup can be entered by Senior Clubs, playing in Westmorland League Division 2 and below, West Lancashire League Reserve Divisions & the Furness League Division 1 and below You may enter a maximum of one team per club. This can be entered into at affiliation stage.

Invitation Trophy

The Westmorland County FA Invitation Trophy is an invite only competition selected by the Westmorland County FA.

SAFEGUARDING ADULTS





Although there is no official requirement for the upcoming season, we as a County FA would recommend that any club with 16 to 18 year old's playing, have coaches that have a DBS and children safeguarding course completed.

As of next season 2024/25 this will be mandatory, so its advised to get this sorted as soon as possible to be compliant.

FACILITIES & INVESTMENT





How can we help?

The Football Foundation are the Premier League, The FA and Government's charity. They provide funding to develop grassroots football facilities across the country and have a number of different funds and programmes which are currently accepting applications.

The Football Foundation also has a free app known as PitchPower which is used for inspecting and improving grass pitches. Once the assessment is completed the regional pitch advisor will generate a report on the findings with observations and recommendations. These recommendations can then support grant applications.

Funds and Programmes include:

- Funding for new or replacement goalposts.
- Grants for Storage Containers for equipment.
- Grants for portable floodlights for use in training areas.
- Grants for minor and major works to improve changing facilities or build new ones.
- A six-year tapered maintenance fund to help enhance or sustain the quality of grass pitches.
- Grants for grass pitch machinery and equipment
- Funding for works to improve the drainage of grass pitches.
- Grants towards ball retention systems, pest control fencing as well as boundary fencing and gates.
- Grants to build or improve the condition of small-sided artificial pitches.
- Grants to help transform unused spaces into quality grass pitches.
- Financial support from the Premier League for National League System and Women's Pyramid Clubs to improve stadium facilities.
- Support to install Automated External Defibrillators and External Storage Cabinets at grassroots football facilities.
- Support for clubs and organisations to become more energy-efficient, targeting clubhouses and pavilions.

Welfare Support

All County FA Youth clubs have a welfare officer and this season year we will continue our support to those in this position.

Last season Westmorland County FA presented at the national safeguarding conference and shared good practice around seven minute briefings. This is a tool to help welfare officers deliver short but effective training sessions to coaches in the club.

They outline a topic and offer key instructions on to notice signs and deal with situations. They also raise awareness of situations that might occur.

REFEREES





Referee Marking

Please see the guidance on how you can effectively mark a referee after a game.

Please ensure that the person marking the referee was at the game.

For good practice, we advice that clubs mark the referee the day after the game.

This gives the marker the chance to reflect and analysee the game before entering an official mark.

How to mark a referee
