### **PLAYER QUALIFICATION DATE**

The player qualification date is **12 noon on Saturday 29 September 2012**, this includes postponements. A “registered player” is one who is either, in the case of a player under written contact, registered with The Association or, in the case of a player without a written contract, registered with a League in which her Club competes in the current season. Any such registration must have been received and accepted by The Association or League by 12 noon on the Saturday previous to the date fixed for playing the Round, and the registration must be continuous through to the date of the match.

Therefore, all players must be registered by **12 noon on Saturday 29 September 2012**, for any ties played in this round irrespective of the date of the game.
