RULES OF THE PREMIER ACADEMY LEAGUE

INTRODUCTION

Definitions

1. In these rules:

"the Academy League" means The Premier Academy League;

"Academy League Match" means a match played in the Academy League competitions;

"Football Academy" means a training establishment operated by a Member Club in accordance with Section N of the Premier League Rules (in the case of a Member Club which is in membership of the Premier League) or Appendix IV to the Regulations of the Football League (in the case of a Member Club which is in membership of the Football League);

"Home Club" means the Member Club at whose venue an Academy League Match is or was or should be or should have been played or, where the Member Clubs participating in that Academy League Match share a venue, the Member Club whose name first appears in respect of that Academy League Match on the Academy League's fixture list;

"Manager" means the Official of a Member Club responsible for selecting the Member Club's first team;

"Match Officials" means referees and assistant referees;

"Member Club" means a club in membership of the Academy League;

"Official" means any director, secretary, servant or representative of a Member Club;

"the Premier League" means The Football Association Premier League Limited;

"the Premier League Rules" means the rules for the time being of the Premier League and a letter and a number following a reference to a Premier League rule identifies the Section in which it is comprised and its number within that Section;

"Rule" followed by a number means the rule so numbered in these rules;

"Section" means a section of the Premier League Rules;

"Strip" means players' shirts, shorts and stockings;

"Visiting Club" means the Member Club playing, which has played, which should play or which should have played an Academy League Match at the venue of a Home Club or, where the Member Clubs participating in the Academy League Match share a ground, the Member Club whose name last appears in respect of that Academy League Match on the Academy League's fixture list;

"the Articles", "the Board", "the Chairman", "the Chief Executive", "clear days", "the Company", "the Football Association", "the Football Association Rules", "the Football League", "Season", "the Secretary", "Student", "Trialist" and "written" or "in writing" each have the meaning set out in Premier League Rule A.1.

Interpretation

2. Unless the context otherwise requires:

2.1 words importing the singular shall include the plural and vice versa; and

2.2 words importing any particular gender shall include all genders.

Headings

3. The headings in these rules are for convenience only and shall not affect their interpretation.

Board Powers

4. Where a discretion, right or power is expressed in these rules to be exercisable by the Board, such discretion, right or power shall be exercisable by the Board in its sole and absolute discretion or as a sole right or power of the Board and shall when exercised be final and binding and not subject to appeal.

Alterations to Rules

5. No alteration shall be made to these rules unless such alteration shall have first been submitted to and approved by:

5.1 the Football Association; and

5.2 clubs in membership of the Premier League in accordance with the provisions of the Articles.

THE LEAGUE

Name

6. The league shall be called "The Premier Academy League" to which names may be added the name of any title sponsor.

Management

7. The Academy League shall be governed, managed and organised by the Premier League acting by and through the Board in accordance with the provisions of the Articles.

Annual General Meeting

8. The Board shall convene an annual general meeting of the Academy League by giving 14 clear days' notice thereof to Member Clubs specifying the time and place of the meeting and the general nature of the business to be transacted thereat.
9. The Chairman or in his absence the Chief Executive or the Secretary shall preside as chairman of the meeting and shall regulate its proceedings as he thinks fit.
10. One representative from each Member Club may attend the meeting and, subject to Rule 5, any resolution put to the meeting shall be passed if approved by two-thirds of such representatives present, representatives of Premier League Clubs having 5 votes and representatives of Football League clubs having one vote.

Membership

11. Membership of the Academy League shall be limited to clubs in membership of the Premier League or the Football League which hold a current licence to operate a Football Academy.
12. Such clubs may become members of the Academy League by submitting to the Secretary on or before the 1st June in each year Form AL1 duly completed.
13. Membership shall lapse at the end of each Season.

Annual Subscription

14. There shall be no annual subscription.

The Academy League Competitions

15. the Academy League shall comprise an Under 18 competition in which a participating team may name on its team sheet up to 3 Under 19 outfield players and 1 Under 19 goalkeeper.
16. Subject to Rules 19 to 25 inclusive, the format of the Academy League competitions shall be determined annually by the Board after the 1st June deadline mentioned in Rule 12 and shall be published to Member Clubs as soon as practicable thereafter.
17. Except with the prior written approval of the Board, Member Clubs shall play home Academy League Matches at the venue indicated on Form AL1. The Board shall be empowered at any time to inspect the pitch and the facilities at all such venues and, if they are considered to be unsuitable for the playing of Academy League Matches, to order that they be played elsewhere.

18. Academy League Matches shall be played in accordance with:
 - 18.1 the Laws of the Game; and
 - 18.2 the Football Association Rules; and
 - 18.3 these rules.

19. Except in the case of any play-off competition to which special rules may be applied, the winner of an Academy League Match shall score 3 points. Each Member Club participating in an Academy League Match which is drawn shall score one point.

20. The results of Academy League Matches in each competition shall be recorded by the Secretary in tables containing in respect of each participating Member Club the following information:
 - 20.1 the number of Academy League Matches played in that Season;
 - 20.2 the number of Academy League Matches won, drawn and lost as a Home Club in that Season;
 - 20.3 the number of Academy League Matches won, drawn and lost as a Visiting Club in that Season;
 - 20.4 the number of goals scored in Academy League Matches by and against that Member Club in that Season;
 - 20.5 the number of points scored in that Season.

21. The position of Member Clubs in a table shall be determined by the number of points scored in that Season, the Member Club having scored the highest number of points being at the top of a table and the Member Club having scored the lowest number of points being at the bottom.

22. If any 2 or more Member Clubs have scored the same number of points their position in a table shall be determined on goal difference, that is to say, the difference between the total number of goals scored by and against a Member Club in Academy League Matches in that Season, and the higher or highest placed Member Club shall be the Member Club with the higher or highest goal difference.

23. If any 2 or more Member Clubs have scored the same number of points and have the same goal difference the higher or highest placed Member Club shall be the Member Club having scored the most goals in Academy League Matches in that Season.

24. If any 2 or more Member Clubs have scored the same number of points, have the same goal difference and have scored the same number of goals in Academy League Matches in that Season they shall be deemed to occupy the same position in a table.

25. If at the end of a Season any 2 or more Member Clubs occupy the same position in a table, the Board shall determine the means, if any, by which they shall be separated.
26. The results of Academy League Matches and each table shall be copied to Member Clubs and to the media by the Secretary as soon as practicable after each Saturday during the Season upon which Academy League Matches are played.
27. The winner of each competition shall receive a trophy, which it shall return to the Secretary in good order and condition not later than 3 weeks before the final Academy League Matches of the next Season, and both the winner of and the runner-up in each competition shall receive 21 commemorative medals to be presented by the Member Club to such of its players and Officials as it thinks fit.

FINANCE

League Expenses

28. Subject to Rule 33, the operating expenses of the Academy League shall be met by the Company.

Academy League Match Expenses

29. The cost of staging Academy League Matches, including the fees and expenses of Match Officials, shall be met by the Home Club and the Visiting Club shall meet the cost of its attendance thereat.

Admission Charges

30. Unless the Board otherwise determine in any particular case, charges for admission to an Academy League Match may be made at the discretion of and retained by the Home Club.

Sponsorship and Broadcasting

31. An Academy League Match shall not be broadcast without the prior written permission of the Board.
32. Member Clubs shall provide such rights, facilities and services as are required to enable the Company to fulfil any contract for the sponsorship of the Academy League or the broadcasting by any means of Academy League Matches.
33. After deducting there from such proportion of the operating expenses of the Academy League as the Board shall decide, the income from any such contract shall be distributed by way of fees equally between Member Clubs.

FIXTURES

Arranging Fixtures

34. The dates of Academy League Matches shall be fixed and published by the Board as soon as practicable prior to the commencement of each Season and except as otherwise provided in Rules 35, 38 and 39, Academy League Matches shall be played on the dates thus fixed.
35. The Board shall have power at any time to change the date upon which an Academy League Match is to be played. Before exercising such power the Board will consult with and take into account any representations made by the Member Clubs participating in the Academy League Match in question and any other Member Club which may be affected thereby.
36. Unless the Board otherwise provides, Academy League Matches will be played on Saturdays, commencing on the last Saturday in August in each Season.
37. Not later than 14 days before the date upon which an Academy League Match is to be played in accordance with the fixture list, (or, if later, on the date upon which the Academy League Match in question is determined), the Home Club shall send Form AL2 to the Visiting Club, the appointed Match Officials and the Secretary.

Postponement of Academy League Matches

38. An Academy League Match shall not be postponed or abandoned except with the written consent of the Board or on the instructions of the appointed referee who shall be empowered to instruct that the Academy League Match be postponed or abandoned only if he considers that the pitch is unfit for or if adverse weather conditions preclude the playing of the Academy League Match.
39. Upon an Academy League Match being postponed or abandoned in accordance with Rule 38, the Home Club shall forthwith give notice thereof to the Secretary in Form AL3 and the Board will thereupon exercise its power under Rule 35 and fix a date upon which the Academy League Match in question shall be played.
40. Except in the case of an Academy League Match which, without either the Home Club or the Visiting Club being at fault, is postponed or abandoned under the provisions of Rule 38, any Member Club which causes the postponement or abandonment of an Academy League Match on the date fixed under Rule 34 or the date to which it is rearranged under Rule 39 will be in breach of these rules.

Kick-off

41. Unless otherwise decided by the Board, after consultation with both the Home Club and the Away Club, the kick-off time of an Academy League Match shall be 11.00am and in any case shall be confirmed on Form AL2.
42. Each Member Club participating in an Academy League Match shall adhere to the kick-off time and the Home Club shall report any delay to the Secretary together with any explanation therefore.
43. Any Member Club which without good reason causes the kick-off of an Academy League Match to be delayed from the time fixed will be in breach of these rules.

Team Sheet

44. At least 30 minutes before the kick-off time of an Academy League Match, each participating Club:
 - 44.1 shall hand to the referee a team sheet in Form AL4; and
 - 44.2 shall hand to its opponents a team sheet in Form AL5, each duly completed.
45. If any player or substitute player named in the team sheet is injured after the submission of the team sheet but before kick-off, upon the referee being satisfied that the injury is such that the player in question cannot reasonably be expected to play, the name of another player may be added to the team sheet as a player or substitute player.
46. No player whose name does not appear on the team sheet shall take the field of play in that Academy League Match.

Substitutes

47. In any Academy League Match a Member Club may include in its team sheet up to 5 substitute players of whom not more than 3 may take part in the Academy League Match subject to the conditions set out in Law 3 of the Laws of the Game.

Duration of Academy League Matches

48. Subject to the provisions of Law 7 of the Laws of the Game and Rule 49, the duration of an Academy League Match shall be 90 minutes.
49. The Board may order an Academy League Match which for whatever reason lasts for less than 90 minutes to count as a completed fixture or to be replayed.
50. The half-time interval in Academy League Matches shall be 10 minutes.

Notification of Academy League Match Results

51. Within 30 minutes of the conclusion of an Academy League Match the Home Club shall notify the result to the Press Association.
52. Each Member Club participating in an Academy League Match shall complete Form AL6 in duplicate, retaining one copy for its own records and submitting the other to the Secretary so that it is received by him within 72 hours of the match concluding.

STRIP

53. When playing in Academy League Matches the players of each participating Member Club shall wear its home Strip unless the home Strips of the participating Member Clubs are alike or similar or are in the opinion of the referee likely to cause confusion in which event players of the Visiting Club shall wear its away Strip or a combination of its home Strip and its away Strip. In the event of any dispute with regard to the Strip to be worn by either Member Club, the referee's decision shall be final.

EQUIPMENT AND FACILITIES

54. The Board shall have power to specify the equipment and facilities to be provided by Member Clubs for the playing of Academy League Matches and the safety of spectators attending them.

MATCH OFFICIALS

Appointment of Match Officials

55. The Board shall arrange the appointment of Match Officials to officiate at each Academy League Match and shall determine the terms and conditions of their appointment.

Rules binding on Match Officials

56. The acceptance by a Match Official of his appointment under Rule 55 shall constitute an agreement with the Company by such Match Official to be bound by and to comply with:
 - 56.1 the Laws of the Game;
 - 56.2 the Football Association Rules;
 - 56.3 these rules.

Fees and Expenses

57. At the conclusion of each Academy League Match, the Home Club shall pay fees and expenses to Match Officials at such rates as the Board shall determine from time to time.
58. No Member Club or Official shall either directly or indirectly make or offer to make any payment to or confer or offer to confer any benefit upon any Match Official.

Pre-Match Procedures

59. Prior to the commencement of an Academy League Match at which he has been appointed to officiate, the referee shall:
 - 59.1 together with the other Match Officials, arrive at the ground not less than 1 hour before the kick-off time;
 - 59.2 decide on the fitness of the pitch for the playing of the Academy League Match and
 - 59.2.1 if the referee considers it to be unfit, instruct that the Academy League Match be postponed or that the kick-off be delayed;
 - 59.2.2 if the referee considers it to be necessary, instruct that the pitch be re-marked;
 - 59.3 receive Form AL4 from each participating Member Club in accordance with Rule 44.1;
 - 59.4 check and approve any football to be used in the Academy League Match;
 - 59.5 ensure that the players' Strip complies with the provisions of Rule 53;
 - 59.6 decide the position of assistant referees for the kick-off and their direction of patrol and ensure that each carries a flag.

Compliance with Instructions

60. Players and Officials shall comply with any lawful instruction given to them by a Match Official officiating at an Academy League Match.

Post-Match Procedures

61. As soon as practicable after officiating at an Academy League Match the referee shall complete and send to the Secretary Forms AL4 and AL7 and shall report to him in writing:
 - 61.1 on the late arrival at the ground of any of the Match Officials giving reasons therefore;
 - 61.2 on the circumstances surrounding the kick-off being delayed;
 - 61.3 on either assistant referee taking over as referee and stating the reasons therefore;
 - 61.4 on any breach of these rules by Member Clubs, players, Officials, Managers and other Match Officials.
62. A referee shall likewise report to the Football Association any breach of the Football Association Rules.

63. Within 72 hours of an Academy League Match each participating Member Club shall submit to the Secretary in Form AL8 a report on the Match Officials officiating at that Academy League Match.

MEDICAL

Attendance of Physiotherapists

64. At each Academy League Match:

- 64.1 Both the Home Club and the Visiting Club shall each procure the attendance of a therapist whose minimum qualification shall be the successful completion of the Football Association's Emergency Aid and First Aid for Sport or equivalent qualification;
- 64.2 the Home Club shall procure the attendance of a qualified medical practitioner or a fully equipped paramedic.
- 64.3 with effect from season 2008/09 the qualified medical practitioner referred to at Rule 64.2 above must hold a current Football Association Resuscitation and Emergency Aid certification or an equivalent qualification.
- 64.4 the Home Club shall before each Academy League Match make available to the Visiting Club an emergency care/medical information sheet in the manner prescribed by the Board.

PLAYERS' ELIGIBILITY

65. A player shall not be named on the team sheet of a Member Club in an Academy League Match unless:
- 65.1 the Member Club holds his registration (other than an amateur or non-contract registration) under the provisions of the Premier League Rules (in the case of a Member Club which is in membership of the Premier League) or the Regulations of the Football League (in the case of a Member Club which is in membership of the Football League);
or
- 65.2 he is a Trialist; or
- 65.3 he is playing a trial match under the provisions of Rule C.1.(i)(i) of the Football Association Rules; or
- 65.4 he is a Student playing under the provisions of Rule C.3.(a)(v) of the Football Association Rules.
66. Subject to Rule 15, a player shall not play in an Academy League Match unless he is aged under 18 on the preceding 31st August.

67. Any Under 19 player playing in an Academy League Match pursuant to Rule 15 must be aged under 19 on the preceding 31st August.

DISCIPLINARY PROCEDURES

68. The provisions of Section R of the Premier League Rules shall apply to the Academy League and Forms 41 to 46 inclusive shall be appropriately adapted for that purpose.
69. By applying for membership of the Academy League under the provisions of Rule 12, a Football League Club shall be deemed to have submitted to the jurisdiction of the Premier League for the purposes of Rule 68.
