The Offer is available to Football Clubs affiliated with the Football Association Ltd who have successfully created a PayPal business account and received their first PayPal payment in the FA Matchday app. The holder of the PayPal account must be aged 18 years or over and must be selected by PayPal to participate in the Offer. PayPal reserves the right to verify the eligibility of the Offer participants.
2. The offer of a £100 discount (the 'Offer') on your next purchase is valid when you use PayPal to pay at participating shops and websites. Offer valid only in the UK and is limited to purchases in Great British Pounds (GBP) only.
