Item 6. Discipline report and figures - season 16/17

Mr Duffield outlined the figures as shown in the previous item. There had been a marked increase in cases and he asked for ideas to improve behaviour. Temporary suspensions were mentioned on the night but Mr Duffield said that any sanction had to fall in line with FA guidelines. Mr Duffield commended the team for the amount of work and high standards.

The CEO reiterated the point about the increase in bad behaviour and stated that it was everyone's responsibility to improve behaviour on and off the field of play. He also thanked Mr Duffield and the Disciplinary Committee/panel members for the work they do and also the time and effort given to the Association.

Item 7. Update on WGS and new 'top notch' affiliation - data, process and payments

Mr Nixon gave an update on the new affiliation approach which has again seen some significant savings passed on to clubs for correct, clean and timely data at the point of affiliation. This is the second season that affiliation has been discounted which in total has seen in the region of £7k passed on to clubs. Mr Nixon also outlined the suggested 'one club' affiliation for season 2018/19 which will again see some significant savings but also ease the affiliation process for clubs and the association
