An application of either 2 or 4 (MAX) per affiliated CLUB/LEAGUE can be made until **12th July 2019**. Please note, there is no guarantee that you will be allocated ANY TICKETS, as the requests always exceed the allocation we receive from the FA, especially if a local team is involved in the match. Should there be an over subscription, then we will take into account the League/Club's 'whole game system' administration and a Club's disciplinary record along with a League/Club's Charter Standard status and the League's/Club's commitment to local grassroots football. **Individual Council member applications will depend on regular attendance at BCFA Council/Committee meetings and supporting BCFA events.** Multiple ticket applications which exceed the maximum allocation (4) will NOT be accepted. This includes anyone with various roles within the game e.g. Clubs, Leagues, BCFA Council membership, RA's, etc.

About the Ticket Holder(s):

In order to comply with FA ticket regulations, the names of ALL ticket holders MUST be provided to the County FA at the point of payment. If the names of ticket holders change for whatever reason, it is your responsibility to notify the County FA immediately with amended names and contact information. Failure to do so may invalidate your application and tickets may be cancelled by the FA and entry to the stadium refused.

Please note – All those who receive tickets MUST adhere to the FA's ticketing rules and regulations which are sent with successful applications. Ticket holders MUST prevent tickets being supplied to any person for resale or used as prizes in auctions, raffles or competitions. We are required to keep a record of the name of each person to whom tickets are issued and, on occasion, the name and addresses of all attendees. If the names we hold on file do not match those at the game or if tickets are sold on, then the applicant or named ticket holders will be banned by the FA and excluded from applying for tickets in the future.
