- Club Secretary, Chair, Treasurer and Welfare Officer must have completed the FA Safeguarding for Committee Members Course (SCM)
- All youth teams (Under 18 and below) managers and coaches are required to have an in-date, FA accepted, Disclosure and Barring Service (DBS) check (within three years of issue date) at the point of affiliation. Managers and Coaches can be submitted without a FA DBS check, but affiliation cannot be approved by the County FA until they have an in-date FA DBS check (in line with FA regulations).
- An individual cannot be the named manager/coach for more than four different youth teams within the same or different clubs, although they can be named as assistant manager/assistant coach for more than four teams.

Please ensure you list **all** teams that you wish to enter in the 2022-23 County Cup competitions. Late entries may not be accepted so it is important that you check with your club's coaches in order to avoid omission and disappointment.

Please note that the U12 Cups (Girls' and Boys') and U13 Girls' Cup will be 9v9 competitions in 2022-23. Mixed gender 11v11 teams are permitted in all competitions including the U18 Youth Shield. U18 Girls' teams (non-mixed) are permitted to enter the GFA Women's Challenge Cup (for Women's Reserve teams). Some Cups may be organised as one-day tournaments if the number of entries is insufficient for a season-long competition.
