## **Guidance for Grassroots Clubs**

## Football Roles and Eligibility for Criminal Records Checks, Child Workforce, August 2013

The Protection of Freedoms Act 2012 [PoFA] has introduced a number of changes to the way in which Criminal Records Checks are carried out.

In order to support grassroots clubs to abide by their legal requirements, following considerable consultation and in line with Government guidance, The FA has defined the roles that are eligible for different levels of checks in football. It is FA policy that checks will be carried out in football for all 16 year olds plus in eligible roles.

In making its decisions on which roles are supervised and which are not, The FA has utilised the Government guidance, alongside the sport sector guidance on supervision, developed by the Sport and Recreation Alliance and the Child Protection in Sport Unit.

Supervision is defined by the legislation as:

- Regular;
- Day to Day:
- Reasonable in all circumstances for protecting children; and
- Carried out by someone in Regulated Activity

Everyone working within the pre-September 2012 definition of regulated activity remains eligible for an enhanced disclosure.

Table1 provides a list of roles that are eligible for a DBS Enhanced Criminal Record Check: with Children's Barred List and Table 2 provides a list of roles that are not eligible, however please note these lists are not exhaustive, if you require further guidance on whether a role is eligible and / or whether it is supervised or not, please contact The FA CRB via FAchecks@TheFA.com or call 0845 210 8080.
