

INTRODUCTION

CHIEF EXECUTIVE





WELCOME TO LANCASHIRE FA'S AFFILIATION GUIDE FOR THE 2021-22 SEASON.

Firstly, a huge welcome back to our longstanding clubs who have experienced unprecedented uncertainty and disruption during the last season. Secondly, a very warm welcome to all the new clubs who are joining us for the first time this year. We very much hope that our entire football community experiences a much more settled season in 2021-22, where we can all enjoy our beautiful game, and all leagues & competitions are completed as planned.

With this in mind, it is important that we all continue to adhere to government and FA measures and guidance to reduce the possibility of another lockdown, as this would likely impact on us all playing the game – we have included best practice around this area to assist you.

RECENT CHANGES

During the current season in the periods without football, we continued to meet with our members on a weekly basis to provide updates as the situation evolved, and to gain valuable feedback on how best we can grow and develop the game. These weekly online meetings will continue for as long as they are required by our members.

We have also had some changes within the staff team at Lancashire FA. Hayley Mather has been appointed Head of Football Services and her team are very keen to ensure that the affiliation process is completed with as little disruption as possible to Club Secretaries, who we consider to be invaluable in their role ensuring hundreds of games go ahead each week. The Football Services team recognise the frustrations that clubs have experienced in previous seasons when trying to get their affiliation issues resolved in a reasonable time and have pledged to ensure that all queries or help is acknowledged and, ideally and wherever possible, resolved within 48 hours of receipt. The team will be on hand full time in the first three weeks of the affiliation window opening so that they can achieve this goal, so affiliate early and make use of the team's support when needed.

FINANCIAL SUPPORT

The financial impact that the pandemic has had on our member clubs cannot be underestimated and, to assist, a reduced affiliation price of £55 per club, regardless of size, will be charged in line with the assistance provided last season.

In addition, during the year, we will continue to work hard to apply for grants and funding to support football facilities and pitch improvements. We use the data that you provide when you affiliate to evidence requirements to our funding partners, so please make sure all details that you submit are fully complete and up-to-date as this is vital data to secure funding.

A FINAL WORD

There are many members of our football family who are either no longer with us or are no longer able to continue their involvement with football, and we would like to take a moment to thank them and pay tribute for their invaluable time and service supporting football.


Finally, we wish everyone in our football community all the very best for the season ahead, starting off with a smooth affiliation supported by the Football Services team.

OPT IN

From Lancashire FA's perspective we are keen to see all our customers opt in so that we can communicate opportunities based on legitimate interests to you from a Voluntary or Playing perspective, by 'opting in' you allow Lancashire FA to connect with you (Club, League, Volunteer, Player and Referee) on a much broader level in respect of Football and how we can enhance and improve your experience as the customer.

By 'opting out' this reduces communication from Lancashire FA and restricts our communication with the customer, therefore you will not have first sight of grassroots football opportunities relevant to you the customer as our engagement with you will be restricted based on this choice.'

CLUB AFFILIATION 2021/22

At the start of each season, ALL clubs playing in FA sanctioned leagues and competitions must affiliate to their local county Football Association. By affiliating with Lancashire FA this will help to ensure that all clubs/ teams have the correct level of insurance, as well a providing you affiliated league who will have access to qualified match officials.

Should a serious incident arise, whether that be from a discipline or a safeguarding point of view, by affiliating with a Lancashire FA this will ensure you have somewhere to raise your concerns and we will be able to offer advice or to investigate the concern for you.

Once you affiliate to a Lancashire FA you must affiliate with them every season, for as long as the club exists. Affiliation is the process by which clubs "register" with their County Football Association, allowing them to play affiliated football for the season. Every club must affiliate each season, this involves supplying details of the teams, as well as the key officers and team officials involved in the running of your club to the Lancashire FA.

The information that is entered at the point of affiliation is vital data, this is the data that we use to be able to apply for funding pots and data that Sports England use to establish areas of need and provide money for pitch improvements and facilities.

As this information is so important for generating better facilities, we would ask you to ensure that all details are correct when entering so that nobody misses out on funding opportunities.

We are not going to issue fines for late affiliation, however it is important that the League Sanction process is not delayed and your affiliation process is fully completed as soon as possible and *no later than 1st July 2021*.

We expect that some things may change from when you affiliate to when the 2021-22 season starts, and we have devised an easy form to complete for any changes you wish to make.

If there are significant changes and additions, we may consider an additional *administration fee of £50*.

2021/2022 club affiliation window will open 17th May 2021. Please ensure you submitted your application early to ensure that we can open the league sanctions on the 9th July 2021

AFFILIATION PROCESS

To commence the affiliation process the Club Secretary will need to log into the Whole Game System with their email address and password.

If, when you try to log into the system, you receive an error message "This email exists on more than one account. Please contact myaccount@thefa.com to resolve the issue".



IN PROGRESS

Once you have logged into the system you will be able to commence the affiliation process. Once you have completed the following, you will be able to submit your application

- * Any club wanting to change their name will need to email info@lancashirefa.com with full details of the current name and the proposed change. Lancashire FA will review the request and inform the club in due course of the decision.
- **If due to the current situation regarding Covid-19 you are unable to confirm your venue for home matches and training, please enter the venues you used last season and update us if and when this changes.
- *** The FA have completed the team migration of data, this will copy drafts of last season's teams, club/team officials etc which clubs will need to review. Any amendments need to be forwarded to info@lancashirefa.com

REVIEW



Once you have submitted for approval at Step 8, the affiliation is then reviewed by Lancashire FA staff. A member of staff will check each step to ensure that it meets our requirements. If there is any information missing, then a member of staff will be in contact with the Club Secretary via email to explain the missing parts of the application. This could include a missing coach, no DBS for a Coach, no league provided etc.

We endeavour to look at all application that have been submitted within 48 hours. Please be mindful of busy periods during affiliation.

SUBMITTED AND INVOICED

If your Club has had no amendments to make or they have already been altered, then the application is then Submitted to be Invoiced. The system will automatically create an invoice which can be paid via Whole Game System. If you have any issues with making payment via the Whole game system please email info@lancashirefa.com

APPROVED

Once payment has been submitted the affiliation will be checked one final time before being submitted for approval.

Please note that any Disciplinary fines & overdue invoices from the previous season must be paid in full before your affiliation application will be approved.

COMPLETED

The Lancashire FA has submitted the affiliation for approval which will then be marked Completed by the system. This can take a couple of days to complete but once completed a unique affiliation number is created.

SAFEGUARDING REQUIREMENTS



The FA continues to be committed to ensure all necessary steps are taken to protect children, young people and vulnerable adults who participate in grassroots football from harm. It is therefore vital that all youth teams must ensure that all safeguarding requirements are met in order for their application to be accepted and approved.

To ensure safeguarding standards are met, the mandatory requirements for youth teams are as follows:

- 1. Chairman, Secretary, Treasurer and Club Welfare Officer must have completed the Online Safeguarding Commitment for Committee Members course.
 - You can access the course *here*. If participants have completed the course since 2017, they will not need to renew until three years have passed.
- 2. All clubs with youth teams must have a Club Welfare Officer who has attended an FA Safeguarding Workshop or renewed their qualification online to ensure the qualification is in date. In addition, the CWO must have attended a Welfare Officer Workshop AND have a COMPLETED valid FA DBS.
- 3. All managers and coaches must have a COMPLETED, valid FA DBS. At the Lancashire FA we monitor DBS Expiry dates so if you have coaches with DBS's due to expire, it is advisable these are addressed as soon as possible to avoid any delays in us being able to approve your affiliation application.

Any clubs that have not received their affiliation number for the 2021-22 season due to an invalid DBS will not be permitted to start their fixtures for the 2021-2022 season.

With this in mind, we ask that affiliation applications are submitted no later than Friday 23rd July 2021. This will enable us to support clubs in ensuring they are fully compliant for the start of the season.



FAQs

- Q-Can I add a Welfare Officer in the Portal Affiliation form without a current FADBS check?
- A No a Welfare Officer needs to have an in date DBS.
- Q Can I add a Welfare Officer in the Portal Affiliation form without a SGW or WOW?
- A No, you will receive warnings, and this won't allow you to affiliate.
- Q Can I add a Youth Team Manager or Coach in the Portal Affiliation form without an FA DBS?
- A No, with face-to-face FA DBS checks reinstated, all Youth Team Managers and Coaches must have a current FA DBS.
- Q Can I add a new Welfare Officer in the Portal Club Officials page without an FA DBS, SGW or WOW?
- A No, this is not allowed. If you need to have a new Welfare Officer who does not have any of these, you will need to contact your Lancashire FA who can support getting the FA DBS check and can record the need for an action plan for the Safeguarding and Welfare Officer Workshops.
- Q Can I add a new Youth Team Manager or Coach in the Portal Team Officials page without an FA DBS?
- A No, this is not allowed. With face-to-face DBS verification now reinstated, all Youth Team Managers and Coaches must have a current FA DBS.



SAFEGUARDING



As part of our safeguarding children strategy, The FA requires those working in eligible* roles with children and young people to pass a DBS check. This is in line with legislation and government guidance and is standard practice.

We provide the framework and guidance for DBS checks in football. The leagues and clubs then have to implement this to ensure those required to have DBS Checks have them. Where the DBS Check highlights relevant information, this is investigated further and a risk assessment is carried out to establish whether or not they will be accepted to work with children and young people in football.

ACTIVITIES THAT REQUIRE A DBS CHECK (ELIGIBILITY*)

* Eligibility is governed by legislation and government guidance. In brief this means a DBS Check is required for anyone aged 16 years or over who undertakes any potentially unsupervised roles working directly with children and young people under the age of 18.

These activities include managing, training, coaching and supervising as well as giving advice or guidance on wellbeing, caring for children or driving a vehicle solely for children on behalf of a club or organisation. All coaches and managers working directly with under-18 players must hold a current, FA-accepted DBS Check.

New guidelines on face-to-face ID document verifications for DBS checks have been produced in line with the Government guidance issued on 1 June 2020, which sees the easing of lockdown restrictions on gatherings, public spaces, and outdoor activities and the phased return of outdoor sport and recreation.

This means that face-to-face ID document verification can now take place as long as the verifier and those requiring their ID to be verified observe all Government guidelines.

WHAT IS THE NATIONAL GAME INSURANCE SCHEME (NGIS)?

In 2011, The FA set out to raise the standards of insurances that could be made available to its affiliated members, to enable access to a uniformity of cover across the grassroots game that hadn't been seen before.

The overarching objective for the NGIS has been to ensure that insurance products, specifically tailored to the needs of grassroots football, could be made available to all.

In 2012, Bluefin Sport was appointed by The FA to deliver the NGIS.

The NGIS provides two core covers – Public Liability and Personal Accident.

It is compulsory for all affiliated clubs to have public liability insurance and all affiliated teams to have personal accident insurance.

When affiliating to Lancashire FA via the Whole Game System, Clubs may choose to opt-in to the NGIS public liability insurance.

Personal accident insurance can be purchased from Bluefin Sport online, or by completing an application form and returning it to them in the post, with a cheque in remittance of the premium payable.

Clubs have the option to purchase the compulsory insurances either via the NGIS or elsewhere.

Other products are available and independent advice can be sourced from a licensed insurance broker.

POLICIES AND PROCEDURES – TEMPLATES

Every football club must have a Safeguarding Children Policy; this could be considered the cornerstone of your club. For your policy to be truly effective members need to understand what it means for them and that includes how it's integrated into daily football activities.

A Safeguarding Children Policy should be based on sound straightforward principles and is the foundation of a well-run and effective club. By signing up to The FA's safeguarding Children Policy and Procedures and implementing key policies and procedures, best practice will soon become common practice.

It's important to make sure that this information is shared with all new members and that your club has a process to check that this is happening. The FA's current affiliation requirements for youth football mean every club with youth teams must have a CWO; they are key to ensuring everyone is aware of the Safeguarding Children Policy and what this really means for the club.

Having an information event such as a pre-season open evening for new players and their parents/carers is an excellent way of introducing your club's officials including the CWO and sharing the philosophy and expectations of the club.

DISABILITY FOOTBALL TALENT IDENTIFICATION

There are an estimated 6% of players within mainstream leagues that are eligible for an England Disability Team.

There may be a future England International currently playing in your team or at your club, who currently doesn't know about the possibility of representing their Country.

The FA eligible impairments to play for an England Para football team are:

Deaf Female, Deaf Male, Cerebral Palsy, Visually Impaired (B2 and B3), Blind and Powerchair.

DISCIPLINE

It is possible that during a match a complaint or discipline charge is made against you. This can occur if a Match Official submits a card or raises misconduct issues that have been experienced during the match. This will be investigated by Lancashire FA.

If you find yourself in this position, you will be able to acknowledge or respond to cases using the Whole Game System and an email will be sent to you if this happens.

We appreciate that you may not have gone through this process before and would offer anybody who would like any support to contact us as soon as they get this notification. We can guide and advise accordingly. Cases will have a response due date and if that date is not met it could lead to additional costs and sine die suspensions for teams and individuals. Please contact us as soon as you receive a charge and we will guide you through the process.

You may also be in a position where you need to make a complaint or raise a concern. We have made this process a lot simpler for you and have specific forms for you to raise these.
