

# **aub Affiliation 2020/21**



Affiliation is the process by which clubs "register" with their County Football Association, allowing them to play Affiliated football for the season. Every club must Affiliate each season, this involves supplying details of the teams, as well as the key officers and team officials involved in the running of your club to the County FA.

### **AFFILIATION PROCESS**

To commence the Affiliation process the Club Secretary will need to log into the <u>Whole Game</u> <u>System</u> with their email address and password.

If, when you try to log into the system, you receive the error message "This email exists on more than one account. Please contact myaccount@thefa.com to resolve the issue". You will need to follow this link in order to resolve the issue - WGS Login - my email exists on more than one account

### **IN PROGRESS**

Once you have logged into the system you will be able to commence the Affiliation process. Once you have completed the following, you will be able to submit your application:

- 1. Club Details
- 2. Club Officials
- 3. Club Grounds
- **4.** Teams and County Cup entries
- 5. Supporting Documents (Personal Accident & Public Liability)
- 6. Membership Fees and NGIS can be purchased
- 7. Summary Page
- 8. Submit for Approval

If as a Club you want to change your name, you will need to email <a href="mailto:Affiliation@LeicestershireFA.com">Affiliation@LeicestershireFA.com</a> with full details of the current name and the proposed change. The County FA will review the request and inform the Club in due course of the decision.

If due to the current situation regarding Covid-19 you are unable to confirm your venue for home matches and training, please enter the venues you used last season and update us if and when this is all confirmed by emailing <a href="mailto:Affiliation@leicestershirefa.com">Affiliation@leicestershirefa.com</a>

The FA have now completed the team migration of data, this will copy drafts of last season's teams, club/team officials etc which clubs will need reviewing. Please make sure this information is correct before you submit, as you will not be able to make changes once it is submitted until Affiliation is approved. ### **REVIEW**

The County FA will then review your Affiliation. This process may take a little while in the current climate. Following the review, we will either submit the Affiliation to the invoicing stage or feedback to you any required amendments. These may include but are not limited to, adding a coach to a team, informing us of which league the team will be playing in, adding in missed insurance products.

The feedback will be via email to the club secretary; therefore, it is important that the club secretary monitors their emails on a regular basis.

### **SUBMITTED AND INVOICED**

The only payment required at this stage will be for Public Liability Insurance and this will be processed through the Whole Game System. All other Affiliation costs will need to be paid by 31<sup>st</sup> August 2020. This will include any outstanding debts from the 2019/20 season. Due to COVID-19 we can only take payments online through Whole Game.

### **APPROVED**

Once payment has been submitted, the County FA will conduct a final review before confirming your completed Affiliation.

### **COMPLETED**

Following the final review, the County FA will approve your Affiliation and send a confirmation email to the club secretary with the club Affiliation number. Until receipt of the confirmation email you are **NOT** Affiliated.

### **RESUMPTION OF GRASSROOTS FOOTBALL**

Once we confirm a restart date for Grassroots football the County FA will contact you regarding any outstanding safeguarding requirements for the Club/Club Officials

**Please note** that becoming Affiliated for the 2020/21 season is **NOT** an indication that your club and its players can start arranging matches. It is crucial that we all continue to follow Government, Public Health England and <u>Football Association guidelines</u> and for now, for the safety of all those involved in football, we ask you to respect these guidelines.

# Safeguarding & First Aid



### Safeguarding

The FA have lifted several safeguarding requirements as a temporary measure to allow County FA's to Affiliate clubs during the lockdown period. This allows County FA to Affiliate a club if:

- a. A coach/manager and/or assistant does not hold an in-date accepted FA DBS Check;
- b. A Club Welfare Officer (CWO) does not hold an in-date accepted FA DBS Check:
- c. A CWO has not completed the relevant safeguarding training (Safeguarding Children Workshop (SCW), Welfare Officer Workshop (WOW) and online Safeguarding for Committee Members (SCM).

For the avoidance of doubt, these requirements are being lifted purely so that clubs can Affiliate and coaches and CWOs must have an accepted FA DBS Check prior to carrying out their roles.

Club Chairpersons, Secretaries, Treasurers and Welfare Officers will have completed, or must still complete, the free online Safeguarding for Committee Members' course, which details their governance and operational safeguarding responsibilities as officers of the club.

# **The FA Safeguarding for Committee Members**

Coaches who need to renew their Safeguarding Workshop can still do so online for free.

# **The FA Safeguarding Workshop Online Recertification**

### **DBS Checks**

All individuals whose DBS checks are due to expire between 1 March 2020 and 1 October 2020 will not be required to renew their DBS checks until 1 year after the scheduled date of expiry. The FA currently requires DBS checks to be renewed every 3 years in accordance with industry standards and best practice. However, we have made an informed decision to extend that to 4 years, in these limited circumstances, on the basis of the current health crisis and associated difficulties in DBS check renewal and the fact that these individuals already hold a DBS check which has been accepted by The FA.

# FA Level 1 Introduction to First Aid in Football (IFAiF)

To support coaches whose IFAiF has expired since the start of the COVID-19 period (Monday 13 March) an interim extension has been put in place until Friday 31 July 2020. All FAN records will automatically be updated to reflect this. For coaches this applies to, it is recommended that they complete both The FA's <u>Sudden Cardiac Arrest</u> and <u>Concussion</u> modules as part of their CPD to refresh their knowledge.

# Fees for 2020/21 Season



The early end to the 2019/20 season and lockdown caused by COVID-19 has had a profound affect on clubs across the county. We wanted to show our support for clubs by either reducing our fees or in some cases removing them all together.

### We have taken the decision to give every club Free Affiliation for the 2020/21 season.

It doesn't seem right to charge a club a late fee for not Affiliating when we have no confirmed return date. So for this season we have removed the fee.

Each team will cost just £10 this season. This is for every team no matter what level you play at.

While we are still unsure of a start date for the season, County Cups have been placed on hold. You will not be automatically charged for a County Cup competition at this moment in time. When we discover a season start date, we will review the viability of playing all of our cups. We will contact you with plenty of time to ensure you are entered for the counties premier competition.

This season pricing has been designed to save clubs money allowing them time to rebuild while being able to continue football. On average, Youth clubs will save over £500 that's a 40% reduction on the previous season while single adult clubs will save between £60 and over £200 (49% - 76%), depending on the level you play at.

### **New Clubs**

A new Club playing their home matches in Leicestershire or Rutland will need to complete the new Club form which can be <u>found here</u>. On receipt of the completed form, the County FA will create the Club and inform you when you can commence the Affiliation process. It may take up to 7 days before we are able to acknowledge your request.

# Insurance Cover



The Insurance Premiums detailed below have been discounted to reflect the group policy arrangements we have as a County FA. As with last season, all teams Affiliated to Leicestershire & Rutland CFA are covered by the group policies as a minimum requirement for Affiliation. The Group Policy is equivalent to Intermediate for Youth and Superior Gold for Adults. Clubs can purchase additional levels of cover through contacting Bluefin directly but would still need to purchase the group policy through Affiliation. # **REDUCED PREMIUMS FOR THE 2020/21 SEASON**

Please note that the premiums detailed above in respect of adult 11-a-side teams and youth teams incorporate a discount to reflect the period of inactivity during the 2019/20 season, due to the COVID-19 pandemic.

For the 2020/21 season Leicestershire & Rutland CFA have arranged a group insurance policy for all their Affiliated adult and youth teams.

This can only be taken out through the Affiliation process. Clubs have the option of purchasing additional levels of cover direct through Bluefin Sports but will need to purchase the group insurance policy through administration first.

Leicestershire & Rutland CFA will be issuing documentation direct to all eligible teams confirming these basic covers are in place once they have completed Affiliation.

# Roles and Qualifications Required



Running a football club is a large project which requires time and effort. This means there are several roles which are mandated by The FA for the club to run successfully. The below table provides clarification for clubs, of the roles and the required qualifications for each role: -
