JOB PURPOSE(S)

- To support delivery of The FA Grassroots Football Strategy and the L&RCFA Business Strategy.
- To ensure that every affiliated football fixture is played on a 'good' quality pitch.
- To identify and activate priority projects for Football Foundation investment via Local Football Facility Plans.
- To protect existing football facilities from planning application unless the facility will be enhanced.
- To contribute to the effective implementation of The FA's Safeguarding Operating Standard for County FAs.
- To support the adoption of FA technology systems across grassroots football.
- To comply with FA rules, regulations, policies, procedures and guidance that are in place from time to time.

LOCATION	Based at the L&RCFA Headquarters, frequent travel to other locations across the Leicestershire and Rutland will be required with some home working.
WORKING HOURS	37.5 hours per week, some evening and weekend work will be required.
CONTRACT TYPE	Fixed term until 30 th June 2024 with possible extension.
SALARY	From £28,000 per annum.



RESPONSIBILITIES

- Support delivery of all activities that ensure every affiliated football fixture is played on a 'good' quality pitch including the use of PitchPower and the Hive Groundskeepers Community.
- Support the training of grounds staff and ensure monitoring is completed using PitchPower.
- Track the quantity and quality of football pitches and facilities for affiliated fixtures ensuring that artificial grass pitches remain on the FA pitch register.
- Ensure that the outcomes of each facility project are aligned to the Football Foundation measurement framework and the FA's National Game Strategy.
- Ensure that each local authority area has a robust Local Football Facility Plan in place to identify priority projects for potential investment.
- Activate priority projects from Local Football Facility Plans to generate enough demand and deliver against Football Foundation spend targets.
- Activate grass pitch and smaller projects from Local Football Facility Plans to generate enough demand and deliver against Football Foundation spend targets.
- Support the Football Foundation by arranging and attending support days providing guidance to Football Foundation applicants working on priority projects and ensure progress is in line with delivery plans.
- Support the Football Foundation to deliver support days to monitor and evaluate previously funded Football Foundation projects providing guidance to ensure they are achieving the required outcomes.
- Contribute to the development of Local Authority Playing Pitch Strategies and provide responses to planning applications affecting football facilities.
- Support the L&RCFA with the usage, contracts, strategic management and future planning of its Head Quarters.
- Collaborate with The FA, Football Foundation, Grounds Management Association and Sport England.
- Develop collaborative working partnerships with local authorities, clubs, leagues, schools and other facility providers.
- Provide the highest level of customer excellence to support volunteers across all FA Technology systems (FA Events, Whole Game System, Matchday app and Full-Time).
- Promote The FA technical guidance documents to local authorities, clubs, leagues, schools and other facility providers.
- Ensure contract agreements are in place with all contractors (facility hire, consultants etc.) and that these outline the requisite safeguarding responsibilities and accountabilities for all parties.
- Contribute to ensuring that safeguarding and equality, diversity and inclusion are embedded throughout the and grassroots football.
- Collaborate with the Designated Safeguarding Officer in all matters involving under-18s and adults at risk within all facility and investment projects.
- Risk assess all LRCFA events and activity for under-18s and where the LRCFA directly deploys under-18 referees, coaches and volunteers to ensure that appropriate safeguards are in place.
- Listen to and consult with under-18s on their experiences of grassroots football as part of the LRCFA youth engagement strategy.
- Execute tasks as required to meet the LRCFA changing priorities.
