3. MINUTES OF PREVIOUS COMMITTEE MEETING:- They were accepted as an accurate record.

4. MATTERS ARISING FROM THE PREVIOUS MINUTES:- There were no matters arising from the minutes.

5. CORRESPONDENCE: - There were no correspondence.

6. SE DIV VISIT TO WESFA COMMITTEE MEETING:- For those not attending the last meeting L Newham gave a résumé of the meeting.

L Newham and M Burke attended the WESFA committee meeting on Thursday 10 November 2022. We posed the question 'What can the LFA do for you?'

The league was most concerned that their telephone calls are not answered. Whereas phone calls to Kent FA and Essex FA are answered immediately. The league Treasurer phoned the LFA office but to no avail. Out of desperation she went on social media and let out her frustration. Not long after she received a call from the LFA.

The league felt that the LFA office should be manned at weekends as most leagues play either on a Saturday or Sunday. They also felt that a Safeguarding phone line should be manned at weekends.

There is a distinct lack of mentoring and support for referees by the LFA. It was agreed that the Divisional Secretary shall write to the Secretary of the LFA Referees Committee drawing this to their attention.

Clubs should be instructed on how to mark a referee. In the past the form for marking a referee in LFA Cup games had a box to place a mark. For instance 'Did the referee keep up with play?

When applying to affiliate on line clubs are automatically entered into an LFA Cup even if the club does not want to enter a cup. This has to be filled in before one can progress onto the next page.

Fund for improving pitches. The league showed concern that many of the goalposts are rusty and a collision with one could open a wound which could become infected.

Next February the league will hold a club meeting. The LFA SE Division is invited and the league also extends the invitation to a referee to speak to the clubs.
