Important Cup Rules

If your opposition do not provide Player ID cards or a Whole Game System Player Registration Print Out (with pictures and date of birth clearly visible) before kick-off, do not play the match, if you agree to play the match then you run the risk of the match being replayed or the result standing.

Extra Time & Penalties

No Extra Time, Straight to Penalties

All London Cup matches will go straight to penalties if the scores are level after regulation up to and including the quarterfinals

If the score remains level after normal time, extra time will be played (Semi-finals & Finals only).

Substitutions

 London Youth Cups, a maximum of 5 substitutes may be named, with <u>roll-on, roll-off</u> <u>substitutions</u> made throughout the game

Please read the below to avoid being fined:

Team Sheets

Clubs must download, print and complete their team sheet and give to the referee 15 minutes prior to kick off. The team sheets are available to download at www.LondonFA.com/Cups-and-Competitions



Please ensure that the referee is handed the team sheet,

given a copy or takes a clear picture of the team sheet to submit to London FA. Clubs are expected to ensure their team sheet is either handed to the referee, emailed or scanned. Clear pictures sent via e-mail are acceptable. If a team sheet is not received by London FA within 4 days of the match, the club can face a fine.

Referee Marks Results Sheet

After each London Cup match, we will need a mark of the referee's performance from each team. Please do either of the below options:

Referees should be marked out of 100 with any mark 60 or below requiring a written report explaining the low mark. 1 of the above must be returned within 4 days of the match or the club may face a £25 fine. Please see the below guidance on referee's marks:

Well Below Standard - 0-60

Below Standard - 61-69

Standard Expected - 70-75

Above Standard - 76-85

Well Above Standard/Exceptional – 86-100

Size of Ball

The size of ball to be used is as follows:

Under 12, 13 & 14 - Size 4

Under 15, 16, 17 & 18 - Size 5

Match Officials

Referees will be appointed by London FA and assistant referees will be appointed from the semi-finals onwards. In the early rounds, if you are the home team, you must contact Jamaal Horne for approval, if you are going to source your own referee. In the event of a referee being



incapacitated or unable to attend the match, the clubs may source a local referee or must agree upon a 'club referee' to officiate the match. The match must be played.

Match Expenses and Costs

Regarding cost sharing specific to the London Youth Cup, we please request that clubs adhere to the below:

When 1 Referee Appointed

Home Team – pays for the pitch

Away Team – pays for the referee

When 3 Referees Appointed

Home Team – pays for the pitch and 1 Assistant Referee

Away Team – pays for the referee and 1 Assistant Referee

Full-Time

The London FA Cups will be administered by Full-Time with further information e.g., draws, fixtures, referee appointments etc. provided on the London FA website.

If you are not receiving Full Time notifications, please email Jamaal.Horne@LondonFA.com asap.

Email Notifications

One of the key aspects to Full-Time is that fixtures and referee appointments are automatically emailed to clubs and referees on a "need to know" basis. Emails are sent when the fixtures and/or appointments are created or adjusted and as a reminder closer to match time.



Please ensure at least 1 member of your club has their email verified to receive notifications from Full Time If you are unsure, please check your email, spam and/or junk for an email from donotreply@FullTime or email Jamaal.Horne@LondonFA.com.

Pre-match Communication

Please confirm venue and kick off time as early as possible

The secretary of the home club is responsible for communicating the kick-off time and venue to the away team secretary and match officials a minimum of 7 days before the match. We understand there will be 1st Round teething problems and we will be as reasonable as possible. From the 2nd Round onwards, this will be strictly enforced.

Contact details for all parties will be sent via Full Time as soon as the match has been arranged and again 14 days before the fixture. You will also receive notification when match officials are added or changed. It is then vital the home club secretary contacts the away team and match official(s). Failure to do so can result in the home club being fined.

Kick-Off Time – Any teams failing to agree on a kick-off time should contact London FA for a decision. All London Cup Competition Matches must kick-off between 10:00am – 2:00pm unless otherwise agreed by both teams in writing.

If a team wishes to play a match at a later kick-off time, under floodlights, special permissions must be sought, in writing, from London FA. Permission will only be granted with the agreement of both participating teams.

Any teams drawn at home, failing to contact their opposition and referee may face a fine.
