

## **Membership Rules 2022-23**

Membership Rules of Norfolk County Football Association  
(The "Association")

The Rules are made pursuant to the Association's Articles of Association and may only be changed in accordance with Article 47. If there is any conflict between these Rules and the Articles of Association, and Articles of Association shall prevail.

### **1. Membership**

All clubs and leagues shall be properly constituted. Such constitution shall provide for the election of at least three officers at an Annual General Meeting and they shall include a President and/or Chairman, a Secretary and Treasurer. Clubs and Leagues shall maintain Minutes of all meetings, appropriate books of accounts and shall have a banking account in the name of the club/league. If the Club has assigned its entitlement to such monies or any part of them, payment will be made by the association as directed in the assignment. This assignment must be completed and signed by at least two Officers of the Club.

The Membership of the Association shall consist of Members of the Association's Board or Council in accordance with Article 20. Affiliated clubs and sanctioned leagues, which are held electronically by the Association for the current season shall be regarded as affiliates of the Association. Such affiliates shall be entitled to attend any General meetings of the Association but shall not have the right to vote at such meetings.

All eligible open age Clubs must enter at least one County Cup Competition, including any Club whose only open age teams are female, with the exception of Professional Clubs

The Cup that is entered must be the most senior Competition for which the Club is eligible unless otherwise agreed by the Board or any delegated Committee appointed for that purpose.

### **2. Affiliation Fees**

Each season, every Club is required to pay a fee for each team that they affiliate as detailed within the annual affiliation document.

### **3. Unaffiliated Teams**

No teams shall be permitted to play in any competition sanctioned by The Football Association or any other Association until the required payment is received at the registered office and the affiliation process has been completed.

### **4. Long Service Awards**

All Long Service Awards will only be considered by the completion of the official nomination form (online or hard copy) which is accessible from NorfolkFA.com or alternatively sent out from County Headquarters on request.

Nominations must be fully completed and submitted to the County FA by no later than 1 July, Annual nominations will be considered by the Board at the first meeting following the deadline date. The following categories' are eligible for nomination:

## **FA Awards**

### **The FA's 100 Year Award for Clubs**

Awarded to those clubs which can provide evidence that the club has been in existence for a period of 100 years

### **The FA's 50 Year Service to Football**

Awarded to those individuals, who have given 50 years' service as a player, referee, assessor, coach or administrator from the age of 18

## **Club Awards**

### **Service as a Club Officer or Official**

Awarded to those individuals, who have served an individual club for a specified minimum period of time whilst holding the position of an elected club officer or committee member. Awards are available for 10, 15 and 25 years' service.

## **League Awards**

### **Service as a League Officer or Official**

Awarded to those individuals, who have served in any league sanctioned by Norfolk FA for a specified minimum period of time whilst holding a position as an elected league officer or committee member. Awards are available for 10, 15 and 25 years' service.

## **Match Officials Awards**

### **Service as a Match Official**

Awarded to those individuals, who have registered and refereed consecutively for a specified minimum period of time in the County of Norfolk. Awards are available for 10, 15 and 25 years' service.

## **Groundsman Awards**

### **Service as a Club Groundsman**

Awarded to those individuals, who have undertaken the duties of a Norfolk club Groundsman for a specified minimum period of time. Awards are available for 10, 15 and 25 years' service.

## **Council Members Awards**

### **Service as a Norfolk County Football Association Council Official**

Awarded to those individuals, who have served on the Norfolk County FA Council for a specified minimum period of time. Awards are available for 15, 25 and 50 years' service.

## **5. Breach of rules and misconduct**

In the event of any club, body or individual who are affiliated, or subject to the jurisdiction of this Association being reported for a breach of rules or misconduct, the Board or a Commission or Regulatory Services Committee appointed by the Board shall investigate the report.

If the club, body or individual is proved guilty to the satisfaction of the Board, Commission or Regulatory Services Committee they shall have the power to order the name of the offending club, body or individual to be removed from this Association, or suspended for a stated period, or be with in such manner as the Board, Commission or Disciplinary Committee may think fit.

Any club, body or individual playing with, or against the offending club, body or individual after such removal, or during such time of suspension shall also be dealt with as the Board, Commission or Regulatory Services Committee may think fit.

No suspended individual, or member or any club or body so suspended or removed from this Association shall be eligible for membership of any other club affiliated to, or body sanctioned by, this Association without the special permission of the Board. The Board, Commission or Regulatory Services Committee may also order any offending club, body or individual to pay all expenses incurred in hearing the case.

Field offences shall be dealt with as laid down in the Memorandum of Procedures for dealing with field offences committed by participants. The provisions relating to Personal Hearing deposit fees as contained in the Association's Memorandum of Procedures for dealing with field offences shall apply to persons or clubs charged with breaches of FA rules or procedures.

#### **6. Responsibility for Misconduct**

Every club is responsible to the Association for the action of its Players, Officials and Spectators. Clubs are further required to take all precautions necessary to prevent Spectators threatening or assaulting Officials and Players before, during, or at the conclusion of matches. Referees, Assistant Referees, Players or Officials shall not make bets on any football match in which they are involved.

#### **7. Inspection**

This Association shall have the right to request the provision to this Association of any documents or information held by any Club, League, Charity or other Competitions, including, but not limited to, meeting minutes and accounts. A minimum of two affiliated clubs' documents shall be inspected annually under Football Association Rules. A minimum of one sanctioned league's documents shall also be inspected annually.

#### **8. Club & Referee Colours**

No team playing in any competition sanctioned by this Association shall play in predominately black, navy or dark blue shirts. Prior to purchasing a new kit it is recommended that a Club contact the Football Services team if they are unsure whether the kit will be permitted.

In all competitions sanctioned by this Association, Match Officials are permitted to wear uniforms comprising a plain shirt, which must be almost entirely black with a white or black collar and black shorts. Alternatively Match Officials may wear non-black shirts, in which case the shirt must be almost entirely of a single colour, with black shorts. In all cases socks must be black and the sock top will be black, white or the colour of the shirt or its collar.

In the event of a Match Official being appointed to a match involving neutral assistants, all the Match Officials must wear shirts of the same colour.

If the Match Official(s) are wearing a coloured shirt, in the event of such shirt clashing with either team, the Match Official(s) must wear an alternative colour that does not clash or alternatively wear a black shirt.

#### **9. County Team**

When a player has been selected by this Association to play in a representative match, no club affiliated to this Association shall permit the player to play for them on that day or in a match during the 48 hours immediately preceding the time of the kick-off of the representative match, unless permission is given by the Chief Executive of the Association. Failure to comply may result in a fine not exceeding £100.

#### **10. Special Distinction Award**

The Board may, at their discretion, give an award to any Player who has, in their opinion, especially distinguished himself in County Matches. They may also, at their discretion, give a special award for exceptionally distinguished service under like circumstances for distinguished service as a club player.

#### **11. Non-affiliated Clubs**

No club affiliated to this Association shall play any matches with clubs not affiliated to this or another Association. All Leagues, Charity, and other Competitions, shall be sanctioned by this Association. Clubs breaking this Rule shall be dealt with as deemed fit by the Board.

#### **12. Council access to Grounds**

Any Member of Council and designated Staff shall have free access to any ground, or part thereof, of any club affiliated to this Association, when on Official County FA business, upon showing their official card or giving other satisfactory proof of their identity. An identification card shall be issued to each member of the Council, and designated Staff, but such card shall be and remain the property of the Association and be returnable to the Chief Executive of the Association on membership ceasing.

#### **13. Right of Appeal**

Any club, body or individual wishing to appeal against a decision of this Association shall forward to [discipline@TheFA.com](mailto:discipline@TheFA.com) or by post to The Judicial Services Department, The Football Association, Wembley Stadium, PO Box 1966, London, SW1P 9EQ within 14 days from the date of the meeting at which the Association gave its decision and by special delivery or signed for post, a notice setting forward the grounds of the appeal together with the sum of Fifty Pounds (£50).

At the same time an exact copy of the notice must be sent to the Chief Executive of this Association, also by special delivery or signed for post. In the case of a body or club, the appeal must be signed by the Secretary, or their nominated deputy and one member of the Committee.

Appeals cannot be made in regard to matters arising out of the Competitions of this Association when the Rules provide that the decision of this Association shall be final.

The Appeals Board appointed by The Football Association to hear the appeal shall have the power to order the Fifty Pounds (£50) to be forfeited, if it thinks fit, and may, in addition, order the appellant concerned to pay the cost of the hearing of the appeal.

#### **14. County Colours & Representation**

The County Colours are Cardinal (red) and Green. The County playing colours are:

- Home – Green & White Shirts, Green Shorts & White Socks
- Away – Cardinal (Red) & White Shirts, Cardinal (Red) Shorts & White Socks

#### **County Youth Team**

##### **First Appearances**

Any player who represents the Association in one match shall be awarded a County Certificate.

##### **County Colours**

Any player playing in two (2) County Youth Matches shall be awarded his County Colours

##### **County Caps**

Any player who plays in four (4) County Youth Matches shall be awarded a County Cap.

#### **15. Reports in the Media & the Public Domain including electronic and social media platforms**

The Association shall have absolute power to publish through the media, or in any other manner it shall think fit, a report of all or any of its acts and resolutions, whether the same shall or shall not reflect on the character or conduct of any Club, Body, Player, Match Official or Spectator affiliated, sanctioned, registered or subject to the Association. Every such Club, Body, Player, Match Official or Spectator shall, by being so affiliated, sanctioned, registered or subject, be deemed to have assented to such publication.

#### **16. Regulations Concerning Approaches**

Players who are not under written contract to a club may be registered with a number of clubs at any time, subject to the following provisions and those of the Competitions in which they play:

- i) Competitions sanctioned by The Association under regulation 3 of the “Regulations for the Sanction and Control of Competitions” may make their own regulations for the approach of Players between Clubs of the Competition;
- ii) During the current season any Club wishing to approach a Player known to be registered with or having played for any other Club must give to the secretary of each such Club, seven days’ formal written notice of the intention to approach the Player;

Formal written notice of approach need to be given by:

- (A) a Saturday Club only to all Saturday Clubs;
- (B) a Sunday Club to all Sunday Clubs; and
- (C) a midweek Club only to all midweek Clubs

- iii) The written notice must be made by special delivery or signed for post, or a written acknowledgment otherwise obtained from the Secretary or Chairman of the Club approached. E-mail may be used provided a receipt of acknowledgment/delivery is also obtained;
- iv) Following the date of posting of the written notice of approach, :
  - (A) the player may be registered on the eighth day; and
  - (B) the player must have been registered before the 21st day;
- v) the approaching Club
  - (A) may not approach the same player a second time in the same playing season;
  - (B) may approach only one (1) Player at a club at any time subject to Rule 16 (viii) below; and
  - (C) may not approach another player at the same club within 28 days of an earlier notice of approach or acknowledgment. The 28 days commences from the date the initial formal approach is made;
- vi) If an approach is made by a Player to another Club during the current season, that Club shall give the Club(s), for which the Player is known to be registered or has played, seven days’ notice of approach as set out in Rule 16 (i) to (v) above before registering or transferring the Player.
- vii) A Club which is the subject of a complaint alleging failure to give notice in accordance with this Rule may be subject to a charge of Misconduct pursuant to FA Rule E1(b)
- viii) A Club proven to have breached the provisions of this Rule may have its current registration of the Player cancelled and be subject to such other penalty as the Association

- deems appropriate, in accordance with relevant regulations of the Association from time to time
- ix) During the current season a maximum of two Players may be approached in the manner described above if invited to trial at a licensed academy or 'Centre of Excellence' of the Association, The FA Premier League or the English Football League
- Conditions
- i) All payments made to Players must be made by the club and fully recorded in the accounting records of the Club
- ii) All Salaried payments must be subject to PAYE and National Insurance
- iii) Any player's paid expenses must be reimbursed via an expense claim form. The Club must retain all expense records in a format acceptable to the HM Revenue and Customs
- iv) A Player approached on or after 1st May in the current season may not play in competitive football for the Club making the approach until the commencement of the following season
- v) For the avoidance of doubt, a player being permitted to train with a club is deemed to be an improper approach from that club.

The provisions of this Rule will apply to all the Clubs affiliated to this Association. Clubs wishing to make a protest under Rule 16 must do so within 14 days of the alleged illegal approach becoming known to them. Clubs breaking this Rule shall be dealt with as shall be deemed fit by the Board.

Any Club guilty of an illegal approach shall not be allowed to subsequently transfer/register the player illegally approached by them during the current playing season, without the permission of this Association. In addition a fine not exceeding £100 may be imposed together with compensation not exceeding £100. These amounts are both at the discretion of the appointed sub-committee.

### **17. Leagues and Competitions**

The Rules of all Leagues and Competitions affiliated to the Association shall, be submitted to the Association, in line with the dates as the Board shall determine each year. Unless otherwise specified by the Board, the relevant deadline dates are listed below:

By no later than:

#### **1st February:**

Proposed changes to League Constitutions / Rules that may have an impact on other affiliated Leagues to be submitted to the Association. These would include, but are not limited to, any changes to Rule 1 – Nomenclature and Constitution or proposed changes to the Norfolk FA Standard Code of Rules. The Association will then circulate these to relevant competitions for observations.

#### **1st March:**

Observations from relevant competitions to be submitted in writing to the Association.

#### **28 days Prior to AGM**

Details of the forthcoming Annual General Meeting, containing proposed amendments to rules to be submitted at least 28 days prior to the AGM.

### **21 days Prior to AGM**

The Association shall advise the League of any required amendments to the submitted Rules

### **17 days Prior to AGM**

The League shall submit to the Association completed Rules, including any required amendments as determined by the Association, prior to circulation to their member Clubs.

### **1st July**

Complete Stages One and Two of the League Sanctioning process on the Whole Game System

### **7 Days prior to the first league match:**

- Complete Stage Three on the League Sanctioning process on the Whole Game System
- At least one copy of the League Handbook, which must include, or be sent separately, a copy of the League Rules and League Cup rules. Such information can either be sent electronically or in paper format.

Failure to comply may result in the issue of a maladministration charge in line with Rule 24, not exceeding £100 and the refusal of sanction.

Clubs or players may appeal to the Association against the decision of a sanctioned league or competition. Such an appeal must be made to the Football Services Manager of the Association, within 14 days of official notification of the decision against which they are appealing, accompanied by an appeal fee of £35 (which may be forfeited and costs may be awarded against the appellant if the appeal is dismissed).

Sanction fees for leagues in the current season are:

### **18. Sanctioning of One Off Matches and Tournaments**

One off Matches and Tournaments must apply for sanction in the manner prescribed by the Association not later than 14 days before the match / tournament is due to take place.

Sanction fees for the current season are:

One off Matches	£5 per unaffiliated team
Tournaments	
(a) 15 teams or less	£15
(b) More than 15 but less than 30 teams	£25
(c) 30 teams or more	£40

In the event of a one off match or tournament being played for charity and / or as a benefit match then the sanction fee may be waived at the discretion of the Association who may also request to see evidence of the accounts of the match.

### **19. Change of clubs' Names**

No club shall be allowed to change its name after affiliating in any one season (except in extenuating circumstances). A club may only change its name in the close season with the consent of the most senior league in which it competes. A club shall not have the same name as any other club affiliated to this Association. A club first affiliating to this Association shall have the priority to a name, but they shall lose that right upon not affiliating for any one season.

### **20. Rules Governing Referees**

All referees registered to Norfolk FA shall be governed by the relevant Rules as published by The FA and this Association at all times.

### **21. Referees' Markings**

Sanctioned Leagues shall ensure that all teams mark referees in accordance with the scheme laid down by The Football Association

### **22. Defunct Leagues and Clubs**

A resolution to dissolve the League / club shall only be proposed at a General Meeting and shall be carried by a majority of at least three-quarters of the members present.

The dissolution shall take effect from the date of the resolution and the members of the club / league committee shall be responsible for the winding up of the assets and liabilities of the league / club.

Any surplus assets remaining after the discharge of the debts and liabilities of the league / club shall be transferred in consultation with Norfolk County FA to another Club, a Competition, Norfolk County FA or The FA for use by them for related community sports or they may be held in trust for a period of not less than five years by Norfolk County FA.

After the expiration of five years the Association may dispose of the assets and/or cups and trophies to the benefit of football or community sport

### **23. Insurance arranged by the Association**

All member clubs, except those involved solely in small-sided competitions, are required to participate in any insurance scheme arranged by the Association and so directed by the Board of the Association. All clubs must have the relevant insurance in place to the required cover levels prior to playing any matches

Any Club with one or more contracted players (i.e. players registered with the Football Association on an official FA contract) must meet the relevant enhanced minimum Public Liability Insurance requirements as specified by the Association at the time of affiliation.

### **24. Administrative Duties**

All Clubs, Leagues and other sanctioned competitions are responsible for the administrative efficiency of their organisation and, at all times, must give prompt attention to the correspondence from this Association. There must be compliance with the instructions given. Referees have the same responsibilities. Failure to comply may result in the issuing of a maladministration charge, which, if proven, may lead to a fine not exceeding £100.

### **25. Club Welfare Officers**

All Youth clubs (Under 18 and below) and all Adult clubs with a Youth section are required to appoint a designated Club Welfare Officer. This person is required to have an in date FA DBS check through



the FAChecks@The FA.com before the Association's affiliation of their club, or club affiliation to a league, is accepted for the coming season.

All designated Club Welfare Officers for all Youth clubs (Under 18 and below) and all Adult clubs with a Youth section are also required to have attended a FA Safeguarding Children in Football Workshop and gained the Certificate of Attendance and attended a FA Club Welfare Officers' workshop prior to the Association's affiliation of each club being accepted.

Each Youth club (Under 18 and below) and each Adult club with a Youth section must provide the details of its designated Club Welfare Officer and all of its managers, assistant managers and coaches on its affiliation form. Also, if requested during the season, full details of physiotherapists/first aiders and any other person, who may come into direct contact with young members of the club must be provided to this Association.

All Club and League Welfare Officers are required to attend an annual Norfolk County FA CWO Training Seminar. The Association will arrange and host a minimum of three specific training seminars each season between the months of September and December.

Should a Club or League Welfare Officer fail to attend they may be removed from their position at the Club / League until such time as they do attend and / or the Club / League may be suspended.

## **26. League Welfare Officers**

All Youth Leagues (Under 18 and below) are required to appoint a designated League Welfare Officer. This person is required to have an in date FA DBS check through the FAChecks@The FA.com before the Association will sanction the competition for the coming season.

All designated Youth League Welfare Officers are also required to have attended an FA Safeguarding Children in Football Workshop and gained the Certificate of Attendance and attended a FA Club Welfare Officers' workshop prior to the Association's sanction of each league being accepted.

All Open Age Leagues are required to appoint a designated League Welfare Officer / League Safeguarding Advocate to act as the lead and first point of contact for safeguarding within their League.

## **27. Change of Secretary, Chairman, Treasurer, Club Welfare Officer, Coach(es) or Manager(s)**

Each club must notify the Association of any change of its Secretary, Chairman, Treasurer, Club Welfare Officer or any Team Manager or Coach within 14 days of a change taking place. Such notification can take place by updating the Club record on the Whole Game System. Failure to comply may incur a fine not exceeding £30.

## **28. Central Player Registrations**

### **i) Online Registrations**

All affiliated clubs who are members of a league who are registering players online are required to submit player details via the Player Registration System. All clubs must gain consent for the player to be registered prior to submitting their details online. Consent can be gained either via the online consent process, or by completing an offline consent form. If consent is gained via the offline consent forms, these must be kept by clubs and provided upon request by their league or Norfolk County FA. Clubs must ensure the full online process is completed prior to the individual playing.

### **ii) Matchday Registrations**

A player can register on the day of a game, if permitted by the relevant league rules, so long as a signed and correctly completed Matchday Registration Form, in ink, is completed prior to playing,

countersigned by an officer of the club and witnessed by an official of the opposing club. This form must then be kept by the club as offline consent.

The details of this player must then be submitted onto the Player Registration System by midnight on the same day or the registration may be deemed as invalid.

### **iii) Online Registrations - Eligibility**

With the exception of emergency registrations completed under the provisions of Rule 28bii) above, players will be deemed as registered once the online registration has been submitted via the Player Registration System. For the avoidance of doubt this means that the player's registration has been submitted and is either Pending League (blue) or has been fully accepted (green). The registration must be completed correctly and the player in all other respects be eligible to sign for the team, otherwise it may subsequently be rejected, and the player's registration deemed invalid until the problem has been resolved.

### **b) Registration Fees**

The registration fees, payable by the club per team are set out as below:

Adult Team (11v11) - £20

Adult Team (7v7) - £10

Youth Team (11v11) & (9v9) - £15

Youth Team (7v7) & (5v5) - £10

Clubs will be invoiced once around November for the relevant balances for their club. Clubs will then have 21 days to pay the invoice. Any invoice not paid by the due date may result in a fine for late payment not exceeding £30 and/or the club's affiliation may be suspended until the debt is cleared.

### **29. Player Data on Full-Time.**

All sanctioned Leagues shall make available to Norfolk FA within 14 days of such a request, player appearance data for their League for the season. Failure to comply may result in a fine not exceeding £100.

### **30. Appointment of Match Officials**

Subject to confirmation by the Board each season, this Association shall centrally appoint all registered match officials to each adult competition by the Association, with the exception of matches appointed by the East Anglian Pool, and County Cup fixtures throughout the duration of the season in line with Cup Competition Rule 28.

The Association may also from time to time make arrangements with youth competitions to appoint to fixtures within their respective Leagues.

### **31. Mandatory Match Officials Training**

All registered Match Officials and Observers, with the exception of level 1s to 4 and newly qualified individuals who are in their first officiating season, are required to attend an annual Norfolk County FA Referee Training Seminar. The Association will arrange and host a minimum of three specific training seminars each season between the months of June and August.

Until such time as each registered Match Official attends a relevant seminar such individual will not be appointed by the Association to officiate on any Norfolk County FA sanctioned fixtures. Should a

Match Official be transferred / registered to Norfolk after the commencement of the season they shall have to undertake mandatory training as determined by the Association before they can be appointed by the Association.

### **32. Saturday League Structure**

#### **New Clubs and Teams**

a) New Clubs and teams playing on a Saturday are only able to affiliate and join one of the (Four) 4 District Saturday Leagues. They cannot apply to join the Anglian Combination directly.

#### **Existing Clubs and Teams wanting to join the Anglian Combination League**

b) Existing Clubs and teams need to make formal application to the Anglian Combination League by 31 December, notifying their existing League, the Anglian Combination and the County FA when doing so.

c) Existing Clubs and teams need to fully meet the required Anglian Combination Ground Grading Standard by 31 March in the same season.

d) If they are a new Club to the League they must achieve Charter Standard status within one year of membership.

e) Existing Clubs and teams must finish in one of the top two positions in their District Leagues' top division to be accepted subject to the provisions of the following rule.

f) If one or both of the top two teams in the top district division does not wish to, or cannot, progress, the teams finishing in 3rd and 4th could be accepted, if they have applied by the deadline of 31 December in the same season.

#### **Regulations**

g) A maximum of two teams from any one District League could be promoted. Meaning a maximum total of eight teams across the District Leagues could progress, if space permits and the criteria are achieved.

h) The Anglian Combination League Management Committee will be responsible for allocating Clubs to the relevant divisions, prior to the League AGM.

i) Clubs may appeal their allocation decision to the Board. Any such appeal must be lodged within 14 days of the posting of the written notification of the decision and must be accompanied by the Appeal Fee of £35, which may be forfeited in the event of the appeal not being upheld.

j) If there are vacancies in the Anglian Combination and the teams in the eligible positions do not wish, or do not meet the criteria, to gain entrance in line with rules 32 e) and f), applications from other Clubs outside of these positions may be considered, but only in extreme circumstances. Any such decision will be at the discretion of the Board.

k) Applications from teams wishing to enter the Anglian Combination from Leagues outside of Norfolk will be considered in line with rule 32 j) and will be subject to space. Such applications must be submitted in line with Rule 32 b).

l) The teams finishing bottom of the North & South Divisions will be relegated and may be re-elected if space permits, or if applications exceed vacancies they may be allocated to a relevant District League.

### **33. Safeguarding**

All managers / coaches / first aiders for each youth team within a Club must have an accepted in-date FA DBS check in place prior to commencing their role for the team. Such check must be kept in date for the duration of the time that they are associated with that team.

The Association shall conduct a Safeguarding compliance visit for a minimum of 13% of affiliated Clubs with youth team(s) during the season.

All managers / coaches / first aiders for each open age team within a Club where that team has players registered who are under 18 years of age must have an accepted in-date FA DBS check in place prior to commencing their role for the team. Such check must be kept in date for the duration of the time that they are associated with that team and they have players Under 18 years of age.

### **34. Powers of Inquiry of this Association**

a) This Association shall have the power to monitor the compliance by each Participant with the Rules and Regulations of this Association and the Rules and Regulations of each Competition affiliated to this Association to which a participant is subject and/or to inquire into any incident, facts or matters which may constitute misconduct under these Rules. It is for this Association to determine in its absolute discretion the manner in which it conducts an inquiry.

b) In carrying out its functions under this Rule, this Association shall have the power to require of any Participant upon reasonable notice:

- (i) his or her attendance to answer questions and provide information at a time and place determined by the Association; and
- (ii) the provision to this Association of documents, information or any other material of any nature held by the Participant; and
- (iii) the procurement and provision to this Association of documents, information or any other material of any nature not held by the Participant but which the Participant has the power to obtain

It is for this Association to determine the nature and extent of any material required for disclosure in accordance with (ii) and (iii) above

c) Each Competition or Club sanctioned by or affiliated to this Association shall ensure compliance by its officials, directors, players, representatives or servants with a requirement to answer questions and provide information and/or produce any one or a combination of documents, information or other material in whatever form held and/or answering questions and providing information.

d) Any participant who fails to fulfil the requirements of this Rule shall be dealt with as Council, or a delegated committee convened for such purpose, shall deem fit. This may include, but is not limited to a period of suspension and/or a fine.

### **35. Support Access to Full-Time**

Any League sanctioned by this Association shall provide the Association with a League Administrator account in order to be able to access their League Full-Time Site to enable the Association to support the League and it's Member Clubs.
