# REFEREE MENTORING PROGRAMME

North Riding County FA offers a dedicated mentoring programme that works in close conjunction with its development team and the local Referee Associations.

With a dedicated mentor workforce across the county we offer fantastic dedicated support to our new referees with our mentors consisting of senior active referee's, referee developers and referee's that generally want to give something back to those requiring it.

North Riding County FA has two mentor co-ordinators that will oversee the support that each of our new referee's will be given during their first 12-18 months in the game.

What support our mentors provide:

- Referee's first point of contact
- Support referee's in contacting local referee's appointment secretaries to get games in your local area
- Watch you in your first 5 games
- Email / phone correspondence to deal with any issues or concerns you may have.
- Contact for parents who may have questions

# HEADS OF REFEREE MENTORING

North Riding County FA's mentoring programme is headed up by Geoff Mann & James Unwin, as Heads of Referee Mentoring.

# RING AND DEVELOPING OUR

# **REFEREE DEVELOPMENT** & SUPPORT POLICY

This policy is designed to clarify the process and procedures that North Riding County FA will adhere to and can be expected to deliver to our Referee Workforce.

The policy has been developed in conjunction with our Referee Development Manager (RDM) and with members of our Referee Development Committee.

North Riding County FA fully appreciates how difficult the role of a Match Official can be, and wants to ensure that all our Officials have the best possible support available to them at all times.

To ensure we can offer the best possible provision, we have implemented the following initiatives to better support our Referee Workforce:

- All new Trainee Referees to be assigned a Referee Mentor in partnership with our local Referee Association Branches
- The Introduction of a 24hr Referee Hotline 0330 122 2932
- Unannounced Visits to games by North Riding FA personnel
- Monday Referee 'clinics' to help support Match Officials from weekend games



## **REFEREE HOTLINE**

The Referee Hotline is in place for all Match Officials who may experience an issue during or after a game with regards to the possible conduct of a team, is subject of an assault or improper conduct, and requires support with submitting any disciplinary reports or any other issue, no matter how minor.

We ask that Match Officials save the following number within their phones – 0330 112 2932 and should they have any issues please don't hesitate to contact us and a member of our Referee Development Team will contact you within 24 hours, but typically the same day.

## MONDAY 'REFEREE CLINICS'

We have also launched a Monday 'Referee Clinic' which makes available to all of our Referee Workforce the opportunity to call into our County FA office or arrange an appointment for a member of our Referee Development Team to help support with disciplinary report writing or offer any advice that may be required.

To arrange an appointment please call **0330 112 2932** and we will be happy to arrange this.

## **U18 REFEREE ARMBAND SCHEME**

Referees under the age of 18 will wear yellow armbands to signify their age, making managers, coaches, players and spectators aware that they are still subject to the children's safeguarding legislation.

Yellow armbands are provided free of charge to match officials and should be worn at all times whilst officiating.



# SAFEGUARDING

The North Riding FA offers a range of safeguarding services and training to help create a safe and enjoyable football experience for everyone.

We ensure safeguarding requirements are met as a requirement of referee affiliation and we support referees to maintain these standards. This includes making unannounced safeguarding visits to matches.

## MATCH OFFICIAL ASSAULT POLICY

If any Match Official is subject to an assault whilst officiating, we will follow the below procedure upon receipt of an allegation on a registered North Riding County FA Match Official, whether sent by the Match Official or other stakeholder within the game.

#### **IMMEDIATELY AFTER RECEIVING THE REPORT WE WILL**

- Acknowledge receipt of Report in writing within 2 working days
- Arrange a meeting / visit or suitable alternative with the Match Official
- Automatically refer the incident to the County Welfare Officer if the Match Official is below the age of 18 years or considered to be a vulnerable adult

#### WITHIN 5 WORKING DAYS OF RECEIVING THE REPORT WE WILL:

- Discuss and agree the appropriate disciplinary action to be taken against the offender(s)
- Provide contact details of the relevant Police authority and/ or Police Victim Services
- Discuss and agree with the Match Official an action plan moving forward that should include the opportunity for match day support moving forward
- Ensure the Local Referees Association branch is informed of the incident to allow further support to be offered

#### **ONGOING COMMITMENT TO THE MATCH OFFICIAL**

- Arrange for a member of the Referee Development Team to attend and support at a personal hearing if one is requested
- Ensure regular contact is made with the Match Official before and after a possible hearing
- Provide details on the outcome of the personal hearing if relevant and requested for by the Match Official

Any Match Official who is subject to physical contact or is assaulted must ring the Referee Support Hotline (0330 112 2932) to make the Association aware and we strongly advise reporting the matter to the Police.



# U18 MATCH OFFICIALS COUNTY CUP FIXTURES REFEREE GUIDANCE

### **OVERVIEW**

As we all know, safeguarding is everybody's responsibility and this section has been included to inform everybody about the role they should all play in keeping under 18s safe. North Riding County FA's believes that every one has a responsibility to ensure that all participants involved within the game, create a safe and enjoyable football environment for all participants.

This document contains the relevant information on what requirements registered North Riding County FA Match Officials must adhere to in respect of Safeguarding and best practice before, during and post North Riding County FA County Cup fixtures.

### **ROLE AS A MATCH OFFICIAL**

As a referee, you are an impartial figure, and able to see how teams/clubs conduct themselves and keep under 18s safe. You have the opportunity to demonstrate best practice on and off the field and to recognise and refer concerns.

North Riding County FA Match Officials who are in a role that involves direct contact with children or vulnerable people will be required to have the necessary Safeguarding Qualifications as well as possessing an in-date DBS. Failure to comply with these requirements will result in a suspension.



### **PRE MATCH CONTACT WITH A U18 MATCH OFFICIAL**

As a Club Official, it is vitally important that when you make contact with a Referee who is under the age of 18 to confirm a County Cup fixture; that you speak with a parent / guardian of the Referee to confirm the subsequent match day arrangements.

We strongly advise that the responsible club official provides a contact number for the match official's parent / guardian of who will be the point of contact on match day and ensure an introduction is given upon arrival. It is also advisable that the club welfare officer's details are provided in case of any issues during match day.

Club officials are strongly advised that no direct communication should take place with match officials 14 or 15 years of age respectively.

### **CLUB FACILITIES FOR U18 MATCH OFFICIALS**

If club facilities in the way of a changing room are to be provided to match officials; a separate provision must be made for match officials who are under the age of 18 to all other teams and other match officials who are over the age of 18.

Ideally, this should be covered in the pre-match confirmation, and if no provision is to be made available, the match official must be informed in advance to ensure he / she comes changed.

### **U18 MATCH OFFICIAL TRAVEL & DEPARTURE FROM GAMES**

It is the responsibility of the parents / guardian of the match official to ensure that he / she is transported to and from a fixture. We strongly recommend that a suitable person of the match official is in attendance on a match day.

We also advise that a contact number is shared with the club official of the suitable person as a backup and should there be any issues or emergencies both parties have a point of contact at all times. Our Referee Development Manager, Ross Joyce should be contacted in an emergency: **07872 469952**.



### U18 NORTH RIDING COUNTY FA 24 HOUR REFEREE SUPPORT HOTLINE

North Riding County FA have a 24 hour support hotline that is available to all match officials and parents / guardians of match officials should they require any immediate advice / guidance. We strongly advise that this number is saved and used if required. The number is: 0330 122 2932.

If you have either heard or witnessed something that you are concerned about, then this can be reported to a member of the North Riding County FA Staff. Alternatively, any concerns can be reported directly to the Police, NSPCC, ChildLine, Child Exploitation & Online Protection or FA Safeguarding Team. The above 24 hour support hotline is available at all times should any immediate support be required and the use of it is encouraged.

# REFLIVE

### **OVERVIEW**

RefLIVE's Referee Management System is an online platform and smartphone app for referees, observers, referee coaches, mentors and referee development team members, which enables a focus on developing referees and ultimately reducing referee abuse. The RefLIVE Referee Management System is now used by a variety of state and national sports associations around the world to assist with referee development and the severe problems plaguing officiating, including abuse and the subsequent effect on the turnover of referees.

### WHY DO WE USE THIS?


North Riding FA are implementing this system to reduce referee abuse by keeping teams accountable for poor behaviour along with assisting referee managers know where and where referees require assistance.

Overall this is to be used to improve the overall match day environment for all officials.

# IN CASE OF EMERGENCY (ICE)

Being a referee sometimes means being on your own. As such the North Riding FA have instructed all match officials carry their ICE in their matchday referees book during the match.

This should be a small credit card style piece of card or paper listing your name, emergency contact name and emergency contact phone number or numbers.

Hopefully this is never needed but should anything happen to you whilst on the field of play there is always a contact number for emergency situations and team officials will know where to look in case it is needed.

It is vitally important that those under 18 carry this for safeguarding purposes as well.
