

## **INTRODUCTION**

This funding guide is intended as a starting point for football clubs seeking to obtain funding for football activities and projects. Please note that this is not an exhaustive list and potential sources of funding and the conditions of grant aid may change.

For this reason this publication is set up to direct readers to various funding websites.













#### **GENERAL POINTERS**

The most important source of funding for any football club is its membership, both in the form of regular fees and subscriptions and fundraising activities such as social events and raffles. The revenue which can be raised from these sources is, however, often limited and can be restrictive to the clubs overall aims and growth. Due to this, external sources of funding have a key part to play in the development of many clubs.

Obtaining funding from sources external to any club is a complex and often frustrating process, however approached in the correct manner, wasted effort can be minimised and prospects of receiving support greatly enhanced.

The points outlined below provide general hints, aimed at assisting you in strengthening your funding applications:

- Always read the entire application pack thoroughly before attempting to respond to any questions. It is essential that you are fully aware of what the objectives of the funder are in relation to the grant programme you are applying under
- If possible find another club, who have successfully obtained funding from the

funder and speak to them about their experience of the process and ask if in hindsight they would have done anything differently

- Make a photocopy of any application form and fill this in as a draft until you are happy that you have framed your application in the best manner possible
- Most funders have a clear idea of what they will and will not fund, make sure that you are aware of this and that your application is appropriately structured
- Make sure that your project is able to deliver the kind of results which the funder is seeking, i.e. helping more females to become involved in football

- Before completing the final application form, obtain another opinion -Oxfordshire FA will be happy to provide this service
- Ensure that your application complies with the timetable for applications if one exists; late applications are unlikely to receive support
- If they have them, follow the funder on social media to keep up to date with opportunities and deadline dates.



# TYPES OF FUNDING

#### **REVENUE FUNDING**

This funding type covers the large majority of funding areas and for the purpose of this guide has been split into six main categories:

#### **Kit & Equipment**

This can be a stand alone application or included as part of a wider application where money for kit and or equipment is needed as well as funding to carry out activity. Awards can vary from £250 to £1,000 and the need for Partnership funding depends on the funder. Applicants will be required to show that there is a need for a grant beyond just a 'nice to have' and how the money will make a difference to the recipient/s.

#### **IT Equipment & Software**

This funding is largely in place to support and enhance communities. In football terms this should be aimed at club and league officials to make their roles easier. Grants are usually given in the form of equipment rather than cash.

#### **Talented Players**

Funding for talented players usually comes in the form of bursaries to cover the costs of travel and training or discount schemes where performers can get reduced access to local authority sports facilities. The definition of talented varies between funders but usually applies to those playing at county level and beyond.

#### **Coaching & Officiating**

These bursaries are available to support coaches and referees to gain qualifications. The amount of support differs from part to full funding and is usually offered on a percentage basis. Funding is rarely retrospective and tends to be paid upon successful completion of the course. Applicants are expected to actively use the qualification.

#### **General Activity**

These grants are for projects based around activity and participation and there are a range of available schemes and levels of funding out there. Funding tends to be awarded for projects looking to develop new activity and is often focussed on target agendas such as increasing participation.

#### Goalposts

As with kit & equipment grants there are schemes that will provide funding for goalposts on their own as well as those that will fund them as part of a wider bid. Posts must comply with British Safety Standards.

#### What makes a good revenue application?

- Caters for an obvious need / meets local demand
- Is strategic
- Has a good plan with clear specific, measurable, achievable, realistic and time measured (SMART) objectives
- Makes an impact
- Is sustainable and not just a quick fix
- Has partnership funding where required
- Represents value for money
- Financial endorsement of other funders
- Engages with the community
- Good sense of ownership
- Hits the funder's agenda

#### **CAPITAL FUNDING**

This funding type concerns the development of new or refurbishment of existing facilities and is covered under one heading in this guide:

#### **Facility Development**

Projects under this category could cover a wide range of areas including changing room development, pitch drainage and maintenance, astro-turf, floodlighting, improvements to meet FA ground grading criteria, maintenance equipment and storage. Funding ranges from around £500 to £500,000 and Partnership funding is required in most cases.

#### What makes a good capital application?

- The facilities are justified by a realistic football development plan
- Fits with local strategy / need
- Sustainable post funding / build
- Meets FA & Football Foundation Standards
- Represents value for money
- Financial endorsement of other funders
- Engages with the community
- Good sense of ownership
- Hits the funder's agenda

# THE DICKIE BIRD FOUNDATION

The vision of the Foundation is to assist young people under 16 years of age to participate, to the best of their ability, in the sport of their choice irrespective of their social circumstances, culture or ethnicity and to ensure that, in doing so, they improve their chances both inside and outside sport.

#### Who is it for?

Disadvantaged children under the age of 16

#### What will it fund?

The foundation provide the following guidelines for sport appropriate items:

- Shirts
- Shorts
- Footwear
- Swimwear
- Personal items of equipment for use by the applicant only.

#### What it doesn't fund

- Children over the age of 16 at the date the application is received
- Travel costs
- Professional fees of any kind including club membership or club fees
- Scholarships
- Summer/Winter training camps.

#### Eligibility criteria

 Applications will only be considered if the applicant can demonstrate that they are unable to raise the funds by any other means

- The foundation only accept applications from individual children that meet the criteria
- Groups, clubs, schools, colleges or associations are no eligible to apply
- The fund will not pay for travel expenses.

#### **Decision process**

 Trustees meet at least four times a year to make a decision.

# THE ROBIN GREAVES SPORTS FOUNDATION

The Robin Greaves Sports Foundation was established in memory of the Late Robin Greaves to provide financial grants to charitable organisations working to promote sports and recreation to those living in Oxfordshire, Berkshire, Gloucestershire and Hampshire.

#### How much?

No specified limit.

#### Partnership funding

Not specified.

#### Who is it for?

Clubs, charities or not-for profit organisations whose activities are legally charitable.

#### Eligibility criteria

The Foundation will consider grant applications from charitable organisations working in the following areas:

- The advancement of amateur sport
- The promotion and preservation of good health by encouraging community participation in healthy recreation and providing or assisting in the provision of facilities for the playing of sport
- The advancement of physical education in young people including, but not limited to, developing skills in physical

- activity, developing physical and mental capacity, evaluating and improving performance in physical education and making informed choices about healthy, active lifestyles
- The provision or assistance in the provision of facilities, courses, training programmes and resources to enable, assist and encourage the education of persons in leadership.

# COMMUNITY AMATEUR SPORTS CLUB (CASC) STATUS

Around 6,000 clubs are now registered as Community Amateur Sports Clubs (CASC). These clubs, partly through mandatory rate relief and the ability to claim Gift Aid on voluntary donations, have benefitted from almost £100 million in savings since 2002.

#### Who is it for?

Recognised sports clubs

#### **Benefits**

- 80% mandatory business rate relief
- The ability to raise funds from individuals under Gift Aid. A registered CASC can reclaim up to £25 in tax for every £100 donated, though at the moment this does not apply to all types of donations
- CASCs are exempt from Corporation Tax on profits derived from trading activities if their trading income is under £30,000 per annum
- Profits derived from property Income are also exempt for CASCs if gross property income is under £20,000 per annum
- CASCs whose income does not exceed these thresholds will no longer be required to complete an annual Corporation Tax return.

#### Eligibility criteria

- Sports clubs must be amateur.
- Clubs must not discriminate in any way in their membership policies and be wholly open to all sections of the community
- Clubs must have a core purpose in the promotion of amateur sports participation
- Clubs must be non-profit making,

- and re-invest any profits in the sports club
- Clubs must stipulate that in the event of being wound up, any remaining assets be distributed to either the sports governing body for use in community sport, another CASC or charity
- Clubs must ensure that anyone involved in the day-to-day running of your club is deemed to be a 'Fit and Proper Person'
- All of the above must be referenced in the club's constitution
- Once registered as a CASC a club will remain under that classification until they de-register.

- Clubs are required to submit a completed application form to HMRC with a copy of the club's constitution adhering to the criteria set out above.

- 4. Courier collection at a suitable time.

# CAUDWELL CHILDREN ENABLE SPORT FUND



The Caudwell Children's Enable Sport Fund provides specifically designed sports equipment to enable disabled children and young people.

#### How much?

Grants depend on the applicant's level of need.

#### Partnership funding

In exceptional circumstances 100% funding will be considered dependent on the family/child's circumstances.

#### Who is it for?

UK residents under the age of 18 with a medical need.

#### Eligibility criteria

- All funding requests must be by application form and be on behalf of a specific child
- Donations must make a significant difference to a child's life
- Funding is only available to families whose joint wage does not exceed £45,000 gross per annum (not including any benefits). The financial details required are those of parents or guardians
- Equipment need must be supported by a medical professional and a coach/manager
- Proof/confirmation of the child's

- situation in written form from a professional body or health care professional will be required as will confirmation that the item requested is suitable for that child
- The charity will not consider any application for funding for items that have already been purchased or ordered before the application has been approved
- The fund is limited and a one-off programme.

#### **Decision process**

 They will look to communicate a decision within a month of receiving an application.

# FA RESPECT BARRIER SCHEME



The FA and Football Foundation's
Respect barriers and packs are
available to football leagues and clubs
to ensure there is good behaviour by
players and parents alike in the
grassroots game, with money provided
by The FA and vouchers supplied by
the Foundation.

#### Who is it for?

- FA affiliated clubs
- FA affiliated leagues
- Schools based in England

#### How much?

#### Clubs

Vouchers are provided for a 50% discount based on the status of clubs:

- Affiliated Non Charter Standard Clubs:
  - Two vouchers
- FA Charter Standard Clubs: Three vouchers
- FA Charter Standard Development Clubs: Four vouchers
- FA Charter Standard Community Clubs:
   Five vouchers

Each voucher can be used towards a range of Respect items or packs of items.

#### Leagues

Affiliated, Charter Standard and Respect Leagues can request a single voucher that entitles the league to get 50% off a maximum of £5,000 of Respect items or

packs. The voucher has a maximum value of £2,500 and can only be used once during the season.

#### Schools

Schools are eligible to apply for two vouchers providing a 50% discount on a range of Respect items or packs of items.

#### Eligibility criteria

- Applicants can submit one application per season
- All items must be purchased through the scheme provider, TMG
- Items purchased must be used at the site of the applicant club, school or league and cannot be transferred elsewhere
- Delivery costs are not included as part of the scheme and must be paid for separately.

#### **Decision process**

Once an application is received the Foundation will send a confirmation email, followed shortly by an offer email providing the unique voucher code and grant amount.

# OPEN AWARDS

## FOR ALL ENGLAND



National Lottery Awards for All England offers funding to support projects and activities that matter to people and communities. While the projects we fund usually last for up to 12 months, we know that some can take a little longer, and other grants are for one-off events.

#### How much?

£300 - £10,000.

#### Partnership funding

Not required.

#### Who is it for?

- Voluntary or community organisations
- Registered charities
- Constituted groups or clubs
- Community Interest Companies (CIC's)
- Social enterprises
- Schools
- Town or Parish Councils

#### What will it fund?

- Small capital projects
- Training costs
- Volunteer expenses
- Staff costs
- Transport
- One-off events
- Equipment
- Utilities/running costs

#### What it doesn't fund

- Profit making/fundraising activities
- Statutory activities
- Recoverable VAT
- Contingency costs, loans or interest
- Paying someone else to write your application

#### Eligibility criteria

- National Lottery Awards for All has three funding priorities and project ideas must meet at least one of these:
  - bring people together and build strong relationships in and across communities
  - improve the places and spaces that matter to communities
- enable more people to fulfil their potential by working to address issues at the earliest possible stage
- Applicants must involve the local community in the design, development and delivery of their projects and demonstrate this in their application

- Projects working with young people or vulnerable adults must demonstrate they have safeguarding policies in place
- Capital projects must have planning permission in place before application (if required)
- Applicants looking for capital investment must have a minimum of a 5 year lease or landlord permission.

#### **Decision process**

 Applications can be made at any time. Decisions are reached in 10 weeks with grants paid out in a further two if successful.

# GREGGS FOUNDATION ENVIRONMENTAL GRANT



The Environmental Grant fund is dedicated to improving the local environment. They look to fund projects that improve the physical environment in a way that also benefits the wider community. They have seven local charity committees which meet regularly throughout England, Scotland and Wales.

#### How much?

Up to £2,000

#### Partnership funding

Not required

#### Who is it for?

- Any not for profit organisation with preference given to small, locally based and community led organisations with a turnover not in excess of £300,000 per annum
- Schools are also encouraged to apply and are given the same level of priority as small locally based organisations.

#### What will it fund?

The scheme focusses on projects that improve the physical environment in a way that will improve people's lives.

Eligible items could include:

- Purchase of new equipment
- Sessional salary costs
- Small capital projects
- Approaches to supporting the local environment

#### What it doesn't fund

- Ongoing running costs
- Overseas travel
- Curricular activities that take place during the school day
- Religious promotion
- Major capital projects

• Sponsorship of events of activities

#### Eligibility criteria

- All projects must deliver a real benefit to the environment. Priority will be given to projects that also include one or more of the following:
  - improves the local environment
  - ensures the involvement of local communities
  - delivers a sustainable and measurable difference
  - supports people in need
- Grants are most likely to be awarded to projects which have a Greggs shop in their region

#### **Decision process**

 Funding is awarded in a series of rounds with decisions communicated approximately 8 weeks of each round deadline

# KRISPY KREME FUNDRAISING SCHEME



Krispy Kreme's fundraising scheme aims to help non profit organisations and charities raise funds through selling their doughnuts.

#### How much?

£4.45 for every dozen doughnuts sold.

#### Partnership funding

Doughnuts must be purchased up front at a cost of £5.50 a dozen.

#### Who is it for?

- Sports Clubs
- Community Organisations
- Registered charities

#### How it works

The club or organisation purchase Original Glazed Kripsy Kreme Doughnuts for a special fundraising price of £5.50 a dozen and then sell them on for £9.95 per dozen or £1.55 per doughnut keeping all of the profit.

#### Eligibility criteria

- Fundraisers must be non-profit making organisations or registered charities and proof must be provided
- Charities must provide details of their registered number which will be checked against the national database
- Organisations must meet minimum order requirement of 10 dozen up to a maximum of 30 dozen per event per day
- The organisation must comply with Krispy Kreme recommended resell prices
- Organisations can participate in the fundraising programme once per

- calendar month unless otherwise agreed
- Krispy Kreme are unable to accept returns
- All fundraising orders must be picked up within four hours of agreed-upon pick up time or they will be considered cancelled
- Cancellations must be received by the providing store no later than four days prior to scheduled pick up
- Cancelled orders received less than three days in advance are subject to a charge of 50% of the total purchase price
- Orders not picked up within one hour of agreed-upon pick up time will be subject to a charge of 100% of the total purchase price
- Ideally Krispy Kreme require two weeks notice of fundraising requirements.

#### How to apply

- Decide how many doughnuts are needed and the date they are required
- Place the order online
- Krispy Kreme will then be in contact to confirm the order and take payment
- Doughnuts need to be collected on the event date from the chosen Krispy Kreme store

# THE GALAXY HOT CHOCOLATE FUND



The Galaxy Hot Chocolate Fund helps small, local community groups and charities by donating cash awards to support warm-hearted people and projects. The Galaxy Hot Chocolate Fund is now in its fifth year and has helped to support more than 100,000 people through its campaigns.

#### How much?

Each weekly winner will receive £300

#### Partnership funding

Not required.

#### Who is it for?

- Community groups
- School groups
- Charity organisations in the UK and Ireland

#### How it works

- Applicants enter their details, information about their organisation and how the money could help on the fund website
- The public can vote for the project they want to receive funding and the one with the most votes each week wins. A winners shortlist is also randomly selected each week with four more winners selected.

#### **Decision process**

- The projects with the most votes are selected as winners each Monday for the People's Choice
- Each week a random shortlist of winners is also created and each project contacted by the team for further information before another

four winners are selected based on:

- The extent to which the proposed initiative will help the local community in question
- The extent of the proposed initiative's reach
- The perceived local need for such hobbies, sporting or leisure activities
- Entries will remain valid each week until either they win or the closing date is reached
- Votes will be reset each week
- Projects can only win once.

# THE FA LEAGUE IT GRANT SCHEME



The FA acknowledges that operating a league is a time consuming task for the volunteers engaged in it. It also recognises that the past 10 years have seen huge strides in the development of IT-based league operations systems designed to ease the administrative burden on volunteers.

#### How much?

Grant awards are based on the number of teams playing in a league. The scheme awards £10 per team and operates from a minimum value of £350 to a maximum of £1,000.

If a league has 150 teams or more they can apply for grant aid up to a maximum of £1,200.

Grants are capped at a maximum of up to £600 for a Desktop/Laptop Computer and £450 for a Tablet.

# SPORT ENGLAND SMALL GRANTS SCHEME



The Small Grants Programme makes awards to not-for-profit organisations to help more people play sport.

#### How much?

£300 - £10,000

#### Partnership funding

Not required. The fund does not expect to contribute to projects costing over £50,000

#### Who is it for?

- Voluntary or community clubs or organisations
- Local authorities
- Schools
- Health bodies

#### Eligibility criteria

- Projects must fit with Sport England's Youth and Community Strategy:
- www.sportengland.org/aboutus/what-we-do
- Applicants should be able to deliver the project within 12 months of the date of the offer letter
- Projects must be focused only on sports currently recognised by Sport England and must be delivered to beneficiaries based in England
- The project start date must be at least 10 weeks after submission of a completed application and supporting documents
- The project must be for new

activity and new costs associated with helping more people play sport.

#### What it doesn't fund

- Projects that have already started or where an organisation has committed to expenditure
- Projects that do not address Sport England's strategic outcomes
- The general running costs of an organisation (e.g day to day expenses such as rent, gas, electricity, and insurance costs)
- Repeat or regular events (except the extra cost of involving new people)
- Existing activity. This includes repeat funding of projects previously supported by Sport England. They would support a project that follows a small-scale pilot or taster sessions. A 'pilot' is defined as a small-scale project that evaluates the time, cost, feasibility and effects of running a particular project
- Replacement of equipment. They may fund extra equipment if it allows more people to take part and if you can demonstrate clearly why it is needed
- Items which only benefit an individual e.g. bursaries or kit and equipment that is not shared.

- They may fund team playing kits for new teams or for teams who have not previously had a kit.
  They are unlikely to fund training and coaches kits and other items of clothing
- Salaries except for coaching costs or fixed term positions needed to meet a specific project requirement. Funding of coaches must be clearly additional to usual club expenditure
- Used road vehicles
- More than £10,000 to the same organisation in any 12 month period, from the date of our award letter
- Activities that the government has a legal obligation to fund, for example, sport sessions which take place in school during curriculum time
- Projects involving construction or refurbishment of property. They will also not fund the erection of temporary buildings or land improvement work (e.g. drainage, resurfacing of playing surfaces, laying of artificial surfaces or installation of irrigation systems)
- Fixed items of equipment (e.g. goals and nets that cannot be easily removed). They also cannot fund fixed equipment which may require planning permission or may impact on any lease.

- Projects that take place or incur costs (including deposits and costs associated in submitting the application) before the date of the offer letter
- Contingency costs and VAT that can be recovered
- Projects involving travel to another country where a similar sporting benefit can be gained in England
- Sponsorship, endowments or loan repayments.

- Once an application has been received there is no more than a six week turnaround provided applicants have provided all required information

- Applicants must be able to demonstrate the Partnership funding is in place
- Only one application can be accepted per club each financial year
- Grants will not be awarded retrospectively therefore applications for costs that have already been incurred or are due before an offer of a grant has been made in writing will not be considered
- When a Grant is offered, the applicant must send a copy of receipt of payment for the goods.

#### **Decision process**

- All applications will be assessed against the following criteria:
- Applicant's financial need
- Value for money
- Evidence of need / Impact
- Disciplinary record over the past 3 seasons
- Charter Standard Health check position (if appropriate)

- The decision of the panel is final and binding, there is no right of appeal
- Applicants will be notified of the panel's decision via email no more than seven days after the panel has met
- Successful applicants will have two months from notification of award to provide paid invoices or receipts for all related expenditure or the grant will be lost.

- There is evidence of stability and good governance
- The outcomes are clear.
- The budget is well thought through and itemised
- · Other funding has been secured
- Volunteers are being used to deliver impact
- The group is collaborating with other organisations and stakeholders, or there is no other provider of the work.

Applicant organisations must have been in operation for a minimum of 12 months.

The grants panel meet every four months to assess applications.

# TESCO BAGS OF HELP GRANTS



Tesco is using the money raised from the 5p bag charge in stores in England, Wales and Scotland will pay for a large number of local projects to improve green spaces in communities.

Administration of the local funding will be managed by the community charity Groundwork, which specialises in transforming communities and the local environment for the better.

#### How much?

- Applicants will need to submit a signed landowner permission form with their application to demonstrate that they have the authority to carry out any funded capital works
- Profit making organisations or individuals are not eligible to apply for funding
- The scheme will not fund retrospectively
- Running costs and overheads are not eligible for funding.

#### **Decision process**

 Applications will be assessed by the grants team who will notify applicants if they have been

- accepted or not
- Successful applicants will have their projects put to a public vote in their local Tesco store with Tesco customers.

# OPEN CROWDFUNDING

Crowdfunding is a way of raising finance by asking a large number of people each for a small amount of money. Until recently, financing a project or venture involved asking a few people for large sums of money. Crowdfunding switches this idea around, using the internet to talk to thousands—if not millions—of potential funders.

#### How much?

Dependent on the crowdfunding platform

#### Partnership funding

Not required

#### How it works

- Those seeking funds will set up a profile of their project on a crowdfunding website
- Projects set a funding goal to achieve
- Projects can use social media, alongside traditional networks of friends, family and work acquaintances, to raise money
- Websites vary but a percentage of donations or a percentage of the full amount when raised will be taken as commission by the provider
- Support with fundraising may be offered by the host website
- There are three different types of crowdfunding:

## Donation/Reward Crowdfunding

People invest simply because they believe in the cause.

Rewards can be offered (often called reward crowdfunding), such as acknowledgements on a plaque, tickets to an event, regular news updates, free gifts and so on. Returns are considered intangible. Donors have a social or personal motivation for putting their money in and expect nothing back, except perhaps to feel good about helping the project.

#### **Debt Crowdfunding**

Investors receive their moneu back with interest. Also called peer-to-peer (p2p) lending, it allows for the lending of money while bypassing traditional banks. Returns are financial, but investors also have the benefit of having contributed to the success of an idea they believe in. In the case of microfinance, where very small sums of money are leant to the very poor, most often in developing countries, no interest is paid on the loan and the lender is rewarded by doing social good.

#### **Equity Crowdfunding**

People invest in an opportunity in exchange for equity. Money is exchanged for a shares, or a small stake in the business, project or venture. As with other types of shares, apart from community shares, if it is successful the value goes up. If not, the value goes down.



# SOUTH OXFORDSHIRE DISTRICT COUNCIL CAPITAL GRANTS

South Oxfordshire District Council offers grants to capital community projects in South Oxfordshire through its Community Capital Grants Scheme.

Approximately £1 million per year is distributed in capital grants.

#### How much?

A minimum of £1,000 and up to 50% of the total project cost.

#### Partnership funding

Applications requesting funding for more than 50% of the total project cost will be rejected.

#### Who is it for?

- Volunteer Groups
- Community Organisations
- Town & Parish Councils.

#### Eligibility criteria

- This scheme will only fund capital expenditure
- The scheme will not fund projects retrospectively unless in exceptional circumstances
- Repairs and maintenance expenditure will not be classified as capital
- The scheme does not provide revenue funding to cover such things as salary costs, heating or rent
- If applying for over £25,000 applicants must have ownership of the site or a minimum of a 10 year lease.

#### **Decision process**

Applications are assessed primarily on the information included on the form and possibly a site visit.

Applicants may be required to provide the following information:

- Copies of the organisation's latest bank/building society statements
- Two quotes or a professional estimate to support your total project cost
- A breakdown of the budget for the project, including how the rest of the cost will be funded
- The organisation's signed constitution, rule or articles of association (except parish or town councils)
- Copies of any necessary planning, listed building, Diocese faculty and other relevant permissions
- Most recent financial accounts or the working budget and financial plan if a new organisation
- A detailed project plan that includes how any ongoing maintenance costs will be funded.

# **APPLICATION WINDOW WEST OXFORDSHIRE** DISTRICT **COUNCIL COMMUNITY FACILITIES GRANT**

The Community Facilities Grant aims to provide financial support for community led capital projects for the improvement and or enhancement of existing community facilities and the procurement of new facilities/equipment.

- Commercial organisations and exempt charities are not eligible to apply for funding

- Applicants must have at least three unrelated people on the management committee/board
- Applications relating to projects on school or church sites are permitted where they provide the only community facility of that type in the village/town, or complement existing provision
- Applicants must evidence that they have sought funding from their town/parish council
- Partnership funding is required from town and parish councils where an application concerns a facility which is their responsibility
- Projects must take place within West Oxfordshire
- Community facilities must be made widely available for community use. Grants will only be awarded towards play area and Multi-Use Games Area projects where there is free public access to the site
- Applicants must demonstrate community benefit (i.e. to residents of and visitors to West Oxfordshire)
- Recent consultation, to demonstrate need, must have been undertaken in developing the project
- Applicants must demonstrate that

- they have taken into account the needs of the wider community including disabled people and those with mobility issues, when planning their project
- Applicants must have a bank account in the name of the organisation with at least two unrelated signatories
- Only one grant can be allocated per project
- Previously awarded grants (unless subsequently withdrawn) determine when organisations can apply
- Only projects of a capital nature will be eligible for a grant.
   Feasibility studies, running costs and routine maintenance will not be supported
- Grants will not be made retrospectively and purchases must not be made, or work commenced, before an offer of a grant has been received in writing
- Applicants must demonstrate a financial need for grant funding from West Oxfordshire District Council
- Applicants must provide copies of supporting documentation as specified

 Applicants must check if their project requires planning permission. The applicant is expected to communicate directly with the appropriate planning department.

#### **Decision process**

There will be two application rounds in each financial year.
All applications will be subject to a compliance check and review.
Recommendations will then be reported to West Oxfordshire District Council Cabinet for consideration.
Financial information will be reviewed by West Oxfordshire District Council finance officers.

### FUNDING ROUNDS VIOLIA ENVIRONMENTAL TRUST



Violia Environmental Trust support community and environmental projects in England and Wales through the Landfill Communities Fund, using money provided by Violia.

#### How much?

£10,000 - £75,000.

#### Partnership funding

A minimum of 20% of the total project cost must be acquired in cash before an application can be made. Cash equivalent goods or services or pledged amounts will not be considered as eligible contributions to this.

#### Who is it for?

 Not for profit constituted groups with a bank account.

#### What will it fund?

Capital improvement projects at a single site with discrete start and end dates in one of the following categories:

- Community buildings and rooms
- Outdoor spaces
- Play and recreation
- Sports grounds
- Pavilions
- Changing rooms.

#### What it doesn't fund

- Projects established to generate an income for use other than on the upkeep of the project
- Projects with accommodation on site
- Projects that involve the purchase

- of land or buildings
- Restoration of buildings
- Portable equipment including sports and fitness kit
- Staff costs that do not relate to the project

#### Eligibility criteria

- Projects must be located within an eligible area which can be checked via the online postcode checker
- When considering proposals, the trust look for projects that will:
- Benefit a wide range of users, including excluded, often overlooked, deprived and hard to reach groups
- Meet a need that has been evidenced through community consultation
- Involve volunteers
- Use environmentally friendly solutions
- Achieve value for money
- Demonstrate innovation, imagination and excellence
- Projects must have a total cost of under £250,000 (including VAT and professional costs)
- Projects must have secured all permissions including planning
- Projects must be completed within 12 months
- Projects must be open to the wider general public for at least 104 days a year without any limit or unreasonable restrictions of

#### use

- Projects are required to have a minimum of six years remaining on their current lease
- Funding is not retrospective therefore projects must not have started
- Schools and other education establishments are not eligible to apply.

#### **Decision process**

 Applications can be made at any time. Decisions are reached in 10 weeks with grants paid out in a further two if successful.

#### How to apply

 An online eligibility checker needs to be completed and if successful applicants can progress to Stage 1(20% of the total project cost must be secured before a Stage 1 application can be submitted).

# FUNDING ROUNDS FCC COMMUNITY ACTION FUND (WREN)

The FCC Community Action Fund is designed to deliver amenity projects within 10 miles of a FCC Environment landfill site in WREN's operating area, under Object D of the Landfill Communities Fund. WREN defines an amenity as something that a community will use for leisure or recreation purposes. It should make the environment more pleasant or comfortable and/or improves the aesthetic qualities of an area for the general public.

#### How much?

Grants of between £2,000 and £50,000 are available for projects with a maximum total project cost of £500,000.

#### Partnership funding

Required including third party funding to meet Landfill Tax requirements.

#### Who is it for?

- Community organisations
- Voluntary groups
- Charities
- Not-for-profit organisations and groups
- Local Authorities.

#### Eligibility criteria

- Applicant sites must be within 10 miles of a WREN Recycling Site
- All projects must relate to a park or amenity which protects either the built, natural or social environment
- The amenity site must be open and accessible for the general public. It should be somewhere where the general public can go, join or use without any limit or restrictions of use (or with reasonable access costs) being in place. If your facility is not available every day for the public to use please contact WREN for advice before applying

- Work must be targeted on a specific amenity at a single location
- Projects must be completed within 12 months of the grant award
- Sports clubs applying for funding must not be members only
- Projects must have the backing of the local community and meet the needs of that community
- All planning permissions must be in place at the point of application
- Day to day management and running costs as well as routine maintenance are not eligible for funding
- WREN will consider applications for funding for the internal fittings of a new building or extension, but applicants should demonstrate that they have the build costs secured
- Funding towards the refurbishment of an existing community building is also available.

#### **Decision process**

 All eligible applications are reviewed by local volunteer Advisory Panels who know the needs and requirements of the area and have the regional knowledge and expertise to assess and consider applications for funding

- The Regional Advisory Panels make a recommendation to the WREN Board on whether your projects should be supported or not
- All projects are then considered by the WREN Board, which assesses projects in association with the Regional Panel's recommendation and decides whether they should be supported, declined or the funding decision deferred.

- Site visits and telephone assessments may be required
- Funding decisions are usually made at monthly steering groups.

# BIFFA AWARD GRANTS SCHEME

Viridor Credits give the maximum benefit to communities within 10 miles of Viridor's Landfill Sites. This is achieved through the careful selection of great schemes and the distribution of as much Landfill Communities Fund money as possible.

#### How much?

Between £10,000 and £75,000.

#### Partnership funding

Required including third party funding to meet Landfill Tax requirements.

#### Who is it for?

 Not-for-profit community groups with capital projects costing no more than £200,000 in total.

#### Eligibility criteria

- The project site must be within five miles of a significant Biffa operation or within 10 miles of an active Biffa Landfill site
- The project's site must also be within 10 miles of any licensed landfill site
- The total cost of the project is less than £200,000
- There will be a minimum of 104 days of full public access to the project per year
- Any Biffa Award grant must be used for site-based improvement work, not for equipment or running costs
- Biffa Award is unable to fund requests to help an existing facility meet the requirements of the Disability Discrimination Act

- Biffa Award is unable to fund retrospectively, so you should only apply for funding for work that will take place in the future
- The applicant organisation and project are eligible for enrolment and registration with the scheme's regulator, ENTRUST. These will be conditions of any grant approved. Please note that organisations must be not for profit. Local authorities cannot apply or enroll.

# THE BERNARD SUNLEY CHARITABLE FOUNDATION

The Bernard Sunley Charitable
Foundation (BSCF) was
established in 1960 and is a
general grant making trust. The
Trust Deed of the Foundation
allows the trustees to give to
charitable causes at their
discretion.

The aim of the trustees is to help raise the quality of life, particularly for those who are young, disadvantaged or elderly. Each year grants totalling about £2.5 million are made to a wide range of charities.

#### How much?

There are three levels of grant:

- Small £1,000 to £5,000
- Medium £5,001 to £24,999
- Large over £25,000.

#### Partnership funding

Not necessarily required.

#### Who is it for?

 Charities registered with the England and Wales Charity Commission whose beneficiaries are based in this country.

#### Eligibility criteria

- The scheme aims to fund projects that assist community projects, the disadvantaged and/or have a focus on environmental issues.
- The scheme funds capital projects only and not ongoing running costs including salaries
- The types of project the fund gives money for include:
- Capital projects
- New build
- Refurbishment
- -Transport
- Applicants may apply for any level of grant but please note that

- large grants are exceptional. The majority of grants (roughly 80%) are 'small'
- The grant given may be used as match funding for a project and, if match funding is required, this may be in the form of a grant from another organisation or volunteer time.

#### **Decision process**

- The Foundation publishes very brief guidelines for applicants
- Length of lease will be considered for any building
- The Foundation aims to make a decision within 3 months
- Following an application, applicants are advised to not reapply for 12 months from the date of the pervious application as their new application will be automatically declined.

#### How to apply

- Applications can be made online following a brief eligibility questionnaire to deem suitability
- Alternatively applications can be submitted in writing to the Foundation Director providing details of:

- The charity and its objectives
- The need and purpose of your project
- How much it will cost
- The size of grant requested
- How much has already been raised and from whom
- How you plan to raise any shortfall.

# PLAYING FIELDS LEGACY FUND

PFLF's main objective is to get more people, especially the young and disadvantaged, playing outdoor sport through more effective use of playing fields.

Through making small grants, the PFLF enables local organisations to lever in much larger amounts from funders such as the Football Foundation.

#### How much?

Up to £10,000 but awards are usually below this limit.

#### Partnership funding

Required. The purpose of this fund is to provide seed-corn grants to unlock funding from other sources.

#### Who is it for?

- County Playing Field Associations
- Voluntary sector sports clubs
- Parish Councils / Town Councils
- Registered charitable organizations
- Unincorporated not-for-profit organisations
- Industrial and Provident Societies
- Local authorities.

#### What will it fund?

- Training for leaders of local groups and organisations connected to playing fields
- Establishing voluntary playing field groups in parts of the country where none exist, particularly in inner city areas
- Helping more voluntary groups to make high quality applications for funding that helps to protect or make greater use of local playing fields
- Providing seed money to stimulate new investment in playing fields

 Providing match funding to help unlock grants from other bodies in applications with a playing fields focus.

#### What it doesn't fund

- Help with the general running costs of an organisation
- Repeat or regular events, or repeat funding of projects previously funded by other grant bodies
- Retrospective funding the PFLF does not fund projects that have already started
- Items which only benefit an individual, e.g. bursaries or kit and equipment that is not shared
- Projects intended primarily at private or personal gain
- More than £10,000 to the same organisation in any 12 month period
- Sports sessions which take place in school during curriculum time
- The erection of temporary buildings
- Sponsorship, endowments or loan repayments
- Projects that require planning permission that is not yet in place
- Projects that will not start within the next 12 months
- Projects that take place and incur costs before the date of the grant award letter.

#### **Decision process**

- The following assessment criteria will be used to prioritise applications that demonstrate:
- Evidence of need
- Partnership working
- Sports participation increase/ improvements
- Long term sustainability
- Value for money
- There is a 12 week turnaround for applications.

#### How to apply

- Applicants are encouraged to contact the fund to discuss their project before submitting a formal application.

# PREMIER LEAGUE& THE FA FACILITIES FUND SMALL GRANTS SCHEME



This scheme awards grants for the provision of capital items, or to refurbish/improve existing facilities.

#### How much?

Up to £10,000.

#### Partnership funding

Required, grants cannot exceed 50% of the total project cost.

#### Who is it for?

- Local authorities
- Educational establishments
- Grassroots football clubs (not including those in the FA National League System)
- Professional and semiprofessional Football Clubs and their associated Community Organisations (from Premier League to Conference), to support their community outreach programmes.

#### What will it fund?

- Replacement of unsafe goalposts
- Portable floodlights
- Storage containers
- Changing pavilion/clubhouse refurbishment and external works
- Grounds maintenance equipment
- Pitch improvement works (natural and artificial surfaces)
- Fencing.

#### Eligibility criteria

- The minimum grant request is £1,000 unless the application is for the replacement of unsafe goalposts
- Funds cannot be awarded retrospectively therefore

applications cannot be considered if work has been started, a contractor has been appointed or items have been purchased before a grant has been approved, grant offer letter sent and a signed formal acceptance has been received.

#### **Replacement of Unsafe Goalposts**

- Grants are only available for the replacement of unsafe goalposts and not for the initial purchase of goalposts
- Photographic evidence is required to demonstrate posts are in need of replacement

#### **Portable Floodlights**

- Applications for both new and previously owned portable floodlights are acceptable
- If lights are previously owned, the equipment will need to be purchased from a reputable dealer, with a minimum 12 month warranty
- Applicants will need to justify why the lights are required as well as demonstrate how the grass pitches or training areas will be able to cope with increased usage
- Floodlights will need to be covered by suitable contents insurance, and be securely stored when not in use Storage Containers
- Only the purchase of new or fully refurbished storage containers supplied with a minimum 12 month warranty will be funded. The cost of

rented or leased storage containers will not be considered

- The replacement of existing storage containers that have reached the end of their useful life will be considered for funding, subject to justification of need

#### **Changing Pavilion/Clubhouse**

- Refurbishment and External Works
- Routine maintenance works such as unblocking drains, minor roof repairs, repainting, or replacement floor coverings would not be considered eligible as individual projects unless they formed part of a larger refurbishment project.

#### **Grounds Maintenance Equipment**

- A report from either The FA Regional Pitch Advisor or an independent qualified groundsman that justifies the need for the equipment is required before application

#### Pitch Improvement Works (Natural and Artificial Surfaces)

- A report from either The FA Regional Pitch Advisor or an independent qualified groundsman that justifies the need for the equipment is required before application
- Routine maintenance costs are not eligible for funding

#### **Fencing**

- Either boundary fencing or ball retention fencing/netting that is required to improve security or safety at a site will be considered

#### **Decision process**

Organisations are only allowed to apply for a maximum of £10,000, every two seasons (1 June – 31 May). This must be through a single grant application

#### How to apply

Before a full application can be started, applicants are required to complete an online FA Expression of Interest Form which can be accessed here:



# PREMIER LEAGUE & THE FA FACILITIES FUND



The Premier League & The FA
Facilities Fund provides grants for
building or refurbishing grassroots
facilities, such as changing
pavilions and playing surfaces for
community benefit, with
money provided by the Premier
League, The FA and the
Government (via Sport
England) and delivered by the
Football Foundation.

#### How Much?

From £10,000 - £500,000

#### Partnership funding

Applicants must be able to demonstrate that all available options for match funding have been exhausted and to be able to provide evidence for this. As a guide, projects would normally be expected to secure 50% match funding although each project will be assessed based on individual circumstances.

#### Who is it for?

- Grassroots clubs
- Professional clubs' community trusts
- Multi-sport clubs
- Local authorities
- Educational establishments
- Registered charitable organisations
- Not for profit companies limited by guarantee
- Industrial and provident societies
- Unincorporated not for profit organisations.

#### Eligibility criteria

- The Premier League & The FA Facilities Fund gives grants for projects that:
  - Improve facilities for football and other sport in local communities
  - Sustain or increase participation amongst children and adults, regardless of background, age, or ability
- Help children and adults to develop their physical, mental, social and moral capacities through regular participation in sport
- The types of facilities funded include:
  - grass pitches drainage/ improvements
  - pavilions, clubhouses and changing rooms
  - 3G artificial turf pitches
  - fixed floodlights for artificial pitches
- All applications must have security of tenure either by freehold or leasehold. A minimum of 25 years security of tenure is required by leasehold
- Applications will not be considered from any project that

has either started or appointed a contractor unless written permission has been obtained.

#### **Decision process**

 Applications for support are likely to exceed the capital grants available and therefore applications will be assessed and weighted towards priority projects.

#### How to apply

Applicants are strongly advised to discuss their project with their County FA before making any progress. Before a full application can be started, applicants are required to complete an online FA Expression of Interest Form which can be accessed here:

# FOOTBALL STADIA IMPROVEMENT FUND



The Football Stadia Improvement Fund provides money for clubs in the Football League and the English National League System

#### How much?

Men's and Women's National League System clubs can apply for grants up to the total value detailed below in any three year period:

Football League Clubs: £750,000 Clubs in Step 1: £400,000 Clubs in Step 2 - 4: £150,000 Clubs in Step 5 - 6: £100,000 Clubs in Step 7: £20,000 (up to £50,000 for applications including changing rooms).

#### Partnership funding

The Foundation will decide what percentage of the full amount of a project they will fund based on the type of project put forward.

Grants are based on the league a club is in at the time of application, regardless of whether relegation or promotion occurs after that, unless promotion or relegation has been confirmed by the league at the time the application was submitted.

#### Who is it for?

- Football League Clubs
- Clubs in the Men's National League System
- Women's pyramid clubs are eligible for funding.

The default level will be set at NLS Step 4 for clubs in The FA WSL.

#### Eligibility criteria

- Clubs must either own the freehold of the site they want to develop or have a lease with at least 10 years left before it runs out. You may be eligible if your club has a licence agreement, but each licence agreement will be considered separately
- Applications will not be considered if a project has started work or has appointed a contractor before a grant is approved
- Clubs are eligible to apply for grant aid to meet current league membership conditions
- Promoted clubs can apply for grant aid to meet the membership conditions of their new league
- The Foundation will not automatically provide funding for work needed to do to meet The FA's ground-grading standards.

#### **Decision process**

 Applications will be initially assessed to ensure all relevant information is present and the project is eligible.

Applications up to and including £20K (8 weeks): a report is presented to the FSIF Chief Executive and the chair of the Safety Improvement Panel for consideration

Applications between £20,001 and £250,000 (12 weeks): a report is presented to the Safety Improvement Panel for consideration

Applications between £250,000 and £1m (18 weeks): project reports are considered by the Safety Improvement Panel and then the Board of Trustees for consideration.

# SPORT ENGLAND COMMUNITY ASSET FUND

Sport England's Community
Asset Fund is a programme
dedicated to enhancing the
spaces in local communities that
give people the opportunity to be
active.

Their aim is to help local organisations create quality and financially sustainable facilities that benefit their community for years to come.

#### How Much?

£1,000 - £150,000.

#### Partnership funding

Preferred but not essential.

#### Who is it for?

- Clubs
- Community organisations
- Local authorities
- Education establishments.

#### What will it fund?

Good ideas that meet the fund's objectives of:

- Improving and protecting existing sports facilities that support the needs of local communities
- Investing in new and different places that meet the needs of local communities, which include their target audiences
- Ensuring capital investment reaches organisations who have not accessed Sport England funding before
- Creating a more resilient, sustainable, less grant dependent sports sector.

#### Examples include:

- Bringing a building back into use or need improvements to a recreational space
- Improving a changing room or installing new toilets, heating systems or social space
- Fixing a roof that's been damaged

- or repairing an area after flood damage
- Making improvements to a building or open space that's clearly needed in the local community.

#### What it doesn't fund

- Football only projects or projects where football is the majority activity
- Routine maintenance and repairs resulting from wear and tear Children's playgrounds and play equipment
- Projects intended for private gain
- Retrospective funding (this is paying for works you have already completed)
- Projects we've funded in the past
- Small-scale cricket projects

#### Eligibility criteria

- Projects must demonstrate how they will deliver against one or more of the five outcomes set out in the government's strategy for sport Sporting Future.
- Awards are typically grouped into three categories:

#### **Small-scale investments**

 Typically ranging from £1,000 to £15,000 These will address emergency works due to something like storm or flood damage, or something totally unexpected that is stopping people from being able to stay active right now.

#### **Medium-scale investments**

 Typically ranging from between £15,000 to £50,000 these will address more substantial changes. This might be an upgrade to an existing facility or developing a new space in the community.

#### **Larger investments**

- Considered by exception ranging from £50,000 to £150,000. This will be when organisations can demonstrate a considerable impact or are targeting underrepresented groups. They are also unlikely to have received funding from Sport England previously.
- Applicants are required to own the space or facility they are looking to develop through freehold or leasehold for a minimum period of time.
- Applicants will need to meet the appropriate tier of Sport England's Code for Sports Governance
- Applicants are required to have fit for purpose up to date safeguarding children policies in place.

#### **Decision process**

 Applications will be initially assessed against Sport England's seven investment principles we outlined in their Towards an Active Nation strategy to make a decision

- After your submission, a decision will be given as soon as possible. If this decision is positive, then the next steps will be reasonable, proportionate and based on various factors, including:
- The nature of your project
- The amount of money requested
- The context of the request
- Who the project will benefit
- If the request is for a small-scale investment in response to an emergency or unexpected event they will look to make a quick award.
- If the request is for a medium-scale investment, they will work with applicants to agree on any further information required. This might be specific information about your organisation, the nature of the works to be undertaken, the people who will benefit or how the project plans to operate in the future.
