

# **CHAIRMAN'S INTRODUCTION**

#### Introduction

I have pleasure in submitting my Annual Report for the period April 2019 through to October 2020. During this period we have experienced challenges and risks never before seen in the 143-year history of the Shropshire Football Association. The following sections will explain the journey we've been on over the past 18 months.

#### Successes

In both Saturday and Sunday adult football numbers have increased with both the Telford Sunday League and Shrewsbury Sunday League seeing an upsurge in membership.

In February 2019 the Shropshire Football Association was successful in their application for a Step 7 league and the securing of a major sponsorship deal with Salop Leisure. The County FA staff a first for any County Association will solely manage the administration of this new league.

Our KPI's show continued growth in both boys and girls football with the latter experiencing a huge increase due to the delivery of Wildcat Centres strategically placed with clubs to give the greatest impact in delivering opportunities for girls to play football. I can also report increased numbers of applications for the running of Wildcat Centres for the 20/21 season.

Our work with Telford College is still on going and I can report completion of the geological surveys, this now puts us in a position to go for full planning on an additional community 3G pitch on the site. Mick's work with the Football Foundation as delivered a successful application for funding and we await the College's response for the next stage, Covid 19 as played a big part in delaying the progress of this so important project.

A successful application for £100k was secured to deliver a much-needed overhaul to the pitch and drainage system at AFC Telford's Bucks Head ground.

We continue to work on our priority projects across the County and are now working more closely than ever with both Local Authorities to deliver much improved and new facilities for the County.

Targeted projects include Clubhouse and changing rooms at Shifnal Town, A new ground for Newport Town, Shawbury Utd's hub site, Market Drayton's multi sport centre and the Newdale project which is still in its infancy.

### Safeguarding

Following a successful SOS inspection we remain dedicated to keeping young people who play football safe with increased investment and resources to support our footballing community. I am pleased at how, in the last few years, the whole game has risen to the challenge of reviewing and continuously improving our safeguarding work. Our safeguarding capability has never been stronger, and we strive to continue to improve year on year working alongside our leagues, clubs and partners to meet the challenge of the FA's Safeguarding Operating Standard.

#### Challenges

Early 2020 saw Covid-19 enter our lives followed by an early termination of the 2019-20 season. The FA experienced unprecedented reductions to their various income streams with projected losses of over £300m,



which meant very painful times ahead for all. The FA took the decision to split the loss evenly over the next four years, which equates to a reduction of £75m per annum; this was a reduction of 38%

against the 2019 budget. The FA also made the decision to take Coach Education, Referee Courses and Safeguarding courses away from

County FA's which resulted in a massive loss of revenue and as a consequence job losses around the County FA network. For Shropshire this meant our commercial income lay at zero with no plan B in place to support the business.

## **Reduction in Funding**

Covid-19's impact on football has been considerable resulting in over £22million of reductions to the National Game Budget for each of the next four seasons. The impact on County FA's has been immense seeing a reduction in overall funding of 23%, which impacts our workforce grant and football development delivery.

### Workforce Re-structure

With drastic losses in revenue and funding the Shropshire FA needed to make savings of over £100k to make the business sustainable over the next 4 years and beyond. We were spending far too much on salaries, which far exceeded the salary grant awarded by the FA.

The re-structuring is now complete with the loss of one job the CEO, who decided the new structure and challenge was not for him so he took the decision to take voluntary redundancy, with the payment covered by The FA.

The new structure sees a number of new positions, a Business Manager to develop a more commercially orientated business, a dedicated Participation Officer for the Telford & Wrekin area who is based at AFC Telford Utd. The remaining staff are going through a period of up-skilling to cover the areas of Facility Investment, Refereeing Development, League Administration and Marketing.

### **The Future**

There are difficult times ahead for all County Associations with some near the state of collapse, currently I can report that Shropshire are in a far better place than where we were six months ago and the business is now on a stable footing following the re-structure. We now have to focus our efforts on new challenges of Governance reforms within the organisation and from 2021 a new funding methodology will replace the current system where we will be measured on performance and ROI (Return on Investment). Our new commercial strategy is showing early promise with a number of projects bearing fruit; we will continue this approach with the monies earned being invested back into various footballing projects. My apologies for not posing a more 'Rosie' picture but these are difficult times where we all need to pull together for the future of this Association, its leagues, clubs and volunteers.

My final words are one of gratitude to the many people young and not so young who dedicate their lives for football, without you there is no game, please stay safe and above all look after yourselves and families through these very difficult and challenging times.

The 2019-2020 season has been like no other in the history of the Association, only wartime has come close to having the effect that Covid-19 has had on the local game and the Association. I would like to send out my thoughts and best wishes to all those who have been adversely affected by the pandemic and place on record our sincere thanks to all essential workers and particularly those who are part of the Shropshire Football Family.

In tough times you see the best in people and it has been fantastic to see how the football family has come together and supported the local community with their efforts, particularly in those most difficult days of lock-down; we should never underestimate the power of football and the impact that it can make beyond the game itself.

The 2019-2020 season offered much promise for the Association as work continued on the Telford Hub project to enhance the game in the County, with the aim to provide a facility where we can deliver our objectives and to sustain the game within the Telford and Wrekin area for many years to come. Unfortunately, the effect of the pandemic has meant that this project has been put on hold, but we will continue to review the situation while working with our partners in an attempt to assure the long term future of the site when the full impact of Covid-19 is understood.

The pandemic has had a detrimental impact on the Association, and we have been hit financially. The Association survives on funding from the Football Association and income from the game such as membership fees, coach education and discipline monies received. Without the game being played the Association simply does not have a business model. It is therefore inevitable that the 2019-2020 has been a disaster in terms of finance, but we are acutely aware that this is the case with businesses and individuals across the Country.

The money that we bring in enables us to provide the service that we do to support the grassroots game, and as a not for profit organisation, all our finances are reinvested into the game.

We have supported the return to the game by significantly reducing fees for the forthcoming season and we hope that this goes someway to assisting our member clubs during these unique times.

It is essential that the impact of Covid-19 does not mean that our service levels are compromised, however, it is inevitable that there will be changes to the way in which we work moving forward. I am confident that we can recover but there is no hiding from the fact that there are tough times ahead. The furlough scheme has enabled us to continue to provide a service throughout this period and I would like to thank you all for your patience during this time. Likewise, I would like to pay special tribute to the staff, most of whom have been on furlough leave for a significant period, but all understand that this will go a long way to ensuring the future of the Association. To those that have



continued to work and go above and beyond during this period, I am in awe of the dedication that you have to the local game.

Prior to its premature conclusion, the 2019-2020 season was a particularly challenging one for our volunteers and especially the grounds workers. To say that the winter was a damp one would be an understatement, and this was particularly testing for our grounds staff.

For the League and Club Officials these have been challenging times but once again you have come through with flying colours enabling the game to be played. The enforced changes to the game have been difficult but you have rallied round to make this work, its been an incredible effort by all of you and we are all extremely grateful for the outstanding work that you do. Adapting to the 'new normal' will be challenging for the grassroots game but we have already seen how this can be done when people pull together. I would like to congratulate to the winners of our Grassroots Football Awards, The awards are a great opportunity for us to recognise and reward the outstanding contributions of individuals and organisations across the county. This year's winners are a reflection of the fantastic work which takes place across the County to make grassroots football happen.

This report highlights our key achievements in the 2019-2020 season and despite its premature end, we have managed to make great strides in the development of the local game. There is no doubt that there are challenges ahead, but the commitment and enthusiasm of our voluntary and professional workforce will mean that we will support you all to get through these tough times and into the future.

Local authorities are critical to the development of grassroots football in Shropshire, with over 90% of the pitch and facility stock owned by the public sector. This lays the ground for local relationships to increase the capacity of clubs and leagues to engage in trusted relationships with local authorities.
