

# International Clearance request for a player under the age of 18 – Minor Application



International clearance is required for any player from the age of 10 and upwards who is seeking to register for a Club in England and has previously been registered for a Club abroad (including the other Home Associations), or who is a foreign national seeking to register for the first time in this country. Applications for players under the age of 18 must be applied for in accordance with FIFA Article 19. There are four exceptions to this Rule - three of which are available for Clubs at amateur level.

Please select below which of the exceptions your Club are applying for a minor application:

- Article 19.2a)** Player's parents moving to England for NON-FOOTBALLING reasons  
**Article 19.2c)** Player's residence within 50km of national border of Club with which they wish to register for and Club is within 50km of national border of country where player resides  
**Article 19 par. 3 and 4** Player is registering for first time and has lived continuously for the last five years in the country of the intended registration prior to this request
