## STATEMENT FROM THE CHAIRMAN

It has been said in the past, that if the Board of Directors ever became Trustees, the fund might be used for other reasons. Let me confirm here today, that the Funds currently held, along with the Funds we hope to add in the coming years, will be used by the Benevolent Fund, for the benefit all participants under the current rules.

However, there will be a review of operations, such as how we will process claims, approve them, pay them, and eventually audit them.

We will also undertake to review current Policies, such as Investment, safeguarding vulnerable beneficiaries, conflicting interests, volunteer management, and complaints handling.

We will also look at the current criteria for claims and see if this can be improved or expanded, within the terms set out in Charity Commission.

The Chairman then asked the Trustees to agree to the following statement:

'As Trustees, we commit today, to be compliant under the laws specific to charities. As a charity we will comply with the Charities Act, the Trustees Act, and any laws on political activity and fundraising.'

All Trustees agreed to the Statement.

## **FINANCIAL REPORT –** Secretary

The Secretary summarised the current financial position of the Benevolent Fund and the process for applications for grants from the fund to be made and considered.

The Secretary proposed that with the current share value falling considerably in 2020, along with continuing fluctuations, it would be prudent to withdraw all current investments in shares at an appropriate time, and place these into a new separate account at Barclays Bank, to avoid further losses and give greater protection to the funds being held. All Trustees agreed.

The Secretary thanked Thura KT Win, Tony Kybett and Steve Walker for their consideration and approval of applications for grants that have so far been received in 2020-21.

## **OPEN DISCUSSION – All Trustees**

There followed an open discussion which, among other things: clarified the responsibilities of Trustees; identified a number of operational issues which required further consideration; and highlighted the need and potential opportunities to raise the profile of the Fund going forward.
