## Rules and Regulations

Entry to Fleet Lane is subject to these Ground Regulations and the rules and regulations of West Riding FA. By entering Fleet Lane, you are accepting all rules and regulations and confirming that you will adhere to them.

- 1) Permission to enter or to remain within Fleet Lane (notwithstanding possession of any ticket) is at the absolute discretion of West Riding FA personnel. On no account will admission to a football match be granted to a person who is the subject of a current Banning Order.
- 2) Prohibited items include knives, fireworks, explosives, smoke canisters, musical instruments, aerosols, air-horns, noisemakers, flares, weapons, dangerous or hazardous items, illegal substances (including legal highs), laser devices, bottles, glass vessels, cans, poles, or any article that may be used as a weapon and/or compromise public safety or which may pose a hazard or nuisance to any other person, or any article to be used for a commercial or charitable purpose. Any person in possession of such items will be refused entry to or ejected from Fleet Lane.
- 3) Threatening, abusive or violent behaviour and foul or abusive language is strictly forbidden and will result eviction from Fleet Lane and/or arrest.
- 4) Causing damage to, or interfering or tampering with any equipment, furniture, fitting or fixture within the Ground will result in arrest and/or ejection from Fleet Lane.
- 5) Racial, homophobic or discriminatory abuse, chanting or harassment is strictly forbidden and will result in arrest and/or ejection from Fleet Lane.

- 6) The following acts are offences under the Football (Offences) Act 1991 (as amended) and a successful conviction may result in a Banning Order being issued:
- 6.1) The throwing of any object within Fleet Lane without lawful authority or excuse;
- 6.2) The chanting of anything of an indecent or racist nature;
- 6.3) The entry onto the playing area or any adjacent area to which spectators are not generally admitted without lawful authority or excuse;

Such acts will result in ejection from Fleet Lane and/or arrest whether at a football match or otherwise.

- 7) The obstruction of gangways, access ways, exits and entrances, stairways and like places is strictly forbidden. Nobody entering Fleet Lane shall be permitted to climb any structures within Fleet Lane.
- 8) Smoking at Fleet Lane is forbidden at all times except for in clearly designated areas and may result in ejection from Fleet Lane.
- 9) CCTV cameras are in use and West Riding FA may use or pass recordings to the police or other relevant authority for use in investigations and/or proceedings.
- 10) At all times whilst present in the Ground, persons must comply with any and all instructions of any steward or officer of West Riding FA.
- 11) Responsibility for minors remains at all times with a parent or guardian. Unsupervised minors may be refused entry to Fleet Lane or ejected.
