The role will also require the ability to influence and support the growth of Adult Male football within the County, as well as other Key Performance Indicators (KPIs) detailed within Worcestershire FA's operational plan.

RESPONSIBILITIES

- Track the quality and quantity of football pitches and ground locations for affiliated fixtures, working towards every affiliated football fixture being played on a 'good' quality pitch.
- Lead on facility projects, ensuring they align with the LFFP and ensuring new facilities offer 'equal access for girls'.
- Oversee a database of funding sources for clubs and leagues.
- Support the Football Foundation with a pipeline of projects and timely responses to planning applications.
- Ensure that the outcomes of each facility project are aligned to the Football Foundation measurement framework and the FA's Grassroots Football Strategy, delivering support days to each Football Foundation applicant.
- Ensure each local authority has an up-to-date Playing Pitch Strategy (PPS) and work with the Football Foundation on the LFFP refresh.
- Activate grass pitch and smaller projects from LFFP to generate enough demand and deliver against Football Foundation spend targets.
- Promote The FA technical guidance documents to local authorities, clubs, leagues, schools and other facility providers.
- Collate and analyse data to determine Adult Male participation.
- Work with all Adult Male leagues to improve sustainability.
- Work with clubs to ensure Adult Male football maintains/exceeds current participation levels.
- Provide the highest level of customer excellence to support volunteers across all FA Technology systems (Pitch Power, Hive Groundskeepers Community, FA Events, Whole Game System, Matchday app and Full-Time).
- Collaborate with the Designated Safeguarding Officer in all matters involving under 18s and adults at risk within all projects to ensure that requisite safeguarding responsibility and accountabilities for all parties are met.
- Ensure all planning, monitoring and delivery is completed in line with the county operational plan.
- Contribute to ensuring that safeguarding and equality are embedded throughout the Worcestershire FA and grassroots football.
- Execute additional tasks as required to meet Worcestershire FA's changing priorities.
