



## Current Suspensions List – As of 25<sup>th</sup> November 2025

On 1<sup>st</sup> January 2024, the FA Football Agent Regulations came into force superseding The FA Regulations on Working with Intermediaries (“RWWI”). Any person subject to a suspension under the RWWI shall remain suspended in accordance with the prior decision of the Regulatory Commission or Appeal Board in that case.
