## Emirates FA Cup Semi-Finals Ticket Giveaway (the "Competition"): Terms and Conditions

- 1. The promoter of the Competition is The Football Association Limited ("**The FA**"), Wembley Stadium, Wembley, London, HA9 0WS.
- 2. Entry into the Competition is dependent on your acceptance of these Terms and Conditions and by entering the Competition you confirm your acceptance of these Terms and Conditions. For the avoidance of doubt, these Terms and Conditions constitute the "Official Rules" of the Competition for the purposes of YouTube's "Contest Policies and Guidance".
- 3. All entrants must be based in the United Kingdom and be at least 13 years of age on the Closing Date (as defined below).
