

## The SSE Women's FA Cup Final: Make Dreams Goals Competition (the "Competition")

### Terms and Conditions

1. The promoter of the Competition is The Football Association Limited ("**The FA**"), Wembley Stadium, Wembley, London, HA9 0WS.
2. Entry into the Competition is dependent on your acceptance of these Terms and Conditions and the FA's Ticketing Terms and Conditions of Sale/Issue (available [here](#)) and by entering the Competition you confirm your acceptance of such terms and conditions.
3. Entrants must be based in the United Kingdom and must be over the age of 7 on the Closing Date (as defined below). All entrants under the age of 16 on the Closing Date must obtain the permission of a parent or guardian before entering the Competition. Employees of The FA, any FA Group Company or anyone professionally connected to this Competition and members of their immediate families are not permitted to enter the Competition.
4. To validly enter the Competition you must fill out your 'Dream' via The FA's online website ([www.thefa.com/makedreamsgoals](http://www.thefa.com/makedreamsgoals)), or via the Make Dreams Goals "Postboxes" which will be located on The Wembley Tour and in the Wembley Learning Zone between 10:00 Sunday 4 February (the "**Opening Date**") and 19:00 Friday 20 April 2018 (the "**Closing Date**"). Members of staff will be handing out forms near the Postboxes.
5. Entrants must provide appropriate and accurate contact details when entering to be valid to win the 'Prize'.
6. There is a maximum of one entry per entrant.
7. No payment or purchase is necessary to enter the Competition.
8. Entries received after the Closing Date will not be processed. For the purposes of these Terms and Conditions and the Competition, the period of time beginning on the Opening Date and ending on the Closing Date shall be referred to as the "**Competition Window**".
9. There will be a minimum of one winner, and a maximum of five winners of the Competition (the "**Winners**"), Winners will be drawn from entries received by our online entry form and our offline 'Postbox' during the Competition Window. For the avoidance of doubt, no individual can win the Competition more than once.
10. Winners will win the Dream experience that they have requested in their entry, which The FA will make come true. The 'Dream' will need to be related to football or the SSE Women's FA Cup Final to be considered to win. These "**Prizes**" for the purposes of this Competition will therefore be decided upon review of an independent panel of FA employees. The Winners will also receive four tickets to The SSE Women's FA Cup Final 2018 for family and friends. If the Winner is under the age of 18, at least one of the four tickets referenced above for the General Admission prize must be used by an appropriate supervising adult.
11. Following the Closing Date, the Winners will be announced from the entrants who have submitted a valid entry accordance with these Terms and Conditions.
12. A Winner will be selected from the eligible entries received within the Competition Window by a panel made up of members of the FA Marketing, Event, Partnerships and Communications teams (the "**Panel**").
13. Entries will be judged on enthusiasm, originality, creativity and how effectively the Panel deem the entrance has embraced the spirit of the Competition.
14. The Winners will be notified by the Closing Date by Luke Payne or another representative of The FA ("**Winner Notification**"). The Winners must respond by email and confirm their acceptance to the notifying representative of The FA within 3 days of receipt of a Winner

Notification in order to claim their Prize. If a Winner does not confirm acceptance within that time period, another winner may be selected.

15. The FA does not accept responsibility for any entries which are lost, delayed, incomplete or otherwise not received or cannot be entered for technical or any other reason. Proof of posting the entry on The FA's online website is not proof of receipt. Incomplete or illegible entries or those not in accordance with the entry instructions and these Terms and Conditions are invalid.
16. The FA has the right to select an alternative winner or substitute winner if: (i) a Winner is ineligible to enter the Competition; (ii) The FA is unable to reach a Winner within the timeframe outlined above; or (iii) a Winner does not wish to accept the Prize.
17. The FA shall have the right, where necessary, to undertake all such action as is reasonable to protect itself against fraudulent or invalid claims including, without limitation, to require further verification as to the identity, age, and other relevant details of an entrant.
18. The FA reserves the right at its absolute discretion to disqualify any entry which it considers does not comply with these or other applicable Terms and Conditions or any entrant who it reasonably believes has interfered with the fair running of this Competition, including providing false or misleading information.
19. Entries must be made by the entrant, and must not be made through agents or third parties.
20. All prizes are non-exchangeable, non-transferable, and not redeemable for cash or other prizes (in whole or in part). In the event of unforeseen circumstances or circumstances outside The FA's control, The FA reserves the right to offer an alternative prize of equal or greater value. Unless explicitly stated by The FA in writing, travel and accommodation are not included in any of the prizes and The FA accepts no responsibility for any costs associated with any prize which are not specifically included in that prize including, without limitation, meals, personal expenses, insurance and travel expenses in connection with the prize. Winners are strictly prohibited from selling their prizes to any other person.
21. The Winner agrees to comply with the conditions of entry applicable at the ground/stadium hosting the match included in their Prize, and shall ensure that those attending with them do so. Entrants who are rude, abusive or deemed otherwise unsuitable by The FA may be excluded from the Competition or required to leave the ground/stadium. The Winner and their guests at the stadium or at the location of the Winner's Dream must not be subject to a football banning order or any other court-issued order which restricts their ability to attend matches and/or makes them unsuitable to attend The SSE Women's FA Cup Final.
22. The FA will use the information that entrants provide to process the Competition and may publish the Winners' names and towns of residence on The FA website and other channels to use as marketing collateral. The Winners may also be required for publicity and/or promotional activity as is reasonably requested by The FA. We may send entrants information from time to time about The FA Group and other related football matters and shall process your information in accordance with The FA's [Privacy Policy](http://www.thefa.com/public/privacy) (found at <http://www.thefa.com/public/privacy>), which you are deemed to accept when entering the Competition.
23. All entrants into the Competition confirm, by entering the Competition, that The FA may use any aspect of their entry for any reason (including but not limited to publicity and promotional purposes). Entrants automatically assign all rights in any entry to The FA. All entrance into the Competition waive any moral rights they may have in relation to their entry.
24. No correspondence will be entered into in respect of this Competition except with the Winners.

25. The FA accepts no responsibility for any damage, loss, liabilities (including direct, indirect, incidental, consequential or punitive damage) injury or disappointment incurred or suffered by you as a result of entering the Competition, not being able to enter into the Competition or accepting any prize. The FA further disclaims liability for any injury or damage to your or any other person's computer or IT systems relating to or resulting from participation in or downloading of any materials in connection with the Competition. Notwithstanding any other clause in these Terms and Conditions, nothing shall exclude the liability of The FA for fraud or for death or personal injury as a result of The FA's negligence.
26. In no event shall The FA or its Group Company's total liability to you for all damages, losses, or causes of action exceed the price of the applicable Prize. Without limiting the foregoing and to the extent permitted by law, this Competition and the Prizes are provided "as is" without warranty of any kind, either express or implied, including but not limited to, the implied warranties of merchantability, fitness for a particular purpose or non-infringement.
27. The FA reserves the right at any time and from time to time to modify or discontinue, temporarily or permanently, this Competition with or without prior notice due to reasons outside its control or in exceptional circumstances.
28. If any of these Clauses should be determined to be illegal, invalid or otherwise unenforceable then it shall be severed and deleted from these terms and conditions and the remaining Clauses shall survive, remain in full force and effect.
