The player Registration Deadline is **12 noon on the day previous to the date fixed for playing the match**, this includes postponements.

Only those players are eligible to take part who have reached the age of 15 years by midnight on 31 August of the current season and not reached the age of 18 years as at midnight on 31 August of the current season. (For season 2019-2020, a player must have been born on or after 1 September 2001 and before 1 September 2004).
