THE DEFAULT DATE FOR MATCHES IN THE SECOND ROUND QUALIFYING IS SATURDAY 3 OCTOBER, KICK-OFF 3.00PM. THE WINDOW FOR WHEN MATCHES MUST BE PLAYED IS FRIDAY 2 OCTOBER TO MONDAY 5 OCTOBER, THIS INCLUDES POSTPONEMENTS.

WHEN A MATCH IS DRAWN AFTER 90 MINUTES, THE WINNER SHALL BE DETERMINED BY THE TAKING OF KICKS FROM THE PENALTY MARK IN ACCORDANCE WITH THE PROCEDURE ADOPTED BY THE INTERNATIONAL FOOTBALL ASSOCIATION BOARD.

## GROUND SHARING

CLUBS WITH GROUND SHARING AGREEMENTS MUST ARRANGE FOR TIES TO BE PLAYED ON FRIDAY, SATURDAY OR SUNDAY. IF A CLASH OF FIXTURES OCCURS WITH THE SHARING CLUB OR OTHER SPORT, IF FOR ANY REASON A TIE IS UNABLE TO BE PLAYED ON THE GROUND OF THE FIRST DRAWN CLUB ON A SATURDAY, THE TIE MUST BE PLAYED ON EITHER THE DAY BEFORE, I.E. ON FRIDAY, OR THE DAY AFTER, I.E. ON SUNDAY ON THE GROUND OF THE FIRST DRAWN CLUB. IF CLUBS ARE UNABLE TO AGREE ON THE DATE, THEN IT WILL BE PLAYED ON THE SUNDAY, UNLESS THE PROFESSIONAL GAME BOARD DECIDES OTHERWISE AND THAT DECISION SHALL BE FINAL AND BINDING.
