### **MATCH DATES**

THE DEFAULT DATE FOR MATCHES IN THE SECOND ROUND QUALIFYING IS SATURDAY 18 SEPTEMBER, KICK-OFF 3.00PM. REPLAYS ARE MANDATORY IF A FIRST MATCH IS DRAWN AFTER 90 MINUTES. REPLAYS MUST BE SCHEDULED ON OR BEFORE THURSDAY 23 SEPTEMBER, KICK-OFF 7.45PM.

IF A FIRST MATCH IS POSTPONED, THIS MUST BE RESCHEDULED AND PLAYED ON OR BEFORE THURSDAY 23 SEPTEMBER. IF A REPLAY IS POSTPONED OR DELAYED DUE TO THE POSTPONEMENT OF A FIRST MATCH, THIS MUST THEN BE SCHEDULED AND PLAYED ON OR BEFORE THURSDAY 30 SEPTEMBER, IN ACCORDANCE WITH RULE 11 OF THE RULES OF THE COMPETITION.

THE PLAYER REGISTRATION DEADLINE IS 12 NOON ON FRIDAY 17 SEPTEMBER 2021 IRRESPECTIVE OF THE DATE THE MATCH IS PLAYED.

### **GROUND SHARING**

CLUBS WITH GROUND SHARING AGREEMENTS MUST ARRANGE FOR TIES TO BE PLAYED ON FRIDAY, SATURDAY OR SUNDAY. IF A CLASH OF FIXTURES OCCURS WITH THE SHARING CLUB OR OTHER SPORT, IF FOR ANY REASON A MATCH IS UNABLE TO BE PLAYED ON THE GROUND OF THE FIRST DRAWN CLUB ON THE DEFAULT DATE, IT MUST BE PLAYED ON EITHER THE DAY BEFORE, I.E. ON FRIDAY, OR THE DAY AFTER, I.E. ON SUNDAY ON THE GROUND OF THE FIRST DRAWN CLUB. IF CLUBS ARE UNABLE TO AGREE ON THE DATE, THE MATCH WOULD THEN DEFAULT TO THE SUNDAY, UNLESS DECIDED OTHERWISE BY THE PROFESSIONAL GAME BOARD.
