

UEFA Women's EURO 2022 Schools Programme - LEGO Prize Promotion Terms and Conditions

Overview

- The one (1) Winner's school will be provided with £500 worth of LEGO sets.
- The two (2) Runners-Up schools will each be provided with £250 worth of LEGO sets.

Terms and Conditions

Where you see capitalised words in the terms and conditions below, the following definitions and descriptions shall apply to such capitalised words:

Opening Date:	Wednesday 18 th May, 00:01am BST	
Closing Date:	Friday 10 th June 2022, 23.59pm BST	
Minimum Age and required profession:	Participants must be over the age of 18 to enter and work within the education sector (i.e., teacher, headteacher, support staff etc.).

Winner:	There shall be one (1) Winner.	
Runners-Up:	There shall be two (2) Runners-Up.	

Prize(s):	<p><u>Winner's Prize</u></p> <ul style="list-style-type: none"> • £500 worth of LEGO sets to the Winner's school. • The prize is non-extendable, non-transferable, non-re-routable, non-endorseable and non-cashable. <p><u>Runners-Up Prizes</u></p> <ul style="list-style-type: none"> • £250 worth of LEGO sets to each of the two (2) Runners-Up schools. • The prize is non-extendable, non-transferable, non-re-routable, non-endorseable and non-cashable.
Selection of Winner and Runners-Up:	The Winner and each of the Runners-Up will be selected at random from the entrants who have met the Entry Requirements via one or both of the Entry Opportunities, as outlined.
Prize Redemption Period:	Six (6) weeks from the date on which the Promoter takes reasonable steps to inform the Winner and the Runners-Up of their wins, in order that the Winner and Runners-Up may claim their Prizes.

1. Entry into the Prize Promotion is dependent on your acceptance of these terms and conditions and by entering the Prize Promotion you confirm your acceptance of these terms and conditions.
2. Entrants must be based in the United Kingdom (excluding Northern Ireland and the Republic of Ireland). Employees of the Promoter or anyone professionally connected to this Prize Promotion and members of their immediate families are not permitted to enter the Prize Promotion. Entrants must be over the age of 18 and work within the education sector (i.e., teacher, headteacher, support staff etc.) to enter the Prize Promotion.
3. To be automatically entered into the Prize Promotion, you must complete the Entry Requirements (via one or both of the Entry Opportunities). Participation in the Prize Promotion is subject always to compliance with instructions issued by the Promoter (including with these terms and conditions), otherwise your entry will be invalid.
4. No payment or purchase is necessary to enter the Prize Promotion. However, where the Entry Requirements require you to submit your entry (including your personal information) online, you will need an internet connection to enter.
5. Only eligible entries received between the Opening Date and the Closing Date will be entered into the Prize Promotion. Entries received after this Closing Date will not be processed.

6. Maximum one (1) entry per Entry Opportunity as per the Entry Requirements set out in these terms and conditions. Any individual found to be using multiple accounts to enter will be ineligible.
7. All Prize Promotion entrants confirm that, by entering the Prize Promotion, they have the right to submit the information used to enter the Prize Promotion in accordance with these terms and conditions and that the Promoter may use any aspect of their entry for any reason (including, but not limited to, publicity and promotional purposes). In particular, the entrant confirms that they have not used the personal data of any third party to enter the Prize Promotion.
8. Where the Entry Requirements provide that the entrant submits an entry which the entrant has created (including, but not limited to, artwork, video content, a written piece), by submitting such entry, the entrant confirms that they have the right to submit that entry in accordance with these terms and conditions and that the Promoter may use any aspect of their entry for any reason (including, but not limited to, publicity and promotional purposes). All entrants into the Prize Promotion waive any moral rights that they may have in relation to their entry. This means that the Promoter shall not be required to attribute the Prize Promotion entry to the entrant and may amend the work in any way which the Promoter sees fit.
9. The Promoter does not accept responsibility for any entries which are lost, delayed, incomplete, or otherwise not received or cannot be entered for technical or any other reason. Proof of delivery of the entry is not proof of receipt. Incomplete or illegible entries or those entries not submitted in accordance with the entry instructions and these terms and conditions are invalid.
10. For the avoidance of doubt, neither the Winner nor the Runners-Up shall be entitled to a choice of Prize.
11. The Winner and the Runners-Up must respectively respond and confirm acceptance with the Promoter within the Prize Redemption Period. If the Winner does not confirm acceptance of their Prize or either of the Runners-Up do not confirm acceptance of their respective Prizes within the Prize Redemption Period, another Winner and/or Runner(s)-Up may be selected to replace that Winner and/or Runner(s)-Up.
12. The Promoter has the right to select an alternative or substitute Winner and/or Runner(s)-Up which shall be selected in the same manner as the Selection of Winners and Runners-Up from all eligible entries if: (i) a Winner and/or Runner(s)-Up is ineligible to enter the Prize Promotion; (ii) the Promoter is unable to reach a Winner and/or Runner(s)-Up within the Prize Redemption Period; and/or (iii) the Winner and/or Runner(s)-Up does not wish to accept their Prize.
13. The Promoter shall have the right, where necessary, to undertake all such action as is reasonable to protect itself against fraudulent or invalid claims including, without limitation, to require further verification as to the identity, age, profession and other relevant details of an entrant.
14. The Promoter reserves the right at its absolute discretion to disqualify any entry which it considers does not comply with these terms and conditions or any entrant who it reasonably believes has interfered with the fair running of this Prize Promotion, including providing false or misleading information.
15. Entries must be made by the entrant, and must not be made through agents or third parties.
16. All Prizes are non-exchangeable, non-transferable, and not redeemable for cash or other Prizes (in whole or in part). In the event of unforeseen circumstances or circumstances outside the Promoter's control, the Promoter reserves the right to offer an alternative prize of equal or greater value. Travel and accommodation are not included in any of the Prizes unless explicitly stated and the Promoter accepts no responsibility for any costs associated with any Prize which are not specifically included in

that Prize (including, without limitation, meals, personal expenses, insurance and travel expenses in connection with the Prize). Winners are strictly prohibited from selling their Prizes to any other person.

Where the Prize involves attendance at a ground, stadium or other venue, the Winner and Runner(s)-Up agree to comply with all conditions of entry applicable at the ground, stadium or other venue at which the Prize is redeemed, and shall ensure that any guest permitted to attend with them, as described in the Prize, also complies with the conditions. Any Winner and/or Runner(s)-Up who is rude, abusive, or deemed otherwise unsuitable by the Promoter may be excluded from the Prize Promotion and/or required to leave the ground, stadium or venue.
18. The Promoter will use the information that entrants provide to process the Prize Promotion and if an entrant is a Winner or Runner(s)-Up, the Promoter may publish their name and town of residence on the Promoter's websites. The Promoter may also request that the Winner or Runner(s)-Up participates in publicity and other promotional activity for the Promoter. Nothing in these terms and conditions shall oblige the Winner or Runner(s)-Up to participate in any publicity or other promotional activity.
19. No correspondence will be entered into in respect of this Prize Promotion except with the Winner or Runner(s)-Up.
20. The Promoter accepts no responsibility for any damage, losses, liabilities (including those which were reasonably foreseeable, or which we would have anticipated that you might incur due to a special circumstance of which we were aware), injury or disappointment incurred or suffered by you as a result of entering the Prize Promotion, not being able to enter into the Prize Promotion or accepting any Prize. The Promoter further disclaims liability for any injury or damage to your or any other person's computer or IT systems relating to or resulting from participation in or downloading of any materials in connection with the Prize Promotion. Nothing shall exclude the liability of the Promoter for fraud or for death or personal injury as a result of the Promoter's negligence.
21. In no event shall the Promoter's total liability to you for all damages, losses, or causes of action exceed the price of the Prize. Without limiting the foregoing, this Prize Promotion and any Prize are provided "as is" without warranty of any kind, either express or implied including, but not limited to, the implied warranties of merchantability, fitness for a particular purpose or non-infringement.
22. The Promoter reserves the right at any time and from time to time to modify or discontinue, temporarily or permanently, this Prize Promotion with or without prior notice due to reasons outside of its control, or in exceptional circumstances.
23. If any of these terms and conditions should be determined to be illegal, invalid or otherwise unenforceable then it shall be severed and deleted from these terms and conditions and the remaining terms and conditions shall survive and remain in full force and effect.
24. This Prize Promotion is in no way sponsored, endorsed or administered by, or associated with any social media site on which it is hosted.
25. These terms and conditions are governed by the laws of England and Wales. Any disputes arising under or in connection with them shall be subject to the exclusive jurisdiction of the courts of England, subject to any mandatory provisions of local laws. If you are resident in Scotland, you may bring your claim before the Scottish or English courts.
