Terms and Conditions

Where you see capitalised words in the terms and conditions below, the following definitions and descriptions shall apply to such capitalised words:

Promoter:	The Football Association Group (which includes the Football Association Limited (“ The FA ”), Wembley National Stadium Limited and the National Football Centre Limited. Wembley Stadium, Wembley, London HA9 0WS.
Opening Date:	21st May 2021
Closing Date:	16th June 2021
Minimum Age:	18
Entry Requirements:	<p>To enter you will be required:</p> <ul style="list-style-type: none">• to record and upload a video of yourself, your child/children or an adult that you are a carer for (as applicable) completing the 3-Step Challenge via the Football Your Way hub (available here: www.thefa.com/get-involved/player/disability/football-your-way/three-step-challenge/competition); and• provide your first name, surname and email address; and• to be considered disabled under the definition provided for in the Equality Act 2010. <p>By submitting a video you:</p> <ul style="list-style-type: none">• agree to The FA’s privacy policy (available here: www.thefa.com/public/privacy); and• confirm that the person completing the 3-Step Challenge in the video is considered disabled under the definition provided for in the Equality Act 2010.
Winners:	There shall be 6 Winners.
Prize(s):	Each Winner shall win one prize from the following six prizes, which shall be allocated randomly to each Winner: <ul style="list-style-type: none">• 4 VIP tickets to the FA Disability Cup at St George’s Park on 17th and 18th July 2021 (including 2 twin rooms at The Hilton SGP on 17th July 2021);• a visit to meet one of the England para football teams at a training camp during the 2021-22 season, on such date as is selected by The FA and notified to the Winner;• two tickets to an England men’s senior team home match;

	<ul style="list-style-type: none"> • two tickets to an England women's senior team home match; • a visit to your school or club from an England Para Football International player on such date and venue as is selected by The FA and notified to the Winner; or • one England senior women's team shirt signed by members of the England senior women's team. <p>For the avoidance of doubt, any ticket to an England team match that is provided as a Prize shall:</p> <ul style="list-style-type: none"> • be a home football match played in England; • shall exclude any match taking place in a FIFA or UEFA organised finals competition (including a men's or women's UEFA European Championships competition (including EURO 2020 and the women's EURO 2021), a men's or women's FIFA World Cup competition or a UEFA Nations League Final Four competition); and • shall be on such date as is selected by The FA and notified to the Winner and subject to the relevant match being open to attendance by members of the general public.
Selection of Winners:	The Winners will be selected at random from the entrants who have submitted a valid entry in accordance with the Entry Requirements.
Prize Redemption Period:	10 day(s) from the date on which the Promoter takes reasonable steps to inform the Winners of their win, in order that the Winners may claim their Prize.
Delivery of Prizes:	The Promoter shall email the Winners with details of the Prizes using the contact email addresses provided.

1. Entry into the Prize Promotion is dependent on your acceptance of these terms and conditions and by entering the Prize Promotion you confirm your acceptance of these terms and conditions.
2. All Prize Promotion entrants confirm that, by entering the Prize Promotion, they have the right to submit the information used to enter the Prize Promotion in accordance with these terms and conditions and that the Promoter may use the information provided in their entry for the purposes of:
 - (i) processing the providing the relevant Prize; and
 - (ii) where applicable, contacting the Entrant to seek consent for the submitted video to be used by The FA in the Football Your Way digital and social media campaign, where, if consent is provided, the footage would be used on The FA's websites (including the Football Your Way hub) and social media pages, together with the websites and social media pages of affiliated football associations, including County Football Associations. Personal data will also be shared with the marketing supplier Cake Media Limited for the purposes identified above.

In particular, the entrant confirms that they have not used the personal data of any third party, other than the child/children or adult that they are a carer for (as applicable) that they have entered, to enter the Prize Promotion.

3. Entrants must be based in the United Kingdom (excluding Northern Ireland and the Republic of Ireland). Employees of the Promoter or anyone professionally connected to this Prize Promotion and members of their immediate families are not permitted to enter the Prize Promotion. Entrants must be the Minimum Age or over on the Closing

Date. Where an Entrant is entering on behalf of their child/children or an adult that they are a carer for, they are certifying that they have the consent of the relevant child/children or an adult that they are a carer for (as applicable) to upload and submit the filmed 3-Step Challenge video.

4. To enter the Prize Promotion you must complete all of the Entry Requirements and any other instructions issued by the Promoter (including compliance with these terms and conditions), otherwise your entry will be invalid.
5. No payment or purchase is necessary to enter the Prize Promotion. However, where the Entry Requirements require you to submit your entry (including your personal information) online, you will need an internet connection to enter.
6. Only eligible entries received between the Opening Date and the Closing Date will be entered into the Prize Promotion. Entries received after this Closing Date will not be processed.
7. Maximum one entry per entrant and per email address; and, if the Prize Promotion is run on social media, per social media account. Any individual found to be using multiple email addresses or, where applicable, social media accounts to enter will be ineligible.
8. Where the Entry Requirements provide that the entrant submits an entry which the entrant has created (including, but not limited to, artwork, video content, a written piece), by submitting such entry, the entrant confirms that they have the right to submit that entry in accordance with these terms and conditions and that the Promoter may use any aspect of their entry for the purpose of the Prize Promotion, or as otherwise detailed in paragraph 2 above.
9. The Promoter does not accept responsibility for any entries which are lost, delayed, incomplete, or otherwise not received or cannot be entered for technical or any other reason. Proof of delivery of the entry is not proof of receipt. Incomplete or illegible entries or those entries not submitted in accordance with the entry instructions and these terms and conditions are invalid.
10. For the avoidance of doubt, the Winner(s) shall not be entitled to a choice of Prize.
11. The Winner, or the parent, legal guardian or carer of the Winner where the Winner is a child or adult at risk, will must respond and confirm acceptance with the Promoter within the Prize Redemption Period. If the Winner(s) do not confirm acceptance of the Prize within the Prize Redemption Period, another winner may be selected to replace that Winner.
12. The Promoter has the right to select an alternative Winner or substitute Winner which shall be selected in the same manner as the Selection of Winners from all eligible entries if: (i) a Winner is ineligible to enter the Prize Promotion; (ii) the Promoter is unable to reach a Winner within the Prize Redemption Period; and/or (iii) the Winner does not wish to accept their Prize.
13. The Promoter shall have the right, where necessary, to undertake all such action as is reasonable to protect itself against fraudulent or invalid claims including, without limitation, to require further verification as to the identity, age, and other relevant details of an entrant.
14. The Promoter reserves the right at its absolute discretion to disqualify any entry which it considers does not comply with these terms and conditions or any entrant who it reasonably believes has interfered with the fair running of this Prize Promotion, including providing false or misleading information.
15. Where the Prize includes an experience or attendance at an event (including, without limitation, at a match or training session) if the Winner is under 18 or an adult that has a carer, he or she must be accompanied by his or her parent, legal guardian or carer (as applicable). Any such parent, legal guardian or carer shall be required to use one of the tickets or spaces to which the Winner is entitled, as part of their Prize. The Winner must be the parent, legal guardian or carer of any minor under 18 or adult at risk which they choose to bring with them.

16. Entries must be made by the entrant, and must not be made through agents or third parties.
17. All Prizes are non-exchangeable, non-transferable, and not redeemable for cash or other Prizes (in whole or in part). In the event of unforeseen circumstances or circumstances outside the Promoter's control, the Promoter reserves the right to offer an alternative prize of equal or greater value. Travel and accommodation are not included in any of the Prizes unless explicitly stated and the Promoter accepts no responsibility for any costs associated with any Prize which are not specifically included in that Prize (including, without limitation, meals, personal expenses, insurance and travel expenses in connection with the Prize). Winners are strictly prohibited from selling their Prizes to any other person.
18. Where the Prize involves attendance at a ground, stadium or other venue, the Winner(s) agree to comply with all conditions of entry applicable at the ground, stadium or other venue at which the Prize is redeemed, and shall ensure that any guest permitted to attend with them, as described in the Prize, also complies with the conditions. Any Winner who is rude, abusive, or deemed otherwise unsuitable by the Promoter may be excluded from the Prize Promotion and/or required to leave the ground, stadium or venue.
19. No correspondence will be entered into in respect of this Prize Promotion except with the Winner(s).
20. The Promoter accepts no responsibility for any damage, losses, liabilities (including those which were reasonably foreseeable, or which we would have anticipated that you might incur due to a special circumstance of which we were aware), injury or disappointment incurred or suffered by you as a result of entering the Prize Promotion, not being able to enter into the Prize Promotion or accepting any Prize. The Promoter further disclaims liability for any injury or damage to your or any other person's computer or IT systems relating to or resulting from participation in or downloading of any materials in connection with the Prize Promotion. Nothing shall exclude the liability of the Promoter for fraud or for death or personal injury as a result of the Promoter's negligence.
21. In no event shall the Promoter's total liability to you for all damages, losses, or causes of action exceed the price of the Prize. Without limiting the foregoing, this Prize Promotion and any Prize are provided "as is" without warranty of any kind, either express or implied including, but not limited to, the implied warranties of merchantability, fitness for a particular purpose or non-infringement.
22. The Promoter reserves the right at any time and from time to time to modify or discontinue, temporarily or permanently, this Prize Promotion, excluding any of the Data Protection provisions, with or without prior notice due to reasons outside of its control, or in exceptional circumstances.
23. If any of these terms and conditions should be determined to be illegal, invalid or otherwise unenforceable then it shall be severed and deleted from these terms and conditions and the remaining terms and conditions shall survive and remain in full force and effect.
24. This Prize Promotion is in no way sponsored, endorsed or administered by, or associated with any social media site on which it is hosted.
25. These terms and conditions are governed by the laws of England and Wales. Any disputes arising under or in connection with them shall be subject to the exclusive jurisdiction of the courts of England, subject to any mandatory provisions of local laws. If you are resident in Scotland, you may bring your claim before the Scottish or English courts.
