#### Terms and Conditions

Where you see capitalised words in the terms and conditions below, the following definitions and descriptions shall apply to such capitalised words:

<b>Promoters:</b>	<p>The Football Association Group</p> <p>(which includes the Football Association Limited, Wembley National Stadium Limited and the National Football Centre Limited.)</p> <p>Wembley Stadium, Wembley, London HA9 0WS.</p> <p>PayPal Pte. Ltd, a Singaporean company registered under number 200509725E and with a registered address of 5 Temasek Boulevard, #09-01 Suntec Tower Five, Singapore 038985</p>
<b>Opening Date:</b>	00:00 UK time on 6 <sup>th</sup> July 2020
<b>Closing Date:</b>	23:59 on 30 <sup>th</sup> September 2020
<b>Minimum Age:</b>	18
<b>Entry Requirements:</b>	<p>For your registered club to be eligible for entry, at least five different players or parents of a player from your registered club must each make a minimum payment of £5 on The FA Matchday app to the registered club during the period starting on the Opening Date and finishing on the Closing Date.</p> <p>Provided your registered club have satisfied the Entry Requirements it will be automatically entered into the Prize Promotion. Your registered club can only be entered once into the Prize Promotion.</p>
<b>Winners:</b>	<p>There shall be 2 Winners.</p> <p>The Winners shall be registered clubs (as registered on The FA Matchday App) (the "<b>Winning Clubs</b>"). The Prizes will be open to the club's managers and a number of players from the Winning Clubs as out in the Prize(s) section below.</p>

1. Entry into the Prize Promotion is dependent on your acceptance of these terms and conditions and by entering the Prize Promotion you confirm your acceptance of these terms and conditions.
2. Entrants must be based in the United Kingdom (excluding Northern Ireland and the Republic of Ireland). Employees of the Promoters or anyone professionally connected to this Prize Promotion and members of their immediate families are not permitted to enter the Prize Promotion. Entrants must be the Minimum Age or over on the Closing Date. Where the Minimum Age is under the age of 18, entrants under 18 must obtain the permission of a parent or guardian before entering the Prize Promotion.
3. To enter the Prize Promotion you must complete all of the Entry Requirements and any other instructions issued by the Promoters (including compliance with these terms and conditions), otherwise your entry will be invalid.
4. Subject to paragraph 5 below, no payment or purchase is necessary to enter the Prize Promotion. However, where the Entry Requirements require you to submit your entry (including your personal information) online, you will need an internet connection to enter.
5. Any individual found to be using multiple email addresses or, where applicable, social media accounts to enter will be ineligible. Each individual log in made on to The FA Matchday app by a player, parent of a player, coach or team official, counts as one entry into the Prize Promotion for their registered club, with multiple entries allowed for clubs
8. All Prize Promotion entrants confirm that, by entering the Prize Promotion, they have the right to submit the information used to enter the Prize Promotion in accordance with these terms and conditions and that the Promoters may use any aspect of their entry for any reason (including, but not limited to, publicity and promotional purposes). In particular, the entrant confirms that they have not used the personal data of any third party to enter the Prize Promotion.
9. The Promoters do not accept responsibility for any entries which are lost, delayed, incomplete, or otherwise not received or cannot be entered for technical or any other reason. Proof of delivery of the entry is not proof of receipt. Incomplete or illegible entries or those entries not submitted in accordance with the entry instructions and these terms and conditions are invalid.
10. For the avoidance of doubt, the Winner(s) shall not be entitled to a choice of Prize.
11. A representative from the Winning Club must respond and confirm acceptance with the Promoter within the Prize Redemption Period. If a representative from the Winning Club does not confirm acceptance of the Prize within the Prize Redemption Period, another club may be selected to replace that Winner.

12. The Promoter has the right to select an alternative Winning Club or substitute Winning Club which shall be selected in the same manner as the Selection of Winners from all eligible entries if: (i) a Winner is ineligible to enter the Prize Promotion; (ii) the Promoter is unable to reach a Winner within the Prize Redemption Period; and/or (iii) the Winner does not wish to accept their Prize.
13. The Promoters shall have the right, where necessary, to undertake all such action as is reasonable to protect itself against fraudulent or invalid claims including, without limitation, to require further verification as to the identity, age, and other relevant details of an entrant.
14. The Promoters reserve the right in their absolute discretion to disqualify any entry which it considers does not comply with these terms and conditions or any entrant who it reasonably believes has interfered with the fair running of this Prize Promotion, including providing false or misleading information.
15. Where the Prize includes an experience or attendance at an event (including, without limitation, at a match or training session) if a chosen representative of the Winning Club is under 18 (where permitted in accordance with the Minimum Age), he or she must be accompanied by his or her parent or legal guardian. Any such parent or legal guardian shall be required to use one of the tickets or spaces to which the Winner is entitled, as part of their Prize. The Winner must be the parent or legal guardian of any minor under 18 which they choose to bring with them.
16. Entries must be made by the entrant, and must not be made through agents or third parties.
17. All Prizes are non-exchangeable, non-transferable, and not redeemable for cash or other Prizes (in whole or in part). In the event of unforeseen circumstances or circumstances outside the Promoters' control, the Promoters reserve the right to offer an alternative prize of equal or greater value. Travel and accommodation are not included in any of the Prizes unless explicitly stated and the Promoters accepts no responsibility for any costs associated with any Prize which are not specifically included in that Prize (including, without limitation, meals, personal expenses, insurance and travel expenses in connection with the Prize). Where the Prize involves attendance at a ground, stadium or other venue, the Winning Clubs and their representatives agree to comply with all conditions of entry applicable at the ground, stadium or other venue at which the Prize is redeemed, and shall ensure that any guest permitted to attend with them, as described in the Prize, also complies with the conditions. Any representative from a Winning Club who is rude, abusive, or deemed otherwise unsuitable by the Promoters may be excluded from the Prize Promotion and/or required to leave the ground, stadium or venue.
19. The FA will use the information that entrants provide to process the Prize Promotion and may publish the name of the Winning Clubs on the Promoters' websites. The Promoters may also request that the Winning Clubs participates in publicity and other promotional activity for the Promoters. Nothing in these terms and conditions shall oblige the Winning Clubs to participate in any publicity or other promotional activity.
20. No correspondence will be entered into in respect of this Prize Promotion except with the representatives of the Winning Clubs.
21. The Promoters accept no responsibility for any damage, losses, liabilities (including those which were reasonably foreseeable, or which we would have anticipated that you might incur due to a special circumstance of which we were aware), injury or disappointment incurred or suffered by you as a result of entering the Prize Promotion, not being able to enter into the Prize Promotion or accepting any Prize. The Promoters further disclaims liability for any injury or damage to your or any other person's computer or IT systems relating to or resulting from participation in or downloading of any materials in connection with the Prize Promotion. 24. If any of these terms and conditions should be determined to be illegal, invalid or otherwise unenforceable then it shall be severed and deleted from these terms and conditions and the remaining terms and conditions shall survive and remain in full force and effect.
25. This Prize Promotion is in no way sponsored, endorsed or administered by, or associated with any social media site on which it is hosted.
26. These terms and conditions are governed by the laws of England and Wales. Any disputes arising under or in connection with them shall be subject to the exclusive jurisdiction of the courts of England, subject to any mandatory provisions of local laws. If you are resident in Scotland, you may bring your claim before the Scottish or English courts.
